Chair Oshiro, Vice Chair Lee, and Members of the Committee:

The Department of Public Safety (PSD) appreciates the intent of House Bill 2848 HD2. This measure establishes a Wellness Center Task Force which will allow the affected agencies to further study the concept of developing a wellness center by narrowing the potential, viable and ideal location, whether it be at the site formerly used for the Kulani Correctional Facility or another location suited to the goals that will be developed by the Wellness Center Task Force.

PSD is in the process of developing its strategic plan. It is through this process that PSD will develop and address the programmatic needs for Hawaii's offenders, which may include the Pu'uhonua concept. PSD supports this measure as the formation of a Wellness Center Task Force will provide a road map to the successful implementation of the Pu'uhonua concept by networking with subject matter experts in the Department of Human Services, Department of Health, the Department of Hawaiian Home Lands, and the Office of Hawaiian Affairs.

Chair Oshiro and Members of the Committee:

The purpose of this measure is to establish a Wellness Center Task Force within the Legislative Reference Bureau to move forward with the concept of pu'uhonua, or wellness center, and to establish a location for the wellness center on lands owned or controlled by the State, with preference given to the site formerly used as the Kulani Correctional Facility in East Hawaii. As part of the duties assigned by the bill, the Bureau would:

- (1) Have the task force administratively attached to it;
- (2) Provide administrative support to the task force; and
- (3) Assist the task force in developing a plan and making recommendations to move forward the concept of pu'uhonua, or wellness center, and to establish a location for the wellness center on lands owned or controlled by the State, with preference given to the site formerly used as the Kulani correctional facility in East Hawaii

The Bureau takes no position on the merits of the measure, but has concerns relating to the burden that having a task force administratively attached to it and providing administrative support would pose to the Bureau's limited personnel and office supply resources and facilities.

The Bureau relies on only one staff person as its lead administrative support officer and has no conference room facilities under its control. Therefore, providing administrative support such as coordinating the schedules of and communicating with task force members, as well as obtaining conference facilities, will be a challenge.

The Bureau is operating under a budget that is 14% below that of fiscal year 2009-2010. This has entailed considerable constraint on our spending, including printing fewer copies of various publications, maintaining a schedule of reduced subscriptions by our library, deferring equipment purchases, purchasing less paper and office supplies, and eliminating travel unless paid for by other sources. Consequently, if the Bureau were to take on the responsibility of providing administrative support to a task force, an appropriation to cover additional expenses incurred by the Bureau may be necessary.

Having stated these concerns, the Bureau believes a more appropriate role would be for Bureau staff to assist the task force in preparing its report and drafting any proposed legislation it may require. We respectfully request that the measure be amended in this fashion. Furthermore, to allow us to manage our workload effectively and minimize interference with our ability to draft bills for legislators during the busy period prior to the start of session, we would request that the Task Force be directed to transmit a draft of recommendations and any proposed legislation to the Bureau no later than November 1, 2013. This would allow sufficient time for review by the Task Force of a draft of the report and necessary edits and still enable timely completion of the report.

The Drug Policy Forum of Hawai`i writes in strong support of HB 2848 HD2 which establishes a Wellness Center Task Force within the Legislative Reference Bureau to forward the concept of pu`uhonua and to establish a center preferably on the site formerly used as the Kulani Correctional Facility.

DPFH supports efforts to address drug use, drug abuse, drug addiction and drug related crimes using public health modalities rather than incarceration. Drug abuse or addiction is often a symptom of a past trauma that needs healing.

The majority of our incarcerated population is Native Hawaiian; culturally appropriate programs are effective in addressing issues of drug abuse and drug addiction. Establishing a wellness center also focuses on addiction as a health issue, using healing methods rather than pure incarceration. Treatment of addiction is more effective than incarceration; and also less expensive.

We urge the committee to pass this important bill that looks for more effective alternatives than we currently have in our criminal justice system. A pu`uhonua will focus efforts not on incarceration, but on healing individuals so that they can take responsibility for their actions and restore their relationships with families and communities.

We urge the committee to pass this measure. Thank you for the opportunity to provide testimony.


