Aloha Chair Hanohano, Vice Chairs Lee and Members of the Committee

Mahalo for the opportunity to speak to you today. I am Ululani Harwood-Wakinekona. I am able to speak first hand for the strong need to support HB 2848 HD1 which requires PSD to plan for a model wellness center that employs Native Hawaiian practices on state land and to submit a report to the legislature prior to the 2013 legislative session.

I am living daily with the need for establishing a Pu`uhonua/wellness center that uses traditional practices that will resonate with and restore an individual. As an instructor and life-long practitioner of ho'oponopono, huna and other cultural procedures of wellness I am learning firsthand how difficult the healing process is for someone who has been incarcerated.

I can see through my relationship with my husband who was incarcerated on foreign soil for over four decades, the serious destruction his children and extended ohana have suffered. There is an enormous need for mihi (forgiveness) between generations. I watched as he first touched the aina and huki kalo, the sun upon his face, the breeze caressing his skin, the song of the birds and the peace that came over him. My husband is a great-grandfather who has never met his four grandsons, each of whom has a need to know him but because of the separation distance during his incarceration, lack communication skills, the bridge to healing and finding closure may never take place.

These grandchildren, great grandchildren are the future of our homeland and culture, they must first know where they come from in order to know where they are going, and without the healing and harmony in a family unit, our cultural future will fade. The parents are not bad, their choices that took them into incarceration were wrong please don't let our future suffer by making a wrong choice, our children's children deserve correct choices, make the right choice to urge the department to bring practitioners and other interested parties to the table to discuss how this could best be accomplished.

Using practices that connect individuals to the 'aina, their 'ohana, and the larger community is vital to what this session of the legislature strives for...strengthening families and reducing recidivism. Let's educate not incarcerate. We are pleased to see this bill moving and we urge you, as policymakers, to encourage the department to work on real alternatives to incarceration and reentry that have been used and proven. We urge the committee to pass this important bill. We need to find alternative means to reintegrate our people who have lost their way. Establishing Pu'uhonua is a wonderful way to rebuild our communities. Mahalo for allowing me to share my mana'o on this very important concern to our culture and community.

In consideration of HOUSE BILL 2820, HOUSE DRAFT 1 RELATING TO HAWAIIAN FISHPONDS

House Bill 2820, House Draft 1 proposes to amend Chapter 183B, Hawaii Revised Statutes (HRS), to require the Department of Land and Natural Resources (DLNR) to establish the east Honolulu fishpond heritage area. The purposes of the area would be to preserve cultural and historical sites; preserve and protect native Hawaii fish, plants and endangered birds in the area; protect spring water sources; provide a site for future public interpretation of the fishponds' cultural, biological and historical areas; and provide for the reconstruction, rehabilitation and stocking of fishponds subject to Section 171-28, HRS. DLNR offers the following comments.

The properties identified in the bill are owned in fee by the State Department of Transportation (DOT), and not DLNR. The properties were acquired in condemnation proceedings with federal highway funds in connection with DOT's Kalanianaole Highway road widening project. Please be aware that in the event the properties are offered to be transferred by DOT to DLNR at gratis¹, DLNR would still need to conduct the necessary due diligence prior to a recommendation and final decision by the Board of Land and Natural Resources on any acquisition.

Thank you for the opportunity to provide testimony on this measure.
