### STATEMENT OF THE ILWU LOCAL 142 ON H.B. 2869, HD2 RELATING TO THE ECONOMY

The ILWU Local 142 supports H.B. 2869, HD2, which extends the motion picture, digital media, and film, separates the calculation of the credit amount based on wages and salaries from the credit amount based on other qualified production costs, and provides different credit amounts based on residence within the counties for the wages and salaries paid to all cast, crew, and musicians of the qualified production, plus an additional unspecified per cent credit amount on wages and salaries of cast, crew, and musicians who are state residents.

We support economic development and creation of jobs for Hawaii residents. The film and television industry can provide Hawaii residents with good-paying jobs while promoting Hawaii to benefit its number one industry, tourism. Dear Esteemed Members of the Committee,

As a producer and fund manager, with international movie finance and distribution expertise, who has been working with difficulty to raise capital for three years in order to fund local productions through a new fund, I am in strong support of Bill# HB 2869 HD2.

Working on an international level to bring independent productions to Hawaii, I have experienced, firsthand the attraction that our state holds for producers regardless of the financial incentives. Unfortunately, it has not proved strong enough to coax these productions from locations which offer higher or even slightly higher financial incentives. Locations like the UK, Canada, New Orleans, Michigan and Illinois have won out in my experience.

If our incentives were raised another 10%, along with amendments like those suggested by Ric Galindez to benefit local workers, I believe Hawaii would see a significant rise in incoming productions as well as local productions, which we intend to help become consistently profitable through our guidance and high-level network.

Our mission is in line with the state's mission of economic diversification and the development of local talent. We have expertise and resources which can help to make this happen in the film and technology industries, and in my experience, incentives such as these could provide the leverage needed to get past the tipping point and help generate a self-sustaining indigenous film industry.
