### TESTIMONY ON H.B. 2874 - RELATING TO BROADBAND

TO THE HONORABLE MARCUS R. OSHIRO, AND MEMBERS OF THE COMMITTEE:

My name is Donn Yabusaki, and I am the Cable Television Administrator, Department of Commerce and Consumer Affairs ("DCCA"). The DCCA opposes this bill as it is written.

The DCCA's chief concern revolves around Section 2 which caps appropriations paid to recipients from fees collected pursuant to HRS chapter 440G to basically 2011 levels. Fees appropriated pursuant to HRS chapter 440G include the annual fees paid to the DCCA by cable operators to administer HRS chapter 440-G. The annual fees paid to DCCA not only go towards the administration of HRS chapter 440-G, but these fees have been used to support broadband infrastructure and services for the Department of Education, University of Hawaii, and Department of Transportation, and to represent the State in proceedings before the Federal Communications Commission (FCC). To limit DCCA's annual fees to 2011 levels would adversely impact its ability to fund broadband projects and infrastructure, and the expansion of the INET. In addition to this, it would adversely impact the State's ability to access federal funds related to broadband and telecommunications that are regulated by the FCC.

It is also unclear from the language of the bill if the intent is to cap the amount of operating fees paid to PEG access organizations and funding paid to PBS Hawaii, that, pursuant to its authority under HRS chapter 440G, the DCCA orders cable operators to pay. The DCCA believes that "recipients of moneys appropriated pursuant to chapter 440G" (page 2, lines 20-21) is limited to the DCCA. If, however, this measure is intended to cover the franchise fees paid by cable operators to PEG access organizations and PBS Hawaii, then the DCCA respectfully requests that the Finance Committee clarify the phrase "recipients of moneys appropriated pursuant to chapter 440G" (page 2, lines 20-21) and identify the recipients.


Finally, this bill assumes that fees that are collected from the cable operators will exceed the amounts paid out in 2011. Because these fees are based on a percentage of revenues, the actual dollar amount collected from the cable operators varies from year to year, and it is possible that there would not be any funds available as a result of this measure to go into the proposed broadband fund.

The DCCA does not object to the creation of a broadband special fund, but rather, other sources of revenue should be found to provide revenue for this fund, as limiting DCCA's current role in broadband would adversely impact the Governor's goal of providing ubiquitous access to world-class broadband service at affordable prices throughout Hawai'i. Thank you for the opportunity to provide testimony on this measure.

#### STRONG OPPOSITION TO SECTION 2 - HB 2874

Aloha Chair Oshiro, Vice Chair Lee and Members of the Committee!

My name is Kat Brady and I am the Coordinator Community Alliance on Prisons, a community initiative promoting smart justice policies for more than a decade. This testimony is respectfully offered, always being mindful that 6,000 Hawai'i individuals are living behind bars, including 1,800 men who are serving their sentences abroad, thousands of miles from their loved ones, their homes and, for the disproportionate number of incarcerated Native Hawaiians, far from their ancestral lands.

HB 2874 creates a broadband special fund to support funding public school broadband and laptop initiatives. Beginning 01/01/13, it freezes appropriations of moneys derived from cable fees at the lesser of the 2011 appropriation or the amount that a recipient would otherwise receive in the current year and requires excess moneys to be deposited into the broadband special fund. Effective 07/01/12 and repealed 06/30/17.

Community Alliance on Prisons is in STRONG OPPOSITION to Section 2 of this bill which we see as an attack on direct democracy that public access media provides. I have hosted a show called Hawai`i InJustice for Community Alliance on Prisons on `Olelo for almost 5 years. The information we share is not found in the mainstream press.

DCCA is responsible to protect the public interest. The PUBLIC rights-of-way the cable operator enjoys are public property and the government must ensure that the public interest is served. In other words, the government has a public trust obligation to the community.

Last session we were stunned when a legislator actually asked in this very committee, "What is the public benefit of democracy?" The public benefit is the public voice. We live in a representative democracy but that doesn't mean that direct democracy is silenced. It means that you, our elected representatives, represent the voice of the people. You don't make decisions in a vacuum – that is totalitarianism. You are elected to listen to the voice of the people you represent. My Mom said it best when she taught us: You have two ears and one mouth for a reason – you are supposed to listen twice as much than you speak.

Given the present state of our society, however, it's no surprise that we find communications not at the heart of a vibrant democracy, but rather in the grip of an oppressive and contradictory system of mass control. Nowhere is this more evident than in the community struggle for access to the airwaves, and the corporate/government campaign to crush it. Nowhere have U.S. citizens lost greater control of its public sphere than in the government's management of the airwaves.

This bill is evidence of that loss and I am ashamed that our representatives would even consider it.

Genuine democracy requires an informed public that has access to a diverse range of controversial and contrasting views.

Genuine democracy requires media that reflect the cultural diversity and local issues that characterize a community.

**Genuine democracy** is based on broad public participation, a condition made possible not by political representation, but by direct public access.

Community media is growing on all our islands. People who never had a voice are finding their voice; they are expressing views that are reflected nowhere else. PEG programming is reflective of all sectors of our community. Section 2 of this bill seeks to limit that growth and the community opportunity to voice our concerns.

Rights-of-way and airwaves are public space and as a community benefit, the cable operator is required to serve the public interest by making channels available for the purpose of broadcasting community media.

The funds for the broadband initiative should not be borne by cable subscribers. The modest fees collected for the use of PUBLIC airwaves should be entirely dedicated to community media.

Noam Chomsky said it best,

"Where there is even a pretense of democracy, communications are at its heart."

This bill has a chilling effect on democracy and we respectfully ask you to delete Section 2.

SUBJECT:

OPPOSITION TO HB 2874 RELATING TO BROADBAND

I hope all members of the committee have looked carefully at this bill. It is not what it seems. While Americans for Democratic Action/Hawaii would certainly support a bill to establish a fund to be used for broadband and technology based learning in the public schools, we note that changes in Section 2 of this bill are erroneously **not** marked as new statutory material and urge that the committee pay close attention to that section. This bill seems to have been designed primarily to slip through a restriction on public access TV. We also note that consistent with the content of a bill that would restrict public information, this bill, first triple referred, was rereferred in a single referral to this committee at the last minute, with only weekend notice of this hearing provided, in both ways restricting the likelihood of public input.

The public access channels of the islands, funded by a portion of cable TV receipts, are critically important to providing television access to voises and events not routinely reported by the commercial channels, including the ability to see public hearings (especially important to neighbor island people, since almost all state governmental hearings are held on Oahu) on the governmental access channels, the development of focused educational materials that can be viewed statewise on the educational access channels, and the ability to hear a wide variety of ideas, viewpoints, cultural events, etc. that make up the public access channels. In addition, the public access channels give individuals and groups in the communities an opportunity to be heard publicly. This access is invaluable in a democratic society, and especially important as we experience the consolidation of the commercial media. Public access TV should be expanded, not contracted.

There are other anomilies in this bill. It is unusual to provide funding to one state agency that is intended for the benefit of another agency. Also, it is highly unusual, and inappropriate, to establish a state fund that allows donors to target their money, by-passing state policy and priorities. In this case, targeted donations may well result in the highly unequal development of technology based education in wealthier and poorer areas of the state.

For these reasons, we strongly urge you to hold HB 2874 in committee.

**Testimony of** Jay April, President and CEO Akaku: Maui Community Television Member HCR 358 Legislative Task Force in STRONG OPPOSITION TO HB2874 RELATING TO BROADBAND

On behalf of the people of Maui, we strongly OPPOSE House Bill 2874 Relating to Broadband because we can demonstrate that it's likely effect will be to limit broadband adoption and education, not enhance it.

Protection of cable access funding of Public, Educational and Government Access is important to broadband education and is an essential component of bringing Hawaii into the forefront of the digital age. Our ability to communicate effectively with each other will only succeed if the fullest range of local community communications needs such as access to bandwidth, tools, skills and ideas on a fast, open, affordable internet are met for all residents at reasonable cost. Media literacy, digital education and access to spectrum are the underpinnings of broadband development. PEG access centers already in place, are providing cost effective resources and tools to accomplish these goals and bring digital literacy to all of our people. They are perfectly positioned to have an immediate positive impact on Hawaii's broadband future. This it why it makes perfect sense to increase funding for PEG for use in broadband adoption and education, not freeze funding as is contemplated in this bill.

This is particularly important because Akaku has been an early adopter of real world broadband applications. Akaku was the first media organization in Hawaii to use the internet to stream video in the late nineties and in 2007 was once again the first to multicast and simulcast, via radio, television and the web, events of public importance to the entire state. Akaku was the first in Hawaii to integrate live TV broadcasts with "skype" technology and currently provides Maui County Government free streaming services and Maui Nui residents with one of the most innovative broadband training programs in the nation - a programs that could be at risk if HB2874 should ever become law. This bill if it passes will, by cutting off its nose to spite its face, negatively impact an existing, highly functional engine

for broadband adoption by Hawaii residents.

Akaku is currently using broadband technology and curricula that are light years ahead of anything public schools are doing including deploying state of the art equipment and software that outperforms anything a laptop can do. This broadband adoption effort is open to all youth in Maui County from ages 10 -25 and extends well beyond the confines of any classroom.

Not only that, we are at the verge of exporting this progressive learning model to our educational partners statewide and are actively investigating the possibility of creating broadband infrastructure build-outs for rural areas that will be superior to anything offered by Time Warner Cable or anybody else. House Bill 2874, by robbing Peter to pay Paul, will help defeat these efforts by taking resources and growth away from the real broadband innovators and trainers, Hawaii's PEG Access centers. HB2874 will put these much needed funds into an undefined, black hole of underperforming state education coffers. Despite the dedication and excellence demonstrated every day in the classroom by Hawaii's teachers, due to bureaucratic and other priorities, it is hard to justify how a few laptops will have the ability to transform the present system into a high performance new media engine no matter how hard they try. And the proof is in the pudding. It needs to be pointed out that for several years now, our public schools have received millions and millions of dollars of cable franchise PEG funds from Akaku and from Olelo with few, if any measurable results and little or no accountability for these funds.

If House members are really interested in creating a real world model to increase broadband adoption and meet the lofty goals outlined in the Hawaii Broadband Initiative, it might consider an amendment to direct the DCCA to raise the current franchise fee assessment to 5% and to increase, not limit, funding to island PEG entities for purposes of broadband education.

You don't make decisions in a vacuum – that is totalitarianism. You are elected to listen to the voice of the people you represent.

Given the present state of our society, however, it's no surprise that we find communications not at the heart of a vibrant democracy, but rather in the grip of an oppressive and contradictory system of mass control. Nowhere is this more evident than in the community struggle for access to the airwaves, and the corporate/government campaign to crush it. Nowhere have U.S. citizens lost greater control of its public sphere than in the government's management of the airwaves.

This bill is evidence of that loss and I am sorry that our representatives would even consider it.

This bill has a chilling effect on democracy and I respectfully ask you to delete Section 2.
