Good morning Chair Ige, Vice-Chair Kidani, and Members of the Senate Committee on Ways and Means. Windward Spouse Abuse Shelter respectfully submits the following testimony in support of HB304, HD1. As a private nonprofit emergency shelter for almost 20 years, our mission is to is to save the lives of women and their children victimized by domestic violence and homelessness. In doing so, we operate 24 hours a day, 7 days a week, year round.

We learned from an annual survey conducted by the National Network to End Domestic Violence on September 15, 2011 – an one 24-hour period – domestic violence advocates in Hawaii served 485 victims and answered more 78 emergency hotline calls across the state. There were, however, 23 unmet requests because of insufficient funding for staff, programs and services. When fewer community resources are available for advocacy, legal representation, **emergency shelter**, interpretation, counseling, support groups, and case management, victims become more isolated, risking their safety and recovery. Funding shortages have created greater and greater vulnerabilities in the network of services that survivors rely upon for their safety, escape, and self-sufficiency. Many agencies have been forced to cut staff or services, or both, while working diligently to meet the needs of victims.

HB304, SD1 appropriates support from the general fund to maintain funding levels of programs for public health, welfare, and education. We specifically support:

 SECTION 58. There is appropriated out of the general revenues of the State of Hawaii the sum of \$350,000 or so much thereof as may be necessary for fiscal year 2012-2013

We ask that you support HB304, SD1, specifically the Sections iterated above, so that we can continue to provide vital services to the survivors. We strive to keep them safe, supported and self-sufficient and ask that you please join us in helping to save one life at a time.

Thank you for this opportunity to testify in support of H.B. 304 H.D. 1, S.D. 1, Relating to State Finances. Section 63 of the bill appropriates \$300,000 to Volunteer Legal Services Hawai`i for pro bono legal services to indigent persons.

Established in 1981, Volunteer Legal is the only organization in the state whose sole mission is to provide legal services using volunteer attorneys. By marshalling the dedication of civic-minded attorneys, the organization leverages a small staff to help more than 2,500 individuals and families each year. Our cases cover a myriad of civil legal issues – family law, housing, bankruptcy, employment, guardianship, immigration, public benefits, to name just a few. These diverse needs are met by a pool of volunteer attorneys who collectively encompass many areas of legal expertise. Volunteer Legal encourages attorneys to donate their legal services by creating a range of pro bono options, from half-hour consultations to taking a case for full representation. In short, the pro bono service delivery model allows our organization to provide the state's low-income population with cost-effective legal services of the high-quality, while providing attorneys with opportunities to give back to the community.

Volunteer Legal is the last resort for individuals and families who have exhausted all other government and non-profit service options. More than 40% of Volunteer Legal Services Hawaii's intakes are referrals from other legal service organizations because the client did not meet the organization's mission, funding restrictions, or financial criteria. These days, as legal service providers deal with resource constraints, Volunteer Legal receives more and more requests for assistance.

Faced with a drastic drop in funding over the past two years, Volunteer Legal has taken harsh cost cutting measures that include reduction in force, pay decreases, and cutbacks in non-personnal operating expenses. Volunteer Legal now operates with 7.2 full time equivalent employees, down from 11.5 at the beginning of 2011. In 2010, Volunteer Legal processed 3,456 intakes and provided 2,601 services. In 2011, the intakes fell to 2,925 (15%); service provided dropped to 1,928 (26%). Every day, 100 telephone calls go directly to voicemail while staff assists other callers and walk-ins. Unquestionably, hundreds of individuals and families needing legal assistance have been — and will continue to be — turned away.

The requested appropriation will help Volunteer Legal maintain the barest level of staffing and ensure continuity of services while the organization continues to aggressively seek new sources of funding. Without the funding, Volunteer Legal would have to further reduce its operations or close its door altogether. For many local families, it will be the difference between shelter and homelessness, economic survival and destitution, financial stability and bankruptcy. We respectfully ask for your support of Section 59 of H.B. 304 H.D. 1, S.D. 1.

Chair Senator David Ige and Vice-Chair Senator Michelle Kidani and Committee Members:

I am Heidemarie Koop, Director of Hawaii Island Programs of Child & Family Service. This testimony is in strong support for HB 304 to restore the following funds:

- 1– Restore all three child welfare contracts that were terminated effective November 30, 2011 including the Family Centers on Kauai, Permanency Support Services on Oahu, and Substance Abuse Counseling Services on Maui.
- 2-Restore funding reductions we received effective November 30, 2011 in our Comprehensive Counseling and Support Services contracts on Maui, Kauai and Oahu
- 3-Provide proposed funds for Kupuna Care in case SB 2320 does not get passed by the House Finance Committee or dies somewhere else along the way
- 4-Provide proposed funds for Domestic Violence Intervention Services from the Judiciary for the court ordered counseling for male perpetrators and victims. These funds would replace the Rainy Day Funds that run out by 6-30-12
- 5-Provide proposed funds for Domestic Violence Shelters in addition to what the Department of Human Services has put in its budget for FY '13.

These funds will ensure essential services in our communities. When the Rainy Day Funds run out by 6-30-12 for our domestic violence programs, services will have to be reduced without funds to replace the Rainy Day Funds that will be fully spent. This will result in reduced services to perpetrators and victims and will jeopardize the safety of women and children who are victims of domestic violence. With fewer services available or longer waiting lists for services, the risk of domestic violence will increase and less service will be provided to protect women and children who are victims. We are pleased to see the DHS budget add at least \$ 1.5 million for the domestic abuse shelters, but this will only keep the shelters open but still will not support adequate services to the women and children in the shelters. That is why there are additional funds proposed in HB 304 to enable the shelters not only to keep their doors open but to provide more than just the bare minimum of a roof over the their heads and food and safety. The additional funds proposed for shelters in HB 304 would allow for more staff coverage in the shelters rather than the one person working for what could be as many as 41 women and children at any one time. These funds would allow for counseling services and not just a roof over their heads, food, and safety.



The Special Education Advisory Council (SEAC), Hawaii's State Advisory Panel under the Individuals with Disabilities Education Act (IDEA), supports the intent of the PROPOSED SD 1 of HB 304 HD1 which appropriates money from the general fund to maintain funding levels of programs for public health, welfare and education.

In particular, SEAC supports funding for the following programs that provide benefit to students with disabilities and their families:

- **Department of Health respite funds** (Section 2) to enable families of students with disabilities to better participate in their child's educational and vocational goals by providing periodic breaks from caregiving;
- **Healthy Start screening and family visiting** (Section 3) to mitigate the effect of poverty and other high risk factors for educational failure for young children aged birth to five;
- **DD Waiver services** (Section 7) to allow students with developmental disabilities the opportunity to pursue vocational and independent living goals;

Chair David Ige and members of the Senate Ways and Means Committee:

Thank you for this opportunity to testify on behalf of HB 304, HD 1 and SD 1. I am Jill Kitamura, Senior Program Director with the Moiliili Community Center Senior Center Program. I refer especially to Sections 4 and 5, and note that we are in favor of both sections.

The opening statements of HB 304 clearly note the economic impact on so many different programs statewide. The programs noted are Important to the well-being of our citizens young and old. I do not envy your task of setting priorities on what programs to fund within the general fund budget. Many of the programs under non-profits, like those assisting the elderly, have been cut from departmental budgets; have received reduced appropriations; or have been at level funding with costs and demand continually rising. The wave of Baby Boomers has arrived. Non-profits face uncertainty with a time frame of not knowing until after the legislature closes, and whether any monies will be released.

The senior center programs at the different community centers help the senior to remain independent at home and in their community, a cost saving alternative to being institutionalized. Being socially involved keeps the mind active, exercise classes help with one's physical fitness, learning new things and the awareness of resources in the community -- all contribute to the well being of the senior. These seniors not only gain personally but contribute back to the community in many ways.

Kupuna Care Services are essential to helping seniors stay in their homes as long as possible. They provide important services, such as case management, transportation, bathing, meals, respite for the caregiver. Seniors can and will contribute for services, but many cannot afford the actual cost of these services. These lower income, gap group individuals will fail very quickly, needing costly institutional care earlier than if intervention services were readily available.

I urge you to seriously consider programs and services for seniors to be one of your priority areas. Thank you for your kind attention.

- 7 Appropriations from the General Fund will bring much needed stability and security to programs serving
- some of Hawaii's most vulnerable residents, and the Department is pleased to provide information on

- SECTION 2 Respite Services appropriation of \$114,467: Funding is shared by the Family Health
- Services Division, Developmental Disabilities Division and Child and Adolescent Mental Health

- Division. The funds provide support services and training to families and caregivers who provide home
- 2 care to approximately 300 DOH participants
- 3 SECTION 3 Health Start appropriation of \$3,000,000: The Affordable Care Act (ACA) Maternal,

Please accept this as my testimony in support of Section 63 of House Bill 304, SD 1, which would appropriate \$300,000 for the continued operation of Volunteer Legal Services Hawaii.

I am a volunteer attorney through VLSH. My time spent with VLSH has increased over the years as I've witnessed the need grow especially during these challenging economic times. Legal problems are not affected by the economy – they are always there. Some may even say legal problems increase during tough economic times.

VLSH assists clients with a wide range of needs, from simple advice to full representation. Lately, most of the clients I have met at VLSH are well spoken and capable individuals who require legal guidance to navigate the legal system. The judiciary's "Access to Justice" approach resulted in many of the commonly used court forms being accessible on their website. Thus, pro se individuals are better equipped to handle their own matters than ever before. But this is no substitute for interaction with an attorney. Many VLSH clients need that interface with an attorney to guide them with arguments, strategy, and general knowledge of the law pertaining to their particular situation. VLSH clients are so thankful for the opportunity to consult with an attorney at an extremely affordable rate.

Having VLSH in our community is important because it provides a way for volunteer attorneys to serve those amongst us who cannot afford to pay for legal services. I appreciate the organized manner in which VLSH handles the many requests that come into their doors to sort, manage, screen, and match attorneys and clients. It is a win-win for both clients and attorneys, and I feel that my time with VLSH is well spent. VLSH also has different volunteer programs for attorneys to participate in based on their time and level of commitment. So even though I may not have time to take on a case for full representation, I can assist through their clinics by providing consultation services. Unfortunately, I cannot say with confidence that my level of volunteering would be sustained at its current level without VLSH around. They make it easy for attorneys to volunteer and best harness the attorneys' energies. The VLSH staff is so

Chair Ige and Members of the Committee:

Mental Health America of Hawaii is writing in strong support of this bill. In addition to supporting numerous critical human services programs, it also provides additional funding in the amount of \$7.5M to the Adult Mental Health Division of the Department of Health in Section 8 of the proposed bill.

As you no doubt know, the Adult Mental Health Division has been cut back by millions of dollars during the last administration, and this is resulted in tremendous cuts in services – reduction in housing options, eliminating Assertive Case Management teams, dramatic reductions in Community Based Case Management services, and the elimination of many diagnostic categories for eligibility for services –including, for example, Post Traumatic Stress Syndrome, serious clinical depression, anxiety disorders, and others.

The additional funding in this bill could help restore some of the vitally needed services. We know that reducing services to the severely and persistently mentally ill merely increases homeless, police emergency room, hospitalization, and prison costs.

Funding the Adult Mental Health Division is ultimately a cost-saving measure.

Adult Friends for Youth testifies in support of HB 304, HD 1 and the proposed amendments in SD 1. The proposed SD 1 provides funding to Adult Friends for Youth for youth gang prevention and intervention services. There is a critical need for these services.

Adult Friends for Youth currently works with 26 groups and 400 high-risk youth/gang members from low income families weekly to redirect their destructive behavior to constructive behavior. This not only helps the youth, providing them the opportunity to move from the generational binds of poverty in which they were raised, but also creates a safer environment in their neighborhoods and schools, and prevents a costly law enforcement and criminal justice response from being needed later in their lives.

Another key service provided by Adult Friends for Youth is that it is able to mediate effectively between rival gangs when a conflict breaks out. When such a conflict breaks out on a high school campus or public housing, the potential for injuries is great. Adult Friends for Youth has been able to calm such situations, restoring peace to the school and community. Without continued Legislative support such interventions would not be possible.

Goodwill Industries of Hawaii, Inc. (Goodwill) is among the largest human service non-profit organizations in Hawaii. Our mission is to help people find and succeed in employment. With a statewide footprint, and offices on Oahu, Maui, Hilo, Kona and Kauai, last year Goodwill served over 15,000 people and successfully placed over 1,500 into jobs in our community.

Significant budget cuts in state government core human services programs have directly impacted the well-being, education, health and safety of Hawaii's economically vulnerable and developmentally disabled residents and their families who have very limited socioeconomic resources available to them. Appropriating moneys to support programs essential to education, public health, and public welfare is urgently necessary to protect the health and welfare of Hawaii's economically vulnerable and developmentally disabled residents and their families.

In particular:

Section 2: Respite Services: Goodwill supports the appropriation to the Department of Health to provide respite services to persons with developmental disabilities.

Section 7: Medicaid Waiver: Goodwill receives funding from the Department of Health-Developmental Disabilities Division (DOH-DDD) via a DHS Medicaid Waiver Contract to operate crucial programs for individuals with significant developmental disabilities on Oahu and in East Hawaii (Hilo). Participants in Goodwill's programs and their families are Medicaid Waiver recipients who have limited socioeconomic resources. Medicaid Waiver programs are essential for the public health, safety, welfare and education of individuals with developmental disabilities.

Goodwill's Medicaid-Waiver participants have been facing reduced services and insufficient rate levels during the past budget cuts. Goodwill's developmentally disabled Waiver Program participants are in dire need for their services to be fully restored in order to grow and prosper.

Section 9: Partnerships in Community Living (PICL): Goodwill supports the appropriation to the Department of Health for the Partnerships in Community Living (PICL) Program.



Section 64: Veterans' Treatment Court: Goodwill supports the judiciary's establishment of a Hawaii veterans' treatment court on the island of Oahu and recommends full funding to support fiscal year 2012-2013.

Section 67: Employment Core Services: Goodwill also receives funding from the Office of Community Services to operate statewide programs providing employment core services to low-income persons and employment core services to immigrants. Program participants are low-income economically vulnerable residents with significant employment barriers. Programs providing employment core services are a critical need to help these individuals and families locate employment, avoid homelessness, reduce dependence on public assistance and achieve self-sufficiency.

Maintained funding for Goodwill's employment and training programs is critically necessary to help low-income economically vulnerable residents of Hawaii survive in the economic downturn.

My name is Michael Lee, Interim Executive Director of Waikiki Community Center (WCC).

Waikiki Community Center (WCC) is a nonprofit 501(c)(3) agency that has provided services to Waikiki's elders since 1978 and currently serves over 500 older persons each year. Our Senior Program provides vital fitness, cognitive stimulation, social connectivity, education and case management that enable hundreds of older adults to maintain wellness and age in place, for as long as it is possible.

Waikiki Community Center is a community-based focal point for seniors to receive needed services and activities that support their independence and avoid pre-mature institutionalization, thereby saving the State of Hawaii over \$100,000 per person annually in long-term care costs. The Center provides a continuum of over 80 educational, recreational and social services, including health screenings, financial education, physical fitness classes, information and assistance, counseling and case management by a licensed social worker, that helps seniors not only maintain their independence and health, but also assists them as they transition through life changes.

WCC utilizes a preventative health, community-based model for services to older adults, with a focus on 3 major areas that national research documents as imperative to maintaining the ability to age in place:

- physical activity;
- new learning or cognitive stimulation; and
- social connections

The importance of this 3-pronged approach is based on the following evidence: The Bureau of Labor and Statistics states that only 2% of adults aged 75 and older are involved in exercise or recreational activity. Fiftyfour (54%) percent spent their time watching TV. It is well established that physical activity has a positive effect on health, leading to better mental health and cognitive functioning. Exercise also reduces the risk of dementia by 50%, even among people who begin exercise after age 60.

According to research at the Rush Alzheimer's Disease Center, "Loneliness and Risk of Alzheimer's Disease", loneliness has a negative impact on cognitive health and increases the risk of dementia. Elders with higher loneliness scores may be twice as likely to develop dementia. In a study of 7 senior centers in 7 states, over 90% of seniors indicate that they have developed important close friendships at the senior center that provide them with needed emotional security.

For the elders of Waikiki, this is especially important. Approximately 25% of Waikiki's 20,000 residents are over the age of 60 years old. Waikiki has one of the highest numbers of senior citizens per area density on Oahu. Waikiki elders live alone among a proliferation of secured, mixed residential condominiums, and are especially at risk to social isolation and physical and cognitive deterioration. The typical elderly resident is female, mid 70's, living alone, with little or no family support systems nearby. When they become frailer, they have little choices of independent living and are often confused by services available to support them. Waikiki Community Center's continuum of services, ranging from health maintenance activities to case management and counseling provide the needed support to these elders.

Waikiki Community Center has submitted a Grant-in-Aid request to support senior services for 2012-2013, in the amount of \$60,000.

While we understand the great financial challenges faced by the State of Hawaii the Waikiki Community Center remains in jeopardy of discontinuing its services to seniors in the community. We have already reduced some services to our seniors, furloughed program staff in order to keep the program operations available to the community, and will likely terminate case management and counseling services for older adults if funds are not available.

Good morning. We join our community allies in reinforcing what is well understood by the Senate: funding to meet the needs of those in our community suffering homelessness, disability, mental illness, hunger, poor health, and violence in their family is essential to create a community that recognizes a quality of life for **all** including those less fortunate, less equipped or less able than we.

As an agency working to bring peace to our island families, this testimony is provided to request your favorable action in restoring funds to the Domestic Violence Action Center (DVAC) for the upcoming fiscal year. After a budget cutback of \$570,000 in 2009 imposed by the Judiciary (with whom DVAC has a POS contract), the agency was forced to cut services, through significant staff lay-offs, to those in desperate need of the specialized, unduplicated DVAC programs designed with their needs in sharp focus.

The loss of Rainy Day funds are imminent – June 30, 2011, and catapults the agency and its services into a spin. Staff will be laid off again, and additional services will be eliminated.

At fiscal year-end 2011, DVAC had 11,155 callers on its Helpline, with victims on our caseload and the community. We received 399 requests for legal representation, opened legal 215 cases, with attorneys making 366 appearances in court. Advocates opened an additional 189 cases, and staff completed 4,500 safety plans, as well as 3,514 risk assessments.

At the half year point for FY 2012, domestic violence shows no signs of abating. Staff has had 2,635 contacts with agency clients, answered 741 Helpline calls, accepted 74 complex and potentially lethal cases, and closed an additional 61 cases. Staff completed 3,090 safety plans in just six months —with Helpline callers, petitioners for protective orders and clients on the agency caseload.

Your willingness to allocate funding to maintain safety and create hope through the work of the Domestic Violence Action Center will make all the difference in the world for those survivors our programs can reach. Thank you.

The Waianae Coast Comprehensive Health Center strongly supports HB304 HD1 SD1 Proposed. Each of the items identified for funding is important to the health and well-being of Hawai'i.

Of particular interest to the Health Center is Section 13 that appropriates \$332,000 to subsidize the costs of the emergency room at our Health Center. Support for the Health Center's emergency room is essential for its survival.

The emergency room is one of the most heavily utilized on Oahu. In particular with the closing of the emergency room and hospital at Hawaii Medical Center West, the Health Center's emergency room has experienced a higher level of visits and the need to hold and monitor hospital-bound patients longer until a hospital bed opens at one of Oahu's remaining hospitals. The majority of the Health Center's emergency room visits are for conditions related to asthma, upper respiratory infection, complications from insulindependent diabetes, cardiovascular conditions such as chest pains and heart attacks, threatened labor, and injuries and wounds, many which are violence related. Time is crucial in many of these situations and the Health Center's emergency room is the safety net on the Leeward Coast since the next nearest emergency room is 40 minutes away (an hour and a half during rush hour traffic).

The Health Center has served the Waianae community since 1972 providing primary care, emergency medical services, and a wide range of other health and social services.

The Health Center is a safety net for the poor and underserved and needs the financial support provided through HB304 HD1 SD1 Proposed.

Hale Mahaolu is committed to expending allocated funds to our Personal Care Program in a prudent and fiscally responsible manner as we have done for the past 26 years.

The Department of Human Services has funded our Adult Personal Care Program since 1985. Through the years, Hale Mahaolu has helped many of Maui County's frail elderly and disabled adults to remain safely in their homes and prevent unnecessary or premature institutionalization. Our clients are struggling more than ever to have their needs met in the privacy of their home due to cuts in funding and services. It makes fiscal sense to maintain people in their homes, as long term care facilities cost the clients, community and State seven times more than it does to help them remain at home.

The clients we serve do not fit the mold for Medicaid Waiver services, as they are not nursing home level clients or they are in the "gap group" who do not qualify for Medicaid or Kupuna Care services because of their age and needs. Although they are not nursing home level clients, they require personal care services to help them safely maintain an independent lifestyle.

Our request for \$210,000 will provide over 10,500 hours of subsidized personal care services a year. In addition to our clients who receive personal care subsidies, we also serve more than 100 clients in the community who have received unsubsidized personal care attendant referrals through our registry.

According to the Mental Health America-Hawaii report, Hawaii leads the nation in females who report being scared to go to school. Also, Hawaii leads the nation in youth who report having considered suicide, made a plan and attempted suicide. Aloha Chair Ige, Vice-Chair Kidani, and members of the Senate Committee on Ways and Means. My name is Stephen Morse, and I am the Executive Director of Blueprint for Change (BFC). I am here to testify **strong support of HB 304, SD 1 Relating to Child Welfare**.

Members, BFC is a non-profit, charitable organization that is the technical, financial, and administrative support entity for five Neighborhood Place programs statewide that provide support and family strengthening services to families at risk of child abuse and neglect. We are a community-based prevention program that is funded primarily by a POS contract by the Department of Human Services as part of the Differential Response System. Our Neighborhood Place programs are unique among CAN prevention programs because they are the only places where children and families at risk of child abuse and neglect can get services without a referral or appointment and by simply knocking on the door.

During the past 15 years, the Neighborhood Places and other prevention programs that would be funded under this bill have been recognized as chiefly responsible for the turnaround in child abuse and neglect rates in Hawaii, from one of the highest in the country, to one of the lowest. For example, in 2003, there were 7,835 reports of CAN made to the State. In 2007, reports went down to 4,690. In the process of helping reduce CAN reports, these prevention programs have also saved the State billions of dollars in social costs, such as welfare payments, foster care payments, unemployment compensation, substance abuse treatment, and incarceration. As such, we are the most cost effective programs in the State system.

But, the severe downturn in our economy has had a huge negative impact on funding for our programs. Our budget, for example, has been cut by \$335,000 over the past three years, a combined 42% cut from 2008. These cuts have led to reduction in force and staff hours and have made it difficult to maintain service levels. We believe the reduction in prevention services has led to increases in CAN reports. For instance, in 2008, there were 4,628 reports to the State's Child Welfare System. In 2009, reports increased to 5,939. This increase of over 1,300 reports represents the single greatest jump in annual CAN reports since these statistics began being kept in 1975.

HB 304, SD 1 will provide the funds needed by prevention programs to keep our State's social safety net intact. Mahalo for allowing us the opportunity to testify this morning.

Dear Senator Ige and Members of the Committee:

I write in strong support of Section 63 of House Bill 304, SD 1, which would appropriate \$300,000 for the continued operation of Volunteer Legal Services Hawaii. I regret that I cannot appear in person at tomorrow's hearing.

After over thirty years, VLSH is in dire financial straits and in danger of closing. Although individual attorneys in Hawaii have made cash contributions of over \$85,000 this year, other sources of funding have dried up---a situation that many non-profits have faced.

The loss of VLSH would be a disaster to Hawaii's indigent population.

I have been a volunteer attorney with VLSH for over a decade, and I can attest to the tremendous benefit it provides to the community. For example, last year I handled a divorce case for a lady from Japan who was both deaf and mute. I can't imagine how she could have navigated the legal system without an attorney and she clearly did not have the means to pay for one. I was happy to take her case at no charge, but I would never have known about her were it not for VLSH. The Legal Aid Society of Hawaii also assists the indigent, however they operate on a very different model. Legal Aid uses paid employee attorneys, and is extremely limited in both the number and type of cases that it can take. VLSH lawyers don't get paid. VLSH relies on volunteer attorneys handling cases on a pro bono basis. However, somebody has to be the clearinghouse that brings people in need together with the attorneys who are willing to help. That is the vital function that VLSH performs, and it takes money to do so.

Aloha, Chairman Ige, Vice Chair Kidani & Senate Ways & Means Committee Members:

On behalf of Equality Hawaii, the state's largest LGBT advocacy organization, we testify in strong support of the SD1 to HB304, relating to state finances.

The proposed language of SD1 funds many proactive solutions to many complex issues facing our state: kapuna care, family planning, those who are differently abled, education, mental health services, substance abuse and more.

However, Equality Hawaii is especially in favor of Section 68.

Section 68 will provide funding to empower the Department of Education (DOE) to train educators and staff to prevent and address bullying and cyberbullying. It will also help to promote peaceful relations among students and others who are a part of a public or private school community.

This is an issue that cannot wait. Bullying is a pervasive problem in Hawaii; it is as pervasive a problem as intolerance.

In Hawaii, the statistics for youth suicide - a direct result of bullying and cyberbullying - are startling. According to the most recent Youth Risk Behavior Surveillance System (YRBSS) from the Centers for Disease Control, Hawaii leads the nation in many categories:

- Seriously considered suicide: 18.9 percent (highest in the nation)
- Made a suicide plan: 16 percent (highest in the nation)
- Attempted suicide: 12.8 precent (highest in the nation)
- Felt sad or hopeless: 30.6 percent (third highest in the nation)

For a state that prides itself on diversity and aloha, these numbers should trigger a sense of urgency in all of us to address this issue with our sleeves rolled up. Additionally tragic is that Hawaii is one of only six states in the nation that does not have a state law that addresses bullying.

While children are bullied for their perceived differences, those who target them take their cues from authority - from the very people and institutions in their lives who either encourage or condone such attitudes and behaviors.

Without a shift in culture where concern is validated and enforced through policy, no student, teacher, or administrator can trust that bullying does not create an environment hostile to a student's well-being AND to his or her ability to learn.

Athough Hawaii is only one of a handful of states that has yet to address bullying on a state-wide level, the DOE does have administrative policies ... policies that are not promoted and lack resources to effectively train staff to address instances of bullying and cyberbullying.

Please equip the DOE to begin training its staff to train its staff on bullying and cyberbullying prevention programs. We cannot wait for the next youth suicide story to be from Hawaii.

We hope you pass this resolution as an indication of your care and concern for all our students' safety

and education.

Good morning Chair Ige, Vice-Chair Kidani, and Members of the Senate Committee on Ways and Means. The Hawaii State Coalition Against Domestic Violence respectfully submits the following testimony in support of HB304, HD1. As a statewide coalition of domestic violence service providers, our mission is to engage communities and organizations to end domestic violence through education, advocacy, and action for social justice.

An annual survey conducted by the National Network to End Domestic Violence provides insight into domestic violence services in Hawaii. On September 15, 2011 – one 24-hour period – domestic violence advocates served 485 victims and answered more 78 emergency hotline calls across the state. However, there were 23 unmet requests because of not enough funding for staff, programs and services. When fewer community resources are available for advocacy, legal representation, emergency shelter, interpretation, counseling, support groups, and case management, victims become more isolated, risking their safety and recovery. Funding shortages have created greater and greater vulnerabilities in the network of services survivors need for their safety, escape, and self-sufficiency. Many agencies have been forced to cut staff or services, or both, while working tirelessly to meet the needs of victims.

HB304, SD1 appropriates moneys from the general fund to maintain funding levels of programs for public health, welfare, and education. Specifically we support:

- SECTION 58. There is appropriated out of the general revenues of the State of Hawaii the sum of \$350,000 or so much thereof as may be necessary for fiscal year 2012-2013 for education and prevention related to children exposed to domestic violence and dating violence.
- SECTION 59. There is appropriated out of the general revenues of the State of Hawaii the sum of \$1,250,000 or so much thereof as may be necessary for fiscal year 2012-2013 for auxiliary necessary staffing for domestic violence shelters.
- SECTION 61. There is appropriated out of the general revenues of the State of Hawaii the sum of \$975,000 or so much thereof as may be necessary for fiscal year 2012-2013 for domestic violence services. The sum appropriated shall be expended by the judiciary for the purposes of this Act.

These general funds will help many domestic programs and shelters keep their doors open so that they can continue to provide services for survivors; so that victims are safe, supported and self-sufficient.

We respectfully request that the committee passes HB304, HD1. Thank you for your consideration.
