The concurrent resolution requests that the Auditor perform a sunrise review pursuant to section 26H-6, Hawaii Revised Statutes ("HRS"), on the regulation of ziplines and canopy tours as proposed in legislation during the Regular Session of 2012. The Auditor's analysis would set forth the probable effects of the proposed regulatory measure, assess whether its enactment is consistent with the purposes of section 26H-2, HRS, and assess alternate forms of regulation. The Department agrees that a sunrise analysis should be completed by the Auditor.

For your information, pursuant to section 26H-6, HRS, a referral to the auditor for a sunrise analysis shall be by concurrent resolution that identifies a specific legislative bill to be analyzed. H.C.R. No. 118, H.D. 1, unfortunately does not identify a specific legislative bill. Senate Bill No. 2433 and House Bill No. 2060, Relating to Challenge Course Technology, were introduced this session and hearings were held on both bills.
