TESTIMONY ON HOUSE CONCURRENT RESOLUTION NO. 141, REQUESTING THE DIRECTOR OF COMMERCE AND CONSUMER AFFAIRS TO CONVENE A TASK FORCE ON DOG BREEDING.

TO THE HONORABLE ANGUS L. K. MCKELVEY, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Keali'i Lopez, Director of the Department of Commerce and Consumer Affairs ("DCCA"). Thank you for the opportunity to offer comments on House Concurrent Resolution No. 141, which requests the Director of DCCA to convene a task force on dog breeding.

While the DCCA supports the intent of the resolution and the prevention of animal cruelty, the DCCA does not feel that it is the appropriate agency to convene such a task force. It does not have the wisdom or expertise on how best to prevent instances of animal cruelty by large-scale dog breeders. The task force should be overseen by a more suitable and appropriate agency.

I am the Vice President of the Shetland Sheepdog Club of Hawaii and a member and director of two other organizations: the West Oahu Kennel Club and the Obedience Training Club of Hawaii, and have been authorized to speak on their behalf.

Aloha!

I am an exhibitor with minimum breeding. The dog shows in Hawaii bring a lot of revenue to the State. Even when I take my dogs out of State for a show, I am required to pay the State a re-entry fee to bring my dog home.

The majority of my dogs have been imported from Australia, Italy and Canada. In order for me to get these dogs processed without quarantine, they have to be processed on the mainland. The dogs do not in arrive in Hawaii until they are 7-10 months old. They also can't compete in any AKC events until they are 6 months old. I have a problem with several of the Senate Bills that count intact dogs as dogs over 6 months of age. This should be amended to a year of age or should not be regulated at all.

First, a toy dog such as a Yorkshire Terrier can't be spayed or neutered at such a young age without risking it's life. Second, I need time to evaluate my dogs in the ring to determine which ones I will show and which ones will be spayed or neutered then placed in their forever homes. I belong to several Dog Fancier clubs that have strict By-laws. One of the By-laws state that, if I sell a pet, it must be on a Spay or Neuter contract.

I have other issues with these Senate Bills dictating the allocated space in which my dogs sleep in. They start by the length of a dog under 25 inches being allowed 12 square feet. My dogs are 10-12 inches in length as are many other Toy Breeds. My dogs eat and sleep in 3×3 pens (9 square feet). The rest of the day they have 1500 square feet to run around and play. Can we not consider the Toy dog group? The majority of pet dogs in Hawaii are Toy breeds due to lack of affordable living space.

Who composed these Bills? Are they experienced enough to purpose such Bills? Have they verified if there is adequate funding to enforce these laws? Would they mandate the inspectors to have criminal background checks done prior to entering private property? Would they have a Veterinarian license to determine my dog's proper care or health? The taxpayers can't afford to pay for such expenses in this economically hard time. We already have City and County restrictions as well as Club By-laws that the legitimate dog breeders and fellow exhibitors must follow. Is there really a need for these bills? If there is, then, allow all of us to be stake holders in compiling the information for a proper Bill.

I understand that **HCR141** has been scheduled to be heard at 0915 on March 22, 2012. **I am for this Resolution.** I believe that all the stake holders should be involved when putting a Bill together. Please approve this Resolution to ensure a proper task force can be formed. Thank you for allowing me a voice and hopefully an input with a properly constructed Senate Bill.

TESTIMONY IN SUPPORT OF HCR 141

The intent of SB 2492 is to prevent another Waimanalo puppy mill incident. This bill fails to do that. To encumber responsible hobby breeders with laws that are difficult to comply with and unenforceable will only remove a reliable source of dogs for the general public. It will do nothing for the large scale commercial breeder.

There are 47 American Kennel Club clubs in Hawaii and another 79 other dog groups or clubs. The HHS did not consult the local dog fancy in crafting this bill. The number of puppy mill operations the HHS identifies as justification for this bill are based upon "tips" that were called in.

The same Star Advertiser article states: FOR NEARLY THREE YEARS, Humane Society investigators had been allowed into the Waimanalo puppy mill — and had issued multiple warning citations for animal cruelty.

Because of the pending criminal trial, Vaughn declined to say why misdemeanor citations were never issued.

After a new state law took effect on Jan. 1 that more clearly defines how animals must be confined and cared for, Vaughn said Humane Society investigators were no longer welcomed onto the property.

"When we had weaker laws, we were never denied access," Vaughn said.

I am opposed to SB2482 SD1 because it is not a well thought out bill and targets hobby breeders who, at great personal expense, try to preserve the breeds they love. These are not puppy mill people; these are people that research blood lines and genetics to better their breeds. If the sentiment of this bill is to stop the puppy mill people the effect is much further reaching. Is it is strictly to add income for the state I believe enforcement will probably exceed any gains. When I visit the shelters I do not see row after row of purebred dogs I see mostly mixed breeds from irresponsible owners.

I think the kennel size and run stipulations shows a lack of knowledge in understanding how gentle older dogs help socialize younger dogs, also the way it is written would take a math major to understand. This bill is not targeting the problem. Why not put an advisory panel together of pure bred dog fanciers, HHS and veterinarians with the assistance of attorneys to draft proper legislation. Please support HCR141. Obviously current legislation failed because of the re-opening of the Waimanalo puppy mill on the Big Island.

I would rather see good legislation put forward that is carefully thought-out then a bill pushed through that could have dire effects on breeders of pure bred dogs in general. These are the same breed clubs that take calls and place dogs constantly. These dogs never go to shelters! The pure bred dog community in Hawaii is not the problem, puppy mills are. Take the time to put together well thought out legislation, look at what has failed in the previous bill. A bill that targets the real problem.

Most breeders in Hawaii sell pets with mandatory spay-neuter in their contracts. If this community is targeted the end effect may actually worsen the problem. You would only have back yard breeders breeding purebred dogs with no thought to health clearances.

Your bill actually states that a vicious dog could be put in an enclosure to be bred. You should not breed a vicious dog at all, you would be furthering that temperament and you would be risking the health of the other dog??? Does this not tell you there are problems with this bill?

What exactly is unfit for breeding purposes, you may ask 5 vets and get 5 different opinions. You are implementing legislation that is to open to interpretation. Please consider working with a panel of experts, rather than imposing faulty and opened ended legislation and instead look at what has failed in the past. Look specifically at your puppy mill case and see why they were able to circumvent the law. Please support HCR141 and oppose SB2492

The American Kennel Club (AKC) writes in support of House Concurrent Resolution 141 and respectfully requests that members of the House Committee on Economic Revitalization and Business pass this measure.

We wish to thank Representative McKelvey and the sponsors of HCR141 for their commitment to preventing dogs from being maintained in inhumane conditions, while also recognizing that residents of Hawaii have the right to purchase healthy dogs raised by responsible, local breeders.

The AKC sent letters of strong concern regarding bills introduced in the 2011-2012 sessions that contain provisions detrimental to the welfare of dogs and that would consider every owner of ten intact dogs to be a "large scale breeding facility," even if the person breeds no litters and sells no puppies. By including experienced, responsible breeders on the dog breeding task force, it is hoped that these and other problematic provisions will not appear in future measures.

The AKC strongly supports the humane treatment of dogs, including providing an adequate and nutritious diet, clean living conditions, regular veterinary care, kind and responsible human companionship, and training in appropriate behavior. The AKC supports reasonable and enforceable laws that protect the welfare and health of dogs without restricting the rights of owners and breeders who properly maintain their dogs.
