Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to comment on House Concurrent Resolution No. 208. The purpose of this resolution is to have the Department of Agriculture address the low level of irrigation water in the Molokai Irrigation System Kualapuu Reservoir. The department respectfully believes this measure is unnecessary.

The department respects the intent of this bill, however would like to reiterate that by and large, the available water in the reservoir is highly dependent on rainfall which is beyond our control. The department has implemented mandatory conservation measures in order to slow the water level decline, but realize that this has had a negative effect on the local economy. As mentioned in our testimony for HCR 207, the department has, this year, reached out to the Molokai community to address the current extreme drought situation. In addition, the MIS is included in the State's Agricultural Water Use and Development Plan which identifies potential improvements to the system. This plan is being continuously updated. Finally, we have contacted the

Commission on Water Resource Management and they have informed us that there is only approximately 180,000 gallons per day left for allocation in the Kualapuu aquifer. While every bit helps, this is not enough to make a measurable difference and should be considered only as a last resort.

Chair Tsuji, Vice Chair Hashem, and Members of the Committee:

I am Dean Okimoto, President of the Hawaii Farm Bureau Federation (HFBF). Organized since 1948, the HFBF is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

HFBF is in strong support of HCR 208, which requests that the Department of Agriculture address the low level of irrigation water available for agriculture.

Access to reliable and affordable water is an essential need for farmers and ranchers to maintain and expand their production. Agriculture is severely affected by drought events and Hawaii needs a systematic approach to address the critical water shortages facing the Hawaii's agricultural industry.

The Molokai Irrigation System (MIS) represents the most critical juncture in Molokai's agricultural industry. The irrigation water restrictions placed on Molokai's farmers and ranchers jeopardizes their viability and Molokai's fragile economy.

There is potential to increase agricultural production on Molokai by further developing the MIS. If improvements can be made to support increased acreage, Molokai could increase employment in the Agricultural sector as well as create additional revenue for the system itself, which could be used for maintenance and/or improvements making the MIS less dependent on State funding.

There are other reservoir dependent irrigation systems across the State. As suggested by the title of this measure, we respectfully request that all reservoirs be evaluated. We respectfully request your strong support of HCR 208.
