- 1.) The Honorable Mayor Oscar Rodrigues, President of the League of Cities of the Philippines (LCP) or the Honorable Mayor Hernani Braganza, Secretary General (LCP) will address the Hawaii State Legislature with a message from the President of the Republic of the Philippines regarding goals to strengthen the relationship between Hawaii and the Republic of the Philippines and working together to encourage business opportunities between Hawaii and the Philippines.
- 2.) We have confirmed that the Governor of the State of Hawaii will come down to address the League of Cities of the Philippines, consisting of all mayors from urban areas of the Republic of the Philippines, on their President's message and their request to build a stronger relationship between Hawaii and the Republic of the Philippines.

We are writing to personally invite you and your staff to the 26th Hawaii State Legislature to attend the upcoming <u>League of Cities of the Philippines Conference to be held in Hawaii</u> from February 27, 2012 - March 7, 2012.

The State of Hawaii shares common goals with the Philippines in fostering strong and effective local governments, promoting and maintaining friendships, as well as learning and sharing social and economic opportunities that benefit cities in the Philippines and Hawaii.

One of the purposes of the Conference is to further strengthen these goals by signing a Memorandum of Understanding and Cooperation between the League of Cities of the Philippines and the State of Hawaii. With the support of the Hawaii State Legislature, we hope to convene a Special Legislative Session to commemorate this historic event.

In addition, we also introduced House Concurrent Resolution (H.C.R.) No. 3, which will be heard during the 2012 Legislative Session. The resolution recognizes the significance of the memorandum of understanding and the important role of the League of Cities of the Philippines in promoting international friendship and seeking opportunities of cooperation in the fields of economics, trade, tourism, culture and the arts, human services, juvenile justice, and disaster preparedness.

We will be holding forums on three areas of interest to the Republic of the Philippines and to the State of Hawaii, namely: 1) "best practices" in addressing Disaster Preparedness; 2) Tourism; and 3) Juvenile Justice and Human Services. These three areas were discussed at various meetings between the League of Cities of the Philippines, the Governor of the State of Hawaii, and other elected officials from Hawaii.

HON. OSCAR S. RODRIGUEZ, hereinafter referred to as the "LCP".

WITNESSETH, that --

WHEREAS, there is a substantial number of Filipinos and former Filipinos who are residents and citizens of the State of Hawaii, occupy very significant and sensitive government positions both in the Executive and Legislative Departments, and who contribute significantly to the prosperity and development of the State;

WHEREAS, the State of Hawaii and the LCP share the common goal of fostering strong and effective local governments and the principles of developing camaraderie and sharing of knowledge, and capacities among local governments of different countries;

WHEREAS, the State of Hawaii and the LCP recognize the rich historical relationship between the United States and the Republic of the Philippines and there continue to exist valid reasons to promote international friendship and understanding for the mutual benefit of both countries to achieve lasting peace and prosperity;

WHEREAS, there is a common desire to maintain a close cultural, commercial, and financial bridge between ethnic Filipinos living in Hawaii with their relatives, friends, and business counterparts living in Philippine Cities;

NOW THEREFORE, for and in consideration of the foregoing, the parties hereto have hereunto entered into this Memorandum of Understanding (MOU) to represent the commitment of the State of Hawaii and the LCP to work together to achieve the benefits of cooperation in pursuing the objectives of this MOU.

- 1. Exchange visits by the citizens of both the State of Hawaii and the Philippine Cities;
- 2. Official visits between representatives from both the State of Hawaii and the members cities of the LCP.
- 3. Cultural exchanges and exchange of various information and materials towards the development of mutual understanding between citizens of both the State of Hawaii and the Philippine Cities;
