#### The Past

With intense behavior and emotional concerns of autism compounded by early childhood emotional and physical abuse. Self abuse which included hitting his head on hard surfaces, pulling his hair out and chewing on fingernails, toenails and his bleeding mouth or lips. Also utterances of groaning and moaning expressing emotional miseries with distraught facial expressions.

As a desperate single parent searching for help and seeking answers, a suggestion of music therapy was introduced around 2004 -- 7 years ago, Keiko Kajiwara was sought.

Good morning, I am now the contented father of Mark Shiraki who was diagnosed with autism at age 2.

Ms. Keiko arrived with her portable keyboard. She brought her talent, knowledge, patience and a heart motivated to bring healing to my son. Week after week, she came, with the initial sessions filled with moments of behavior outbursts coupled with Mark's sitting calmly with Ms. Keiko at the keyboard. Music brought calmness into Mark's troubled life. This continued during Mark's middle school years.

As I look back, this was one of many remarkable methods employed which laid the foundation for Mark through his high school years and up to the present and on to his future.
