



H.C.R. 42/H.R. 22 - REQUESTING THE DEPARTMENT OF

HEALTH AND DEPARTMENT OF HUMAN SERVICES TO

EDUCATE OPERATORS OF ADULT RESIDENTIAL CARE HOMES

AND COMMUNITY CARE FOSTER HOMES ABOUT THE APPROPRIATE INSURANCE FOR THEIR BUSINESS

PURPOSE: The purpose of H.C.R. 42/H.R. 22 is to request that the Departments of Health and Human Services implement a program to educate operators of adult residential care homes, community care foster homes, and other home-based care services about the appropriate insurance for their businesses, and to coordinate the program with the relevant trade organizations.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) respectfully opposes the provisions of H.C.R. 42/H.R. 22.

Hawaii Administrative Rules, Section 17-1454-49, require the Community Care Foster Family Homes (CCFFHs) to have liability insurance in order to be certified as a CCFFH. In addition, the CCFFH must have a contract with the Med-QUEST Division's health plans in order to be paid for services rendered to Medicaid clients. The health plan contracts also require the CCFFH to have liability insurance. Information we have on one of the health plans show that the provider is required to have coverage of general and professional liability in the amount of \$1 million per occurrence or whatever is set in State law, whichever is greater.

DHS does not specify what type of liability insurance the CCFFH should acquire to operate a business. DHS is not an insurance carrier, and we are not qualified to implement programs to educate the public on their insurance needs. DHS also has no affiliation with trade organizations that might have the expertise regarding insurance policies.
