Purpose of Resolution:

REQUESTING AN AUDIT OF ALL STATE DEPARTMENT

EXPENDITURES RELATING TO MAINTENANCE CONTRACTS AND

EXPENDITURES.

#### Department's Position:

The Department of Education ("DOE") believes the reporting requirements contemplated by this Resolution will be unduly burdensome on its operations, and offers the following comments on pertinent substantive portions of the Resolution:

- The Resolution urges state agencies to consider the costs of performing maintenance duties by existing State maintenance staff versus contracting with outside vendors. On a continuing and case-by-case basis, DOE assesses whether it would be more efficient and effective to use its own maintenance staff to perform services or whether it is more effective or efficient to use outside vendors. Each maintenance service need is assessed on the specific circumstances and takes into consideration several factors, including nature and scope of the maintenance services needed, availability of internal resources and funds, whether special expertise or equipment is required, whether this is an ongoing and frequent service or whether the maintenance is called for only as needed. In addition, significant collective bargaining considerations are implicated in decisions to use private vendors.
- The Resolution urges state agencies to consider lower costs alternatives, such as purchasing energy efficient electronic equipment. The Department is currently replacing all incandescent bulbs with energy saving compact florescent light bulbs and replacing florescent lamps with the newer energy saving lamps. We are also replacing old equipment with energy star equipment. The Department is also working to significantly reduce the cost of school operations by using photovoltaic panels on school facilities and entering into Power Purchase Agreements. The Department has started with 15 Kauai schools and a pilot project on Oahu involving four high schools and will expand statewide as benefits are demonstrated.
