Aloha Madam Chair Hanohano, Vice Chair Lee and members of the House Committee on Hawaiian Affairs. The Association of Hawaiian Civic Clubs supports House Resolution 60 and House Concurrent Resolution 86 that urges the State to give proper recognition to Mokauea Island as a cultural and educational resource. It also urges that Mokauea Island be placed on the Register of Historic Places.

Old time residents of Mokauea tell of being able to walk across to Kalihi-kai during low tide before the lagoon was dredged to accommodate amphibious "flying boats." In the old days they never lacked for the bounty of the ocean but "progress" happened. Despite harassment and humiliation from the State in years past, a few residents continue to make Mokauea their home and keep the traditions alive.

It stands to reason that placing Mokauea Island on the State Register of Historic Places would greatly enhance the opportunity for Mokauea to be placed on the National Register also.

We urge the passage of these resolutions. Mahalo.
