**PROPOSAL TO STUDY THE LESSONS LEARNED BY ISRAELI SOLAR ENERGY
INITIATIVES AND THEIR APPLICABILITY TO THE STATE OF HAWAII.**

Chair Coffman, Vice Chair Kawakami and Members of the Committee.

The Department of Business, Economic Development, and Tourism (DBEDT) supports the intent of HCR 110/HR 81. DBEDT recognizes the value of studying best practices of Israel in using solar generated energy to provide water and space heating. Israel has been successful in utilizing this renewable energy source as a means to reduce its dependency on imported oil. Best practices and lessons learned here could further assist Hawaii's ongoing efforts to achieve energy independence. However, HCR 110/HR 81 does not identify any additional funding for this study. It would be difficult for DBEDT to allocate resources to achieve the objectives set out in HCR 110/HR 81 without degrading existing programs.
