I. MISSION STATEMENT

To provide excellent legal and public services in a timely manner.

II. ATG-100 LEGAL SERVICES

A. HOW CURRENT ECONOMIC AND FISCAL CONDITIONS ARE AFFECTING THE DEPARTMENT

Legal Divisions

Economic conditions have reduced the number of hours available to respond to the legal needs of our client agencies, due mainly to the high level of budgeted vacancy savings. The time frame for getting work product to clients, and the number of pending assignments at any given time, have increased. Because our vacancy savings are budgeted at 23.8% of payroll, we have fewer deputies available to respond to our clients' legal needs.

Deputy attorneys general often work longer hours and weekends to maintain their caseload. In addition, past furlough days, the current 5% salary reduction, and the lack of adequate clerical staff levels decreases the attorneys' efficiency. These facts have contributed to some deputies leaving the department, and have hampered our ability to hire personnel to fill vacancies. (Several former deputies stated that the effect of furlough on their salaries contributed to their decision to leave the department. And recently, many very well qualified applicants stated that they chose not to pursue the available positions because the pay, after the 5% reductions, was lower than expected.) This has resulted in fewer qualified candidates and a long delay in filling the vacancies that have been approved to fill. Specifically, current delays in our services to our clients are due in large part to an inability to fill positions. Deputies who usually serve other clients are temporarily handling some of the workload of different clients, but the work takes longer because their experience is primarily with their main clients.

Although everyone has been doing the best they can under the circumstances, because of the decreased manpower and the increased volume of work, our deputies are faced with more cases, more deadlines, and more trials and hearings with less time to prepare and defend the cases. At some point, the State may be forced to pay more of the taxpayers' money than it might ordinarily pay in settlements and judgments if we must continue to operate with the reduced resources. Given the current volume of work we may not be able to devote adequate time to prepare and defend the cases.

Generally, we are meeting or exceeding current performance measures. The only two exceptions to this are the slightly lower number of cases settled or tried, which is a function of the number of cases filed or that can be scheduled for trial, and the lower number of legal opinions and advice issued, which is a function of having fewer deputies to respond to division's clientele.

The next impact of poor economic conditions we are facing is the loss of both ARRA and federal grant monies. The most immediate example is the loss of federal funding for the Sex Offender Registry program effective January 2013, which has funded 2.5 Investigators over the past several years. We have been advised these funds will no longer be available and have submitted a request, which was not approved, to convert these positions to general funds. This may prevent our department from adequately addressing criminal justice issues.

Crime Prevention and Justice Assistance Division

Due to the current economic conditions, the Juvenile Justice Information System (JJIS) branch has been unable to fill two vacant positions that are critical to delivering the core services of the branch. The first position is the JJIS Analyst. The JJIS Analyst's primary work involves developing and testing applications directly related to the Next Generation (NG) JJIS. The work has been distributed to the remaining team members and has added at least six months of effort to each team member's workload, thereby slowing the development of the NG JJIS.

The second position is the Juvenile Justice (JJ) Research Analyst. This position is responsible for producing relevant, evidence-based research and analysis related to juvenile justice topics that can be used for decision-making by policymakers, stakeholders, service providers, and the community. Prior to the vacancy, the JJ Research Analyst produced a statewide juvenile information data book, a juvenile crime trend series for arrests in all four counties and a recidivism study for HYCF.

Software maintenance for the JJIS is a key component in sustaining an operational, statewide information system that provides crucial information on juvenile offenders and missing and runaway juveniles on a 24/7 basis to its participating agencies. Budget cuts in previous fiscal years have depleted the JJIS software maintenance budget. As the NG JJIS becomes operational, it is even more critical that adequate funds are available for software maintenance. JJIS has requested additional funds in the supplemental budget to pay for software maintenance to ensure that any issues related to software can be resolved in a timely manner.

The Missing Child Center-Hawaii's services to families and law enforcement when a child goes missing have been affected by the past furlough days and, more critically, by the RIF. Due to the RIF, there is only one staff member for MCCH. Although availability should be 24/7, the one staff member is unable to answer calls and respond on a 24/7 basis. No one is able to respond if the staff member is sick, on vacation, or out of town. If there were an emergency, e.g., an AMBER Alert, a person is needed 24/7. Cases that involve mainland contacts are difficult to investigate due to the time difference and furloughs. Many times staff is playing phone tag with the parties, which delays the assistance. Currently, the Friends of the Missing Child Center-Hawaii (FMCCH) are able to fund a half-time Assistant Coordinator. However, FMCCH is not a permanent source of funding, and we would like to

request that the Assistant Coordinator's position be re-established and funded by State general funds.

The programs and services of the **Community and Crime Prevention Branch** have been affected by the current fiscal conditions. One of the programs the branch manages is the statewide McGruff Truck Program. In previous years, McGruff Truck Program representatives met on a quarterly basis to coordinate community safety efforts, such as McGruff Truck School Assemblies and McGruff Truck Driver's Training. Because of travel restrictions, the representatives are only able to meet once a year, thereby reducing the number of McGruff Truck Driver's training sessions and the number of McGruff Truck School Assemblies.

The work structure of the branch has also been impacted. To maximize scarce resources, the branch relies heavily on partnerships with other agencies to meet its goal of community outreach efforts, such as providing community presentations on identity theft prevention and Internet safety. However, the reliance on partnerships can also have adverse effects on the branch. For instance, the branch's involvement in partnership projects has delayed implementing projects on its own, and staff time that might have been devoted to a branch specific project has been diverted towards partnerships projects.

B. ALTERNATIVES CONSIDERED

1. Generating additional revenue

The department has submitted legislative proposals or is working on the following revenue increases;

- a. To increase the registration fees for notaries public from \$40.00 to \$60.00 for a four year commission.
- b. To implement a \$500.00 fee for pardon applications.

2. Shifting funds

- a. Shift salaries of staff in the Tax, Family Law, and Criminal Justice divisions from general to special funds.
- b. Shifting salaries in various divisions by charging CIP projects for "Legal Review services."
- c. Implement a 15% recovery fee on all collections made for various state agencies.

3. Consolidation or elimination of program – None.

4. Reduction of Services – None.

III. ATG-231 HAWAII CRIMINAL JUSTICE DATA CENTER

A. HOW CURRENT ECONOMIC AND FISCAL CONDITIONS ARE AFFECTING THE DEPARTMENT

For ATG-231 and the Hawaii Criminal Justice Data Center (HCJDC), recovering from a 34% vacancy rate as recently as FY 10-11 for the mission critical and public service programs that encompass HCJDC's cadre of services is still challenging, even with recent approvals to fill. Unfortunately, many of these civil services positions still remain vacant as appropriate recruitments are restarted statewide; however, significant progress is being made.

The economic impact detailed below addresses the continuing challenges faced by the ATG-231 programs due to past hiring restrictions and the impact to the public and public safety has been significantly negative:

- Although effectiveness levels of data quality and disposition completion percentages for CJIS-Hawaii continue to decline, we have recently filled one of the Data Quality positions whose main responsibility will be to address errors from the different interfaces. When this new clerk is trained, it will help to reduce the number of errors which should also reduce the number of missing dispositions in CJIS-Hawaii, thereby improving the criminal history information being disseminated;
- State ID card services where public wait times were previously peaking at 5 hours are now improved to a maximum 3 hour wait time and the number of cards issued increased by 9,000 cards;
- Criminal identifications still have errors backlogged and unaddressed, impacting state and national law enforcement partners; however, with the Criminal ID Supervisor permanently filled and 2 other technical fingerprint positions filled, 4,000 arrests that previously were unlinked to a possible offender have been reduced by almost 50%;
- Expungements are mandated by statute to be completed in 120 days. In the first half of 2011, expungements were being completed using the maximum 120 days. In the second half of 2011, expungements are being completed in an average of 116 days;
- Now that the Criminal History Records Checks Unit is fully staffed, the response time for criminal history record checks has been cut in half. Results are now being sent out within 7 business days instead of the previous 15 days, allowing adoptions, visa applications, and many other licensing, certifications, and employment suitability evaluations to be completed in a timelier manner;

- Despite the continuous growth of the Sex Offender Registry which now tracks 3,500 covered offenders, there has been progress on the ability to post sex offenders on the public website within 3 days of judgment of conviction entry into the court's automated system; and
- The ability to support our mission critical systems which require 24x7 on-call services to law enforcement and criminal justice agencies was previously negatively impacted in terms of responsiveness when time is always of the essence. Further, the ability of our IT technical staff to respond to problems reported by statewide CJIS-Hawaii users that require program changes resulted in delayed implementation and appropriate corrective action. However, recent filling of vacant IT Specialist positions has and will provide HCJDC with more staff able to participate and address these problems and has already positively impacted the ability to support after-hours issues.

B. ALTERNATIVES CONSIDERED

1. Generating additional revenue

The department has rules in progress to increase both the criminal history record check fees and the state ID fees.

2. Shifting funds

There is a plan to shift a portion of costs for AFIS maintenance fees from general to special funds, beginning in FY 2013, by implementing fee increases, and applying for federal grants funds.

3. Consolidation or elimination of program

The department has submitted a legislative proposal as part of the Administration's package to consolidate the State ID program with the Driver's License program under the Department of Transportation. 49 other states issue the state ID card as a non-driver's license card and in times of economic challenges, this streamlining of services for the State is appropriate and timely.

4. Reduction of Services – None.

IV. ATG-500 CHILD SUPPORT ENFORCEMENT AGENCY

A. HOW CURRENT ECONOMIC AND FISCAL CONDITIONS ARE AFFECTING THE DEPARTMENT

The impact of substantial vacancy savings and lack of General Funds is listed as follows:

Vacancy Savings Issues:

- The agency has a budgeted vacancy savings of \$632,137 in general funds, which requires 22% of the budgeted positions must be held vacant and, in turn, prevents the agency from operating at its optimal capacity. The existing 5% temporary reduction in pay, has led to resignations and a lack of qualified candidates due to the lower pay, further exacerbates the situation. The agency has 42 vacant positions as of the month of December, 2011.
- The aforementioned issue results in unfilled vacancies in the call center. Regular staffs from the Oahu Branch where the call center is located have to rotate in daily to answer customer calls. Resources in managing cases at the Oahu Branch are therefore stretched thin and affect the agency's performance.
- The agency's file room staffs play a critical role in the digital file conversion project. The branch currently has approximately 25% of its positions vacant. If the agency cannot recruit all of them, the digital file conversion project will be delayed.
- 28% of the agency's Information Technology Office has left to other State departments since October 2011. If these vacancies cannot be filled, the agency will not be able to maintain its child support enforcement system effectively.
- Due to the hiring freeze, retirements and other position movements the agency has experienced an increased number of vacancies. In addition nine (9) positions were abolished in the 2010 Legislature.
- One of the abolished positions is the supervising deputy attorney at the Kona Branch of the Big Island Family Support Unit. To continue serving customers' needs for paternity establishment for child support purposes, deputy attorneys from the Hilo Branch of the same unit have to travel to and stay at the Kona office several times a month.

Lack of General Funds to upgrade current child support enforcement system:

- The agency's child support enforcement system (KEIKI) was installed in June 1998 and the underlying technology is outdated. However, the agency does not have the funding to upgrade the system to increase its efficiency and effectiveness. Since the majority of the child support enforcement functions are automated on KEIKI, any possibility of a system slowdown or breakdown will severely hamper the agency's ability to provide essential services to customers. It is estimated that about five to

seven million dollars in general funds will be required in the next two to three years to renovate the agency platform.

B. ALTERNATIVES CONSIDERED

1. Generating additional revenue

The agency has submitted a supplemental budget request for the following:

- a. To reduce the vacancy savings by \$140,000 in General Fund to allow the agency to recruit for a few essential positions.
 - b. To increase the agency's budget by \$72,000 (i.e. \$24,480 General Fund and \$47,520 Special Fund) for SFY 2013. This addition will be used to hire a contractor to perform an assessment of the Federal income tax data safeguard issues cited by the Internal Revenue Services.
2. Shifting funds – None
 3. Consolidation or elimination of program – None.
 4. Reduction of Services – None.







POSITION ORGANIZATION CHART




POSITION ORGANIZATION CHART


