

I SUBMIT THIS TESTIMONY IN SUPPORT OF THE CONFIRMATION OF ADRIANNE N. HEELY TO THE DISTRICT FAMILY COURT, SECOND CIRCUIT.

This letter is to express my support for Adrianne N. Heely's appointment as a District Court Judge to the Second Circuit. I believe she will bring a sense of commitment and pride to the judiciary in her service on the District Court bench.

I have been a practicing attorney in the State of Hawai'i since 1978. Ms. Heely and I practiced at a 16-member law firm, in my role as a partner and her position as an associate attorney, during the 2003 to 2004 time frame. I was immediately impressed with both her legal skills and people skills. When I started my law firm, the Law Offices of Frank K. Goto, Jr., AAL, LLC in September 2004, I knew that I would need assistance in building and sustaining my law practice. I looked to hire an attorney that I could rely on for analysis of complex issues and interaction with clients and staff. When I became aware that Ms. Heely was interested in a new career opportunity, I approached her and offered her a position in my firm.

Ms. Heely and I worked together from September 2004 through November 2006. During that time frame, we practiced in a three person office, with Ms. Heely working as an associate attorney along with our paralegal/legal secretary. In our busy practice, primarily

representing professionals in the architecture, engineering, accounting and legal fields, Ms. Heely had to efficiently and effectively handle a voluminous case load with a variety of civil procedural and legal issues. She accomplished these tasks not only with the skill of a competent practitioner but also with a temperament which displayed even-handedness and fairness towards our clients, opposing counsel and parties.

Ms. Heely's legal qualifications as a practicing attorney are exhibited by the results of our work. In our two years together, we represented in excess of a hundred clients through the legal process and, in many instances, complex legal and/or factual matters. I specifically recall two circuit court trials we worked on. One case involved a complex construction project where we represented an engineering firm in defense of a claim by the State Airports Division. The other case involved complex accounting issues where we represented a CPA in defense of claims of negligence. Aside from obtaining favorable results, Ms. Heely demonstrated the ability to analyze complex legal issues and to deal with a myriad of different personalities through the discovery and trial process. In addition, she is a student of the law in that she would always be current on the latest legal decisions and rationale for the areas of law we practiced. I found her to be meticulous in drafting, revising and finalizing any opinions she would convey to clients.

Although I did not have direct involvement in all her community activities, I do know that Ms. Heely's character is reflected in the activities and associations she developed. She served as a member of the Board of Directors of the Young Lawyer's Division of the Hawai'i State Bar Association, the chair of the Government Lawyers Section of the Hawai'i State Bar Association and is the vice-president of the Maui County Bar Association. She also sits on the Board of Examiners of the Hawai'i Supreme Court.

In our professional working relationship, I have always found Ms. Heely to practice and display the highest level of integrity, credibility and morals. I believe her character to be unassailable. Her character is also reflected in her enthusiasm for her work and her embracement of all things good in Hawai'i. She is a *keiki o ka aina*, with a strong sense of seeking to provide justice for all people, whether they are a professional person or an individual who cannot speak for his or her civil rights.

Since she may have more direct contact with litigants in a pro se capacity on the District Court bench, I believe Ms. Heely will be able to effectively reach out, understand and communicate with the broad range of people we have in our State. She is a problem solver not a problem creator. I believe she has the attitude to treat litigants and counsel with respect and courtesy; in other words, I believe she has the right temperament to sit as a State District Court Judge.

The HSBA Board has established criteria for determining the qualifications of judicial appointments generally utilizing the American Bar Association Guidelines for Reviewing Qualifications of Candidates for State Judicial Office. The HSBA uses the following criteria in its deliberations: integrity and diligence, legal knowledge and ability, professional experience, judicial temperament, financial responsibility, public service, health, and responsibilities and duties required of the position for which the applicant has been nominated. The HSBA Board's rating system includes the categories of "qualified" and "not qualified."

As part of its procedures for evaluating and taking positions on judicial appointments, the HSBA Board utilizes a subcommittee of the HSBA Board to review materials presented by the nominee and input from members. The subcommittee is also tasked with checking references and contacting others who have knowledge of the nominee's experience and qualifications. The full Board reviews the materials prepared by this subcommittee, the materials submitted by the nominee and members, and conducts an interview of the nominee.

Taking into consideration all of the information presented by and about the nominee and an interview with the nominee, the Board of Directors of the Hawaii State Bar Association finds Adrianne N. Heely to be qualified for the position of District Family Court Judge, Second Circuit Court.

I have known Ms. Heely for approximately seven (7) years and my contact with her has been entirely in the professional context.

I first came to know Ms. Heely in the first few years that I began working for the Department of the Corporation Counsel with the City and County of Honolulu. At that time, Ms. Heely was working for the Law Offices of Frank Goto, a private law firm. Ms. Heely represented another party in a premises liability case involving several defendants—one of these defendants was my client, the City. Given the extensive discovery and motion proceedings that took place in that case, I was able to develop an informed opinion of Ms. Heely's character and abilities. Ms. Heely was, and is, an adept advocate. She always appeared prepared and knowledgeable with regard to the particular legal or factual issue at hand.
