RELATING TO GOVERNMENT

Description:

My name is Tom Berg and I represent the residents of Honolulu City Council District One, testifying in support with a proposed amendment.

SB 2080 encourages the use of City facilities for bicycle motocross activities. It provides that counties may allow bicycle motocross activities at public skateboard parks. Specifies that counties are not prohibited from constructing or designating county facilities for bicycle motocross parks. Limits the liability of the counties, the State, and volunteers for damages or injuries that result from bicycle motocross activities at public skateboard parks and bicycle motocross parks.

I support the intent and contents of the bill but it does not go far enough. It should also include motorized motocross cycles. There is a huge lack of facilities and places for these types of bicycle motocross and motorized motocross activities. By adding the motorized motocross, there will be greater flexibility to the Counties to offer a wider variety of motocross activities at County parks and facilities.
