I urge your full support for SB2095. SNAP is one of the most beneficial federal programs. It provides food for those with incomes inadequate to provide for a regular wholesome diet. In 2010 President Obama expanded the eligibility for SNAP from 130% of poverty to 200% of poverty. Thousands of additional residents are now eligible for SNAP.
