I would like to share my testimony on the SB2145 bill.

I have been diagnosed with SMI Serious Mental Illness. I was up until recently, under AMHD and on SSDI. I was given a Ticket to Work from SSA and found a part time job. However, after a few months, I was told that I would no longer be able to stay at my group home, as I had to take the insurance offered by my new job. This resulted in me losing my housing, mental helath case management, psychiatrist, and I lost my support system from Clubhouse. It was if I was being punished for tyring to do what I had been taught at clubhouse, to rehabilitate myself and get back on my feet, get a job and not rely on government assistance. I was suicidal, even lately I have been very depressed, with all the new challenges that I face, now without any support for my mental health issues. I would like to be able to tell people, (those like me who are on government assisitance and living with mental health issues) that it is a positive experience to overcome the obstacles associated with rehabiliation, however until this issue; that now people with mental health issues are not reciving the help that they so desperatley need, beacause of their insurance rather then their diagnosis, is fixed, I will not lie to them and tell them that it will be better for them. Here

in Hawaii right now, they should stay on assistance until the State of Hawaii realizes that they are employing people at AMHD clubhouses to get people to return to work, only to lose everything. I have faith that you would see the flaw of the current rules on AMHD services, how it actually punishes its consumers for doing what it tries to promote psychoo social rehabilitaion and dicriminates against people beacuse of their insurance rather than their mental health diagnosis.
