## Re: SB 2182 Relating to the Center for Nursing

The Workforce Development Council ("WDC") supports the amendment to repeal the 2014 sunset date and make permanent the assessment and deposit of center for nursing fees into the compliance resolution fund and distribution of those funds to the credit of the center for nursing special fund.

The WDC is an attached agency to the DLIR and is responsible for advising the Governor and Legislature on workforce development to support economic development and employment opportunities for all. The WDC is also the State Workforce Investment Board for purposes of the federal Workforce Investment Act ("WIA") of 1998. The WDC assists the Governor in developing and updating comprehensive five-year strategic workforce investment plans and oversees workforce (public) investment activities in the state.

In response to Governor Neil Abercrombie's New Day Plan goal to develop and implement a comprehensive strategy to address Hawaii's aging population and ever increasing healthcare needs, the WDC has recently completed a Healthcare Workforce Development Plan and Report (an Addendum to the Comprehensive State Plan for Workforce Development 2009-2014) published in December 2011, which documents Hawaii's severe healthcare workforce shortages. Without support of legislation like this, the plan describes how primary care shortages, especially on the neighbor islands and rural areas, will have an estimated statewide shortfall of 20% by the year 2020. To develop this plan, the WDC enlisted over 150 healthcare stakeholders statewide to discuss workforce barriers and plan solutions for some of the most needed health occupations in Hawaii. Representatives from the Center for Nursing proved especially helpful in providing information to stakeholders to further develop the plan, which documents Registered Nurses to be in the top 20 High Demand Health Occupations in the state. Comments from stakeholders revealed a major issue as new nurses not having the skills required for success in Hawaii's workplace. The Center for Nursing NEIL ABERCROMBIE GOVERNOR

helped to identify and address this and many other issues specific to the nursing profession and must continue to be funded in order to address the numerous, diverse needs of Hawaii's nursing workforce.

Some of the center's plans have proven especially helpful in developing a healthy nursing workforce. For instance, the center's focus on removing scope of practice barriers has provided industry-driven recommendations that will increase the workforce of skilled nurses. The center's implementation of the Nurse Residency Program has been monumental in improving the quality of new nurses entering the workforce to better meet the needs of employers. The center's focus on increasing the number of nurses with Baccalaureate and Doctorate degrees has also brought this need to the attention of educators statewide who have often focused on graduating Associate degree level nurses, which in turn is producing an abundance of low-skilled workers who are displacing lower level healthcare professionals and earning lower than their expected pay grade. Additionally, the center's nursing surveys have proven immensely valuable when calculating future workforce needs, and have become an example of how future workforce surveys should be implemented to track the workforce gaps of other high needs healthcare professionals.

Overall, the WDC supports the amendment to make permanent the assessment and deposit of center for nursing fees into the compliance resolution fund and distribution of those funds to the credit of the center for nursing special fund in order to continue the excellent work of the Center for Nursing which has become the standard of what the future of healthcare workforce development in Hawaii should reflect.

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO supports the purpose and intent of S.B. 2182, H.D. 1, which makes permanent the assessment of the Center for Nursing fees into the compliance resolution fund and the distribution of those funds to the credit of the Center for Nursing special fund.

The HGEA supported the formation of the Hawaii State Center for Nursing (Center for Nursing) in 2003 and believes in its core functions which are to: 1) collect and analyze data, prepare and disseminate written reports and recommendations regarding current and future status and trends of the nursing workforce; 2) conduct research on best practices and quality outcomes; 3) develop a plan for implementing strategies to recruit and retain nurses; and 4) research, analyze and report data related to the retention of the nursing workforce.

The Center for Nursing provides valuable objective data and programs designed to address the nursing shortage that will materialize over the next 5-10 years. Hawaii is experiencing a short-term surge in the nursing workforce, but that is a temporary situation. A highly educated and competent nursing workforce is essential to the healthcare of Hawaii, and the Center for Nursing is a valuable resource in accomplishing that objective. Therefore, we support making permanent the assessment and deposit of the Center for Nursing fees into the compliance resolution fund and the distribution of those funds to the credit of the Center for Nursing special fund.

We appreciate the opportunity to testify in support of S.B. 2182, H.D. 1, but suggest amending the bill so that it takes effect upon approval.
