Thank you for allowing me the opportunity to testify in support of SB2192. My name is Warren Wegesend. I am the General Manager of the Villages of Kapolei Association and am here on behalf of the Board of Directors and the members of our Association.

SB 2192 exempts certain ground signs from county outdoor advertising regulation and allows ground signs to be posted in public places. For years the Villages of Kapolei placed ground signs throughout our community as means of communication with out members. We used sign boards to inform them about events within our community as well as providing notices of Board Meetings giving them an opportunity to participate in the governance of their community. Late last summer we were notified by the police department that we were in violation of State and County laws and if we continued to place our informational signs throughout our community that we could be subject to fines.

While we have a quarterly newsletter as well as maintain a website, we have found that the most effective means of communication is the sign board. It provides quick, concise and timely information to our membership. Our signs are generally placed throughout our community a week before an event and removed the day after.


