The Office of Hawaiian Affairs (OHA) strongly <u>SUPPORTS</u> SB 2211, which would provide a mechanism for the consideration of cultural practices in the environmental review process by requiring all draft and final environmental assessments to include a cultural impact assessment and all draft and final environmental impact statements to include a cultural impact statement.

SB 2211 provides an opportunity to fulfill the intent of Act 50, Session Laws of Hawai'i 2000, which required EISs to analyze the impacts a proposed project would have on cultural practices. As the Hawai'i State Legislature has found, "the past failure to require native Hawaiian cultural impact assessments resulted in the loss and destruction of many important cultural resources and has interfered with the exercise of native Hawaiian culture." *Ka Pa'akai O Ka'aina v. Land Use Commission*, 94 Hawai`i 31, 47, fn 28 (2000). Unfortunately, Act 50 did not provide a mechanism or minimal requirements for cultural assessments. In addition, administrative rules for CIAs do not exist. As a result, in the ten years since the passage of Act 50, we still see vast inconsistencies in the manner in which CIAs disclose a project's cultural impacts.

Finally, OHA is happy to report that since introduction of a similar bill during the 2011 session, we have been working with the Office of Environmental Quality Control and the Environmental Council to address these concerns through rule making. SB 2211 is consistent with these efforts and would support this initiative.

Therefore, OHA strongly urges the Committees to PASS SB 2211. Mahalo for the opportunity to testify on this important measure.


