## TESTIMONY ON Senate Bill 2252 RELATING TO CORRECTIONAL FACILITIES

Chair Espero, Vice Chair Kidani, and Members of the Committee:

The Department of Public Safety (PSD) appreciates the intent of Senate Bill (SB) 2252 that amends Section 353H, Hawaii Revised Statutes (HRS), to require all correctional staff to undergo the same drug screenings procedures as visitors, when entering correctional facilities.

PSD agrees there is a need for a proper mechanism to allow the appropriate screening of staff and visitors when entering a correctional facility. PSD continues to strengthen our entry procedures, but recognizes a stark difference between the procedures for staff and visitors. PSD trains and expects our staff to comply with our standards by upholding the law. Staff are aware that any involvement with the illegal possession of a controlled substance and other types of contraband may result in criminal prosecution.

In order to strengthen our entry procedures, PSD proposes the purchase of walk through metal detectors and x-ray machines so all personal bags may be screened. In order to fully execute this proposed procedure at our facilities, PSD will require an additional twenty-one (21) full-time Adult Corrections Officers and the necessary equipment. The cost for the first year of implementation is estimated at \$1,481,482. PSD would require additional funding of \$1,157,000 in the following years for staffing cost and maintenance of the system.

In conclusion, PSD appreciates the intent of SB 2252, and recommends modifications to this measure as stated above to improve safety and security measures at the correctional facilities.

#### Comments:

I appreciate your time in my being heard on what I believe to be a very important topic in which you are unaware. This piece of legislation is on the market and has my support with the exception of one piece of language. Just screening for drags does not solve the problem, however screening for all contraband as its recognized in the policies and procedures manual at PSD correctional facilities would. Correcting a systemic problem taking place at Hawaii Correctional Facilities. Embarrassingly, having been a detainee at the OCCC facility as a first time offender I have personal knowledge and have witnessed very disturbing things that this legislation touches upon. I am a bit perplexed that there are not mechanisms already in place for all correctional personnel to be screened mechanically and physically. Visitors are! They are screened for all facility recognize contraband. I can personally testify to witnessing contraband items in an inmates possession ranging from candy, tobacco, marijuana, cell phones, and even meth. More troubling, is personally witnessing the transfer taking place of such items on separate occasions. How did such contraband find its way into a secure state correctional institution and into an inmates possesion? Regretably, I'm here to testify that it was distributed to inmates by corrections officers in recreational yards and in module housing units for financial gains. Let me be clear, these occasions were few, but few is to many. Not all guards partake in these endeavors. In fact, most officers aspire to facility and inmate safety. However, for the few that do practice thid etiology, they are undermining the facilities integrity and preying on societies most codependent individuals. Significant taxpayer funds were ask for by and appropriated to PSD Corrections for modernizing scanning equipment. But these are only being implemented on visitors, during visitation days, or not at all. Correctional Facility Employees do not currently fall under the same scrutiny when entering the Correctional Facility. They are allowed free access. Thus, I am reporting to this committee I know first hand hawaii correctional facility OCCC is not contraband free. I further give testimony that while having to go to OCCC on a weekly basis for the better part of a month, not once did I witness a corrections employee being screened, lunch box or bag checked. Instead they were waved into the facility with impunity. My bag was searched, pockets emptied on each occasion, and only then was I allowed access. It's a systemic double standard! Having witnessed what I have, I overwhelming support this bill if language is changed to reflect a true form needed. I feel all in corrections should aspire to a higher standard or least to the same standard as visitors entering into a correctional facility. All forms of contraband that is recognized by the facilities policies and procedures should be screened for upon trying to gain access to a state correctional facility by all persons. Just screening for drugs leaves a major loophole for individuals to circumvent the system. This will insure Hawaii's correctional institutions are in compliance with present PSD correctional policies and procedures when it comes to the definition of contraband, making it safe and secure for all within the confines.
