Testimony of Anthony K. Shriver, Founder and Chairman Best Buddies International February 13, 2012

Thank you for the opportunity to submit written testimony in support of SB2269, Making an Appropriation to Best Buddies International to fund our inclusion programs for children and adults with intellectual and developmental disabilities in Hawaii.

I have known ever since I first visited Hawaii that Best Buddies would flourish here because of the generosity of spirit and caring nature of the people of Hawaii. Hawaii has abundant natural beauty. How well I recall travelling up into the hills to the volcanoes, the gorgeous beaches, and the powerful and alluring surf. What has stayed within me, though, is the welcome we got from the people. Each person we encountered paid excellent attention to us and made us feel right at home.

So, I am not surprised to tell you that, Best Buddies has been flourishing here since we launched our first programs on Maui in 2008. Our school-based programs have had a positive impact on over 4,000 children and adults. While we know the need here for Best Buddies is great, we also know the ability of the people to meet that need is strong – so long as we secure the funds that will ensure that every child with special needs is educated in an inclusive setting.

We know that it is the development of social skills that best prepares students with intellectual disabilities for life on the job and in the community after school. Yet, without Best Buddies, most special education students never have the chance to develop those skills through interaction with their typical peers. In Hawaii, nearly 32% of students with disabilities spend more than 60% of their time in school separated from their non-disabled peers (www.ideadata.org). Hawaii's students with disabilities are separated from their non-disabled peers more than any of the other 50 states and territories with the exception of Guam.

With an appropriation from the state, we can expand to serve even more students in more schools. Specifically, state support would fund an office on Oahu that would manage Best Buddies chapters at 15 middle and high schools and involve at least 300 additional students.

I am proud of the work that Best Buddies Hawaii has done under the leadership of our State Director, Mike McCormick. We have proven ourselves a worthy partner of the state's investment, and I hope you will pass this request for funding.

Testimony for SB 2269 February 12, 2012

Good afternoon, my name is Sarah Man and I'm President of the Best Buddies Oahu Advisory Board. Many years ago I was a member of Best Buddies in Indiana. Upon moving back to Hawaii two years ago with my husband and family I was shocked to hear that Best Buddies was not on Oahu. I immediately put together a board of community leaders in an attempt to get funding to start local chapters.

This is extremely important to me and my family. I have a seven year old daughter with autism. We must lay the groundwork necessary for children with Intellectual Disabilities to be included in the community. Best Buddies is **hands down** the best program for inclusion.

Quite often, young people with intellectual disabilities are forgotten, left behind both academically and culturally. Whether it's sitting alone in the cafeteria, isolating themselves in the back of the bus, or fearing being waylaid by taunts and teasing by their general education peers, these young people merely want to fit in. A recent study revealed that 83 percent of children and young adults with disabilities in this age group have undergone some type of bullying ranging from being sworn at to sexual abuse.(Intellectual and Developmental Disabilities, Bullying Among Special Education Students with Intellectual Disabilities, Reiter and Lapidot-Leftler 2007).

It is sobering to realize that they are segregated from their peers, left in an isolated world void of friendship and interaction. Often their only recreation is watching television, removed from the active world around them. (Mental Retardation, "I'd Rather Watch TV": An Examination of Physical Activity in Adults With Mental Retardation, Georgia C. Frey, Alice M. Buchanan, and Dawn D. Rosser Sandt). Students with special needs hear about sporting events, dances, school clubs and social service days, but these activities are not yet fully available to them. "Disabled young people are often left out of the less formal 'rites of passages' such as joining a sports team, courting, learning to drive the family vehicle. This exclusion distinguishes young people with disabilities from all other groups of young people" (Groce, 2004).

Best Buddies introduces socialization opportunities and job coaching, providing the necessary tools for people with IDD to become more independent and, consequently, more included in the community.

Best Buddies High Schools has paired students with IDD in one-to-one friendships with high school students. By introducing Best Buddies into public and private high schools, participants are crossing the invisible line that too often separates those with disabilities from those without. In today's middle schools, students with IDD often enter the same building and walk the same hallways as their peers, but they are left out of social activities.

Please consider this very important bill. It is paramount for the future of our social fabric.

When an adult is asked to recount her high school days, she thinks of whether she felt a general sense of belonging. Did she feel noticed, involved, did people care? Most of us still have friends we made in high school. Many of those friends became our social support network during life's ups and downs. The social aspects of middle and high school stay with us throughout our adult lives.

Now please imagine two scenarios.

In the first scenario, you attend classes at a high school on Oahu, but you are not included or involved in the social aspects of the school. You have lunch in a portable classroom far away from the "hub" of the school with your teacher and one or two classmates. You've never met any of the kids you hear about on the school's news announcements. You never go to the sports events. You get on the yellow bus immediately after the school bell rings and never participate in extracurricular activities. Imagine watching television shows that depict teenagers "hanging out" with friends. You think, "why isn't my life like that?"

Now imagine eating lunch in the cafeteria with a group of with kids. Imagine having typical teenagers say "hi" to you in the hallways. Imagine attending a school basketball game or a pizza party with some of these same teens. Imagine having contact with these new friends outside of school as well. How different your life would be. Well, this scenario is happening now at Kapolei Middle and High School on Oahu thanks to Best Buddies. Other schools would like Best Buddies chapters, but funding is needed to get these programs up and running.

Best Buddies is an international program that promotes friendships between youth with and without intellectual disabilities. Please consider Senate Bill 2269 to expand the opportunities described above to other schools in our State. Senate Bill 2269 requests a small investment of state funds that will provide life-changing experiences for young people in Hawaii. These friendships are a "game-changer" in promoting acceptance in our schools and our communities. Please consider being part of the change.

We are grateful to have support from Maui County and the City and County of Honolulu, as well as a number of corporations, foundations, and individuals. We would like to partner with the state in order to serve more Hawaiians who are in need.

Testimony in support of SB2269

I write, as a private citizen, in support of SB2269 MAKING ANN APPROPRIATION TO BEST BUDDIES INTERNATIONAL

I have observed the Best Buddies Program on Maui as they have participated on our Panels for the Maui Disability Alliance Legislative Forum and at our annual BIG MAC High School Transition Event for students with special Needs.

The Best Buddy program fosters inclusion for students with special needs by giving them a peer buddy at their school.

This relationship of "Buddy" benefits the student with the special needs but also equally benefits the student who is being the "Best Buddy".
