to provide the purchaser with RICO's address, telephone number, and email address. The bill also requires the same disclosures at the time services or merchandise are provided under the terms of the contract.

Senate Bill No. 2316 recognizes the potential vulnerability of consumers both when cemetery or funeral services are purchased and when these services are provided. RICO supports Senate Bill No. 2316 because the bill provides consumers with important contact information that they can reference should they have questions or concerns about their transactions at the time of purchase or when services are rendered.
