1 EOA's Position: The Executive Office on Aging (EOA) supports the intent of this measure, 2 provided that its enactment does not reduce or replace priorities within our Supplemental Budget 3 Request. Fiscal Implications: This measure appropriates unspecified amounts for: 4 5 A home- and community-based services program; 2. The Healthy Aging Partnership Program; 6 7 3. Catholic Charities for the Lanakila Multi-purpose Senior Center, Moiliili Community Center for the Moiliili Senior Center, and Waikiki Community Center; and 8 4. A wanderer's registry to protect individuals with Alzheimer's Disease and related 10 dementia. Purpose and Justification: The Kupuna Care Program has been providing essential services for 11 12 Hawaii's seniors since 1999, and is Hawaii's only state-funded home- and community-based

services program for older adults who do not qualify for other government or private assistance.

- 1 Although highly successful, the Kupuna Care program has always been considered a
- demonstration project, and therefore, administrative rules have never been established.
- 3 EOA would like to develop administrative rules for Kupuna Care, but we are unable to do
- 4 so until the program is established within EOA's statutes and the Director of EOA is given the
- 5 authority to adopt rules. Therefore, we are in support of Section 2 which statutorily establishes the
- 6 Kupuna Care Program within EOA.
- We note that the appropriations in this measure are not part of the Governor's
- 8 Administrative package. Should there be surplus funds available for this measure, we would be
- 9 supportive as we agree with the concept of these initiatives as they are consistent with EOA's
- 10 goals and objectives. If the Legislature deems these programs necessary, EOA respectfully

MCOA's Position: Maui County Office on Aging (MCOA) is in strong support of SB2320 SD2 HD1 RELATING TO AGING. This measure provides funding for Home and Community Based services administered by each County Aging and Disability Resource Center, supports the Healthy Aging Partnership that includes Better Choices, Better Health and EnhanceFitness, supports senior centers on Oahu, and assists with the development of enhanced services for individuals with Alzheimer's Disease and their family caregivers. The direct result of the measure is that the Executive Office on Aging (EOA) and all four Area Agencies on Aging (AAAs) will be enabled to better assist the aging population to remain living as independently as possible in the community.

**Purpose and Justification:** SB2320, SD2, HD1 builds and strengthens a statewide system of support of Hawaii's older adults and their family caregivers. *The need is clear and compelling*. There are about 238,000 Hawaii residents aged 60 and over who constitute 18.7% of the state's total population. Between 2000 and 2030, the number of adults 60 years and older will increase by 93.8% and those 85 years and older will increase by 174.7%. This explosive growth of older

adults alerts us that a strong infrastructure must be in place to serve the growing needs especially as the baby boomers join this age group.

Critical components of Hawaii's aging infrastructure are being addressed by the programs in this bill: 1) access to information; 2) affordable home and community based services including respite care for family caregivers; 3) social and civic engagements for retired seniors; 4) keeping people with Alzheimer's and dementia related diseases safe; and 5) promoting healthy aging through the Healthy Aging Partnership evidence-based programs.

Both direct services as well as a focus on prevention activities are necessary. While we cannot ignore those who need assistance with the basic functions of daily living, we must also work diligently to assist our aging citizens to live as healthily as possible for as long as possible in the most cost effective way as possible.

While the aging population is increasing exponentially each year, the base funding for providing services to assist seniors to remain living in the community has not been increased. For this reason, SB2320 SD2 HD1is crucial at this time.

Keeping seniors healthy and at home is the most cost-effective manner to address the needs of one of our most valuable societal resources, and SB2320 SD2 HD1 will ensure that state funds are utilized to provide assistance in the community at a much lesser financial drain than institutional services. By funding home and community based services, family caregiver assistance, and prevention services, the overall need for Medicaid enrollment and expensive residential care will be minimized.

POSITION:

The Policy Advisory Board for Elder Affairs strongly supports SB 2320 SD2 HD1, which establishes the Kupuna Care program in the EOA statutes and appropriates funds for the Kupuna Care Program, Healthy Aging

Partnership Program, Senior Centers, and Elder Registration Services.

### **RATIONALE:**

The Policy Board for Elder Affairs has a statutory obligation to advocate on behalf of the senior citizens of Hawaii. While we advise the Executive Office on Aging, we do not speak on behalf of the Executive Office of Aging.

- The Kupuna Care program has been a pilot program in the Executive Office on Aging since 1999. The program needs to be established in statutes so that administrative rules can be created which will assist in the efficient operation the program. The program enables frail elders to be cared for at home and there will be a growing need for the services. The program reduces the need for Medicaid enrollment and expensive residential care.
- During the past several years, the "Rainy Day" fund has enabled many essential services
  to be offered to our most vulnerable citizens. These funds end in June of 2012. Although,
  revenues are still low due to a slow process of economic recovery, it is both cost-effective
  and consistent with our community values that we maintain funding for critically needed
  services.
- Just to maintain current Kupuna Care services, EOA is requesting an additional \$4.2 million, which provides services for between 1254 and 3398 individuals, depending upon level of impairment. These services are for frail elders not eligible for Medicaid services, enabling families to care for their elders at home and keeping persons from having to go on Medicaid. Not to fund basic home and community services would result in many persons having to use higher cost residential/institutional care, usually at public expense.
- Evaluation research in Hawaii shows that The Healthy Aging Partnership program
  reduced hospital stays, emergency room use, and falls among the frail elderly and
  increased physical functioning, thus resulting in substantial reductions health care costs.

- Senior centers serve as important and accessible resources for senior programs, congregate meals, health monitoring and education, wellness and exercise programs and social and recreational activities which enrich the lives of our citizens.
- Elder registration services are a much needed addition in order to assist law enforcement officers when confused seniors become lost when away from home.

These programs are the heart of our efforts to address the many needs of our vulnerable senior population, who face many challenges in their older years. The proportion of our budget which is devoted to these worthy services is relatively small, but in most instances has the potential to actually save on potential costs as well as assure a quality of life to our vulnerable citizens.

The vehicle makes no difference as long as the content of the legislation passed is to support the elderly and their caregivers to receive the support needed to keep them living independent of long-term care institutions.

Good afternoon, Chair Oshiro, Vice Chair Lee, and Members of the Finance Committee,

Lanakila Pacific strongly supports SB 2320, SD2, HD1 Relating to Aging to provide critically needed services for our most vulnerable seniors. Although our preference is that ongoing support be provided in the base budget, this measure provides essential supplemental funding for Kupuna Care services (now called home and community based services program) which are designed to prevent more costly care.

As a Kupuna Care service provider, Lanakila Meals on Wheels, a program of Lanakila Pacific, serves more than 1,200 seniors every day or more than 250,000 meals each year. Our staff and volunteers deliver more than a nutritious meal, as they may be the only person that the senior will spend time with each day. Our average meal recipient is a woman of Asian or Pacific Island descent, 83 years old with an income of less than \$1,000 per month.

As a Kupuna Care program, we also provide nutritional education and counseling, monitor health and welfare, and serve as an important bridge to support services, helping seniors remain in their homes rather than more costly premature institutionalization.

Unfortunately, the Kupuna Care appropriation in the base budget has remained flat at \$4.85 million since 2002, despite our rapidly aging population's even more urgent need for these critical services. Because of this, Kupuna Care programs including Lanakila Meals on Wheels are faced with heartbreaking waiting lists.

Lanakila Meals on Wheels alone is already facing a waiting list of 303 seniors that will continue to grow. Seniors like 93 year old Mr. R who was diagnosed with terminal cancer two years ago. He ever imagined needing assistance and wants to stay in his own home for as long as he can. The services of Kupuna Care will enable Mr. R to continue to live in his own home at a fraction of the cost of a nursing home.

According to the most recent Hawaii's Older Adults: Demographic Profile: University of Hawaii, Hawaii has one of the fastest growing senior populations and the longest life expectancy in the nation. By the year 2020, one out of every four people in Hawaii will be 60 years and older.

Providing Kupuna Care Sevices, which enables seniors to stay in their homes and avoid costly institutionalization, can be the difference between \$170 for a month of home delivered meals vs. \$9,034 for a month of a semi-private room in a nursing facility.

The passage of this measure is vital as it will provide critically needed and more costeffective services for the most isolated and vulnerable seniors in Hawaii. Aging network providers cannot meet the current and growing demand for services when faced by years of flat or reduced State and Federal funding.

We urge you to support seniors by supporting ongoing funding for Kupuna Care as it provides essential services for the most isolated and vulnerable seniors in Hawaii.

### Supporting SB 2320 SD 2 HD 1: Relating to Aging

The Healthcare Association of Hawaii advocates for its member organizations that span the entire spectrum of health care, including all acute care hospitals, as well as long term care facilities, home care agencies, and hospices. In addition to providing quality care to all of Hawaii's residents, our members contribute significantly to Hawaii's economy by employing over 40,000 people. Thank you for this opportunity to testify in support of SB 2320 SD 2 HD 1, which appropriates funds for various programs to improve care for the elderly.

This bill is one of many that are designed to strengthen the infrastructure that cares for the elderly or reduces elder abuse. Hawaii's elderly population is growing faster than even the national average. Since statehood, the proportion of elderly to Hawaii's total population has increased three-fold, from roughly 5% in 1960 to 15% in 2009. By comparison, the nation's population stands at 13%. Between 1990 and 2009, the number of elderly aged 75 and older increased 115% in Hawaii compared to 44% nationally. By 2030, the elderly population will represent 20% of the population in Hawaii.

There is a clear relationship between age and the prevalence of chronic conditions and level of disability, so the elderly are the heaviest users of health care resources. Hawaii's existing resources are not sufficient to satisfy the current high demand for care for the elderly, which is increasing further as the population ages. This bill takes several steps toward improving the infrastructure to care for the elderly.

### Chair Oshiro and Committee Members:

AARP is a membership organization of people 50 and older with nearly 150,000 members in Hawaii. We are committed to championing access to affordable, quality health care for all generations, providing the tools needed to save for retirement, and serving as a reliable information source on issues critical to Americans age 50+.

AARP strongly supports SB2320 SD2, HD1. This bill establishes the home and community based services program (also known as Kupuna Care); and appropriates funds for the needs of the State's older adults and elderly population. AARP especially supports the funding for the home and community based services program, and offers the following comments.

This bill appropriates funds out of the general revenues of the State of Hawaii for fiscal year 2012-2013 for the home and community based services program. This appropriation is in addition to the current \$4.85 million Executive Office on Aging base budget appropriation that has remained unchanged since 2002, even though demand for services has increased as a result of our rapidly aging population.

In 2011, the home and community based services program, Kupuna Care, served 4,836 persons statewide, at a cost of \$103 per month, per person. The Executive Office on Aging has estimated that an additional \$4.2 million appropriation could serve up to an additional 3,398 persons depending on the level of impairment.

Seniors and caregivers need assurances that they will continue receiving occasional, yet critical respite services that enables them to live in their homes as long as possible.

The passage of this bill is vital to support the increasing demand for service from our rapidly aging population:

- Approximately one out of every five (20%) Hawaii residents are over 60 years old.
- Hawaii's population over age 65 is increasing rapidly and projected to increase by 71% between 2010 and 2030.
- Approximately 247,000 family caregivers are the backbone of Hawaii's long-term care system and currently provide nearly \$2 billion a year of unpaid caregiving services.
- The number of family caregivers is declining. The primary family caregiver group is 50-64 years old. This group will decline by 10% by 2030, and cause further strain on seniors and remaining caregivers.

The Alzheimer's Association, Aloha Chapter strongly supports the adoption of the Relating to Aging Bill, SB 2320 SD2 HD1, which establishes the Kupuna Care Program amongst other vital and important services for the elderly within the state of Hawaii. Also included in the legislation is funding for the establishment of a Wanderer's Registry for persons with Alzheimer's disease or a related dementia (ADRD). The development of a statewide Wanderer's Registry is of critical importance to the safety and protection of persons with ADRD.

Alzheimer's disease is a progressive, degenerative disorder that attacks the brain and the brain's nerve cells typically affecting people 65 years and older. This usually results in loss of memory, decreased thinking and language skills, and extreme behavioral changes. It is estimated that more than 31,000 people within the state of Hawaii have Alzheimer's disease or a related dementia. Furthermore, about 60% of people with Alzheimer's disease wander. Incidences of wandering can pose many dangers and result in injury, hospitalization, or death of the person who has wandered. Additionally, communication and memory problems may impair a wanderer's ability to provide their name, correct home address or any other pertinent information required by emergency response personnel.

The Wanderer's Registry provides a solution to this safety concern by providing a 24-hour emergency response service for individuals with ADRD that wander or who have a medical emergency. Members enrolled in the registry will wear a bracelet which identifies who they are and their medical conditions. For incidences in which a wanderer is found, whether it is by emergency personnel or a Good Samaritan, hotline or chapter staff will contact the caregiver and provide safety planning to prevent future incidences of wandering. In situations in which the caregiver reports a missing individual, hotline/chapter staff will assist with activating search and rescue efforts in addition to providing safety planning upon finding the wanderer.

Please make one aspect of caregiving easier for the 31,000 families with Alzheimer's and dementia in Hawaii, by supporting the enactment of SB 2320 SD2 HD1.

Garval, President & CEO of Child & Family Service, Hawaii's oldest and most comprehensive human service nonprofit organization with services on every island. Each year we touch the lives of 40,000 Hawaii residents from keiki to kupuna.

I am testifying in support of SB 2320 which supports the continuation of implementation of the Hawaii Aging and Disability Resource Centers (ADRC); the allotment of funds for Home and Community-Based Services (Kupuna Care Services) to meet the increasing demands; the continued support and appropriations for the Healthy Aging Partnership (HAP); Senior Centers and implementation of an elder registration program to address the needs of individuals with dementia who are at risk of wandering. These measures help to strengthen the safety net that protects our Kupuna.

As a provider of senior services for the past 30 years, we have seen firsthand the difficulties faced by seniors and their caregivers. In a time of reduced resources, the ADRC makes economic sense. This federal initiative of the Administration on Aging and Centers for Medicare and Medicaid Services will help Hawaii by:

- Improving operations across counties through standardization of tools and the adoption of common performance standards.
- 2. Ensuring that older adults and individuals with disabilities can make informed choices about how to meet their long-term care needs.
- 3. Positioning the state to respond to federal initiatives and requirements affecting health care and long term care services.
- 4. Helping residents of Hawaii keep their loved ones in the community by building programs that support the spirit of 'ohana.

Home and Community-Based Services (Kupuna Care) Program serves frail elders not eligible for Medicaid services, enabling families to care for their elders at home and keeping persons from having to go on Medicaid. Such services also include Meals on Wheels which are critical to seniors. Reducing funding for basic home and community services would result in many persons having to use higher cost residential/institutional care, usually at public expense. Current Kupuna Care funding falls far short of meeting the critical need, and the demand for these services will continue to grow. EOA is requesting an additional \$4.2 million for Kupuna Care, which would enable services for between 1254 and 3398 individuals, depending upon level of impairment.

As a member of the Health Aging Partnership we have implemented the Better Choices, Better Health and EnhanceFitness programs along with other evidence-based programs for seniors. Better Choices Better Health help Hawaii's diverse senior population make good choices using the tools learned in the six week class. CFS was so impressed with the EnhancedFitness program that we also implemented this into our No Fear of Falling Program. Our outcomes were similar to those of Kauai which was funded through the state program. We've seen an improvement in our senior's health and well-being that is in line with the state and the nation.

We recognize the importance of Senior Centers as a "first responder" in the Aging Network. Participants are monitored and linked to services as their needs become evident. These centers serve the more active seniors and add quality to their lives.

There is an estimated 28,000 people living in Hawaii with Alzheimer's disease. Six in 10 people with the disease will wander, and many cannot remember their own name or address. With a registry in place, many wandering patients are found even before they are reported missing. Many families cannot afford this simple program and the funding of the program will assist in reaching many low income families.

At Child & Family Service our mission is Strengthening Families and Fostering the Healthy Development of Children. I think you can see why we strongly support SB2320 which strengthens a senior's family and support their continued living in the community. We and ask for your support of this bill.

HCF has been providing direct private support to programs that serve a limited number of elderly throughout the State for many years. We are keenly aware of the demographic data showing the need for long-term care and supports for Hawaii's elderly, as well as the current status of our long-term care infrastructure. Because our philanthropic dollars are limited, we continue to seek opportunities to leverage those dollars and help build systems that will continue to support this growing population. My name is Michael Lee, Interim Executive Director of Waikiki Community Center (WCC).

Waikiki Community Center (WCC) is a nonprofit 501(c)(3) agency that has provided services to Waikiki's elders since 1978 and currently serves over 500 older persons each year. Our Senior Program provides vital fitness, cognitive stimulation, social connectivity, education and case management that enable hundreds of older adults to maintain wellness and age in place, for as long as it is possible.

Waikiki Community Center is a community-based focal point for seniors to receive needed services and activities that support their independence and avoid pre-mature institutionalization, thereby saving the State of Hawaii over \$100,000 per person annually in long-term care costs. The Center provides a continuum of over 80 educational, recreational and social services, including health screenings, financial education, physical fitness classes, information and assistance, counseling and case management by a licensed social worker, that helps seniors not only maintain their independence and health, but also assists them as they transition through life changes.

WCC utilizes a preventative health, community-based model for services to older adults, with a focus on 3 major areas that national research documents as imperative to maintaining the ability to age in place:

- physical activity;
- new learning or cognitive stimulation; and
- social connections

The importance of this 3-pronged approach is based on the following evidence: The Bureau of Labor and Statistics states that only 2% of adults aged 75 and older are involved in exercise or recreational activity. Fifty-four (54%) percent spent their time watching TV. It is well established that physical activity has a positive effect on health, leading to better mental health and cognitive functioning. Exercise also reduces the risk of dementia by 50%, even among people who begin exercise after age 60.

According to research at the Rush Alzheimer's Disease Center, "Loneliness and Risk of Alzheimer's Disease". loneliness has a negative impact on cognitive health and increases the risk of dementia. Elders with higher loneliness scores may be twice as likely to develop dementia. In a study of 7 senior centers in 7 states, over 90% of seniors indicate that they have developed important close friendships at the senior center that provide them with needed emotional security.

For the elders of Waikiki, this is especially important. Approximately 25% of Waikiki's 20,000 residents are over the age of 60 years old. Waikiki has one of the highest numbers of senior citizens per area density on Oahu. Waikiki elders live alone among a proliferation of secured, mixed residential condominiums, and are especially at risk to social isolation and physical and cognitive deterioration. The typical elderly resident is female, mid 70's, living alone, with little or no family support systems nearby. When they become frailer, they have little choices of independent living and are often confused by services available to support them. Waikiki Community Center's continuum of services, ranging from health maintenance activities to case management and counseling provide the needed support to these elders.

Waikiki Community Center has submitted a Grant-in-Aid request to support senior services for 2012-2013, in the amount of \$60,000.

While we understand the great financial challenges faced by the State of Hawaii the Waikiki Community Center remains in jeopardy of discontinuing its services to seniors in the community. We have already reduced some services to our seniors, furloughed program staff in order to keep the program operations available to the community, and will likely terminate case management and counseling services for older adults if funds are not available.

Home and Community-based Services Program (Kupuna Care) serves frail elders not eligible for Medicaid services. Most importantly, it enables families to care for their kupuna at home rather than having to institutionalize them often at public expense. Senior Centers are also important because they provide essential programs for active seniors to come together and remain productive members of the community. Lastly, there is an estimated 28,000 Hawaii residents with Alzheimer's disease. Statistics reveal that six in 10 people with the disease will wander justifying the need for the implementation of an elder registration program.

Catholic Charities Hawai'i (CCH) is a tax exempt, non-profit agency that has been providing supportive home and community based services to elders since 1973 and currently serves approximately 5,000 older persons each year. We strongly support SB 2320, SD2, HD1.

This bill will provide funding for a number of important services for senior citizens. In particular, it will allow the continuation of services that were maintained or increased through Act 191, Emergency and Budget Reserve funding. This funding ends in June 2012. Without additional funds through SB 2320, SD2, HD1, there will be significant reductions in services provided to our Kupuna, particularly through senior centers and Kupuna Care:

### SENIOR CENTERS

SB 2320, SD2, HD1, supports a network of senior centers on Oahu that provide vital health education and screenings, fitness, recreation, case management, and other services to enable thousands of senior citizens to maintain wellness, support independence and avoid costly institutionalization and have a history of state funding.

Catholic Charities Hawai'i has operated the Lanakila Multi-Purpose Senior Center since 1981. Lanakila Multi-Purpose Senior Center is a State owned facility that was built as a model senior center for the State of Hawaii in 1969. The Center provides a range of educational, recreational and social services that include:

- Exercise and Educational activities, such as Stretch & Tone and Basic English.
- Recreational courses, such as Ukulele and Sewing.
- Sponsorship of 7 ethnic clubs that perpetuate ethnic traditions and promote cultural sharing.
- Health promotion and screening activities, such as monthly blood pressure checks, health fairs, and more.
- Special events for education and recreation purposes, such as Candidates' Fair.
- Onsite access to professional counseling and case management services –available to Center members and their caregivers to aid in the transition from independence to interdependence.

• Opportunities for hundreds older adults to contribute their time and skills to the community thousands of hours of volunteer service annually.

The Center serves senior citizens, age 60 and older. By contract, it serves seniors living in the geographic area bounded by census tracts 38-66 (Kakaako - Nuuanu/Punchbowl – Downtown - Liliha/Kapalama - Kalihi/Palama - Kalihi Valley - Moanalua). Its priority is to serve those in greatest economic and social need, with an emphasis on serving low-income, minority elders. Seniors who live outside the contracted geographic area and lack access to comparable services due to language, etc. are also served.

### **KUPUNA CARE (Home and Community-Based Services Program)**

Catholic Charities Hawai'i is also the current provider of Kupuna Care transportation services. Currently, Act 191 (Emergency and Budget Reserve funding) provided funds that make it possible for Catholic Charities Hawai'i to provide an additional 6,000+ trips for seniors to access health, nutrition and other services this fiscal year. Additional funding through SB 2320, SD1, HD1, will assure that seniors will continue to receive access to the services they need that support their ability to remain independent in the community.



Healthy Aging Partnership

This is a testimony in support of S.B. # 2320, SD1, HD1 – Relating to Aging which provides funding for Kupuna Care (Home and Community Based Program), Aging and Disability Resource Center, Healthy Aging Partnership that includes Better Choices, Better Health and Enhance Fitness workshops, Alzheimer's registry, and seniors centers. This bill builds and strengthens a statewide system of support for Hawaii's older adults and their family caregivers. The need is clear and compelling. There are about 238,000 Hawaii residents aged 60 years and over who constitute 18.7% of the state's total population. Between 2000 and 2030, the number of adults 60 years and older will increase by 93.8% and those 85 years and older will increase by 174.7%. The explosive growth of older adults alerts us that a strong infrastructure must be in place to serve their growing needs especially as the baby boomers join this age group.

Critical components of Hawaii's aging infrastructure are being addressed by the programs in this bill:
1)access to information; 2)affordable home and community based services including respite care for family caregivers; 3) social and civic engagements for retired seniors; 4) keeping people with Alzheimer's and dementia related diseases safe; and 5) promoting healthy aging through the Healthy Aging Partnership program. The Healthy Aging Partnership is a major initiative which offers two widely used evidence-based health promotion programs - Better Choices, Better Health and EnhanceFitness. These programs are available throughout the state to empower people with chronic diseases take control of their health and better manage their health conditions. Better Choices, Better Health is a weekly, sixweek sessions which cover topics ranging from healthy eating and exercise, pain and stress management, appropriate use of medication and other practical tips and easy to use tools to help people live a healthy lifestyle.

EnhanceFitness is a group exercise program which helps elders become more active, energized and empowered to sustain independent lives through structured exercise sessions of stretching, low impact aerobics and strength training. The one hour classes are offered three times a week and led by certified fitness instructors who are trained in EnhanceFitness. Both programs have demonstrated to be effective in helping people adopt healthy behaviors, improve their overall health, and reduce

hospitalizations and emergency room visits. For example, Hawaii data showed- 39% fewer falls; 19% decrease in hospitalizations; and 25% decrease in experiencing symptoms such as pain, fatigue and shortness of breath and 31% increase in the number of days spent in physical activities per week. These health improvements translate to health care cost savings especially for Medicare and Medicaid. Effective management of debilitating and chronic conditions can reduce the cost of medications, hospitalizations, frequent physician visits while improving people's quality of life and independence.

- The provision of Kupuna Care Services enables seniors to live in their homes and avoid costly institutionalization. The savings is vast over \$9,000 for a month of a semi-private room in a nursing facility, as compared to \$170 a month of home-delivered meals.

Thank you for the opportunity to support written testimony in strong support of SB 2320, SD2, HD1 Relating to Aging. My name is Patricia Blair and I work as a Group Dining Leader at the Lanakila Meals on Wheels program at Moiliili Senior Center.

The passage of this bill is vital because it ensures the continuation of services such as senior centers and home delivered meals for our most vulnerable seniors. The population of individuals over the age of 60 is constantly growing in Hawaii, and it is essential that funding continues to support programs for these older adults. The amount of funding has remained the same for the last ten years since 2002, but the number of seniors in need of services continues to grow. As a result of this growth without funding to support it, senior programs around the state face waiting lists and inability to meet the needs of the seniors they serve. Included in this is Lanakila Meals on Wheels Home Delivery program, which currently has a waiting list of over 300 seniors. These seniors are among the most vulnerable because they do not have the ability to shop, cook, or take care of themselves independently. Some of these seniors have no family or informal support to help them care for themselves. Others who have local family members or friends need home delivered meals to help ease the burden on their caregivers, who care for them tirelessly and are in need of respite.

Home delivered meals and other senior programs also allow seniors to live more independently and remain in their homes, versus moving to a care facility. The difference in cost is substantial; a senior can receive home delivered meals for \$170 per month while a nursing home can cost \$9,034 per month.

Without continued support from our state, Kupuna Care programs like Meals on Wheels will be forced to further reduce their services at this critical time when an expansion of services is needed to serve Hawaii's growing aging population.

In my experience working for Meals on Wheels for the last year, I am certain that some seniors could not survive without this program. Seniors rely on home delivery and group dining programs to maintain their independence and improve their nutrition and overall health.

I urge you to support seniors by voting yes on SB 2320, SD2, HD1.

My name is Anthony Lenzer. I'm testifying on behalf of the policy advisory board for elder affairs, a body which advises the executive office on aging, and also serves as an advocate for Hawaii's older people.

The board strongly supports SB 2320 which contains key elements in an aging program for the fate of Hawaii. I note the name of the Kupuna Care program has been changed to home and munity-based services program in the current version of the bill. This is indeed the main function of the Kupuna Care program, but the need for the name change is not exactly clear. The other components of the overall program: the healthy aging partnership; the senior centers; and the wanderers registry are all essential services. We strongly believe that all should be supported with appropriations for the coming year.

I also note that the home and community-based program is described in the bill as a function of the Aging & Disability Resource Centers, which serve people of all ages rather than older people, as in the case of the Kupuna Care program. I can personally attest to the critical need for wholesome, nutritious prepared foods that they deliver to the elderly. For many families these meals are depended on for the kupuna and without it they may not be eating as healthy if at all.
