1 Department's Position:

The department opposes this bill.

2 Fiscal Implications:

Passage of this bill would require additional resources by the department

- 3 to contract with a professional testing service; review site plans for temporary events, and inspection of
- 4 any trade shows, conventions, or exhibitions.
- 5 Purpose and Justification: We oppose this bill, as the department feels it is unnecessary. Hawaii
- 6 Revised Statutes (HRS) Part XXX. Tattoo Artists. §321-375 (b) states that, "The department may
- 7 contract with a professional testing agency to prepare, administer, and grade the exam for licensure as a
- 8 tattoo artist." Furthermore, the department has been advised by the Deputy Attorney General that tattoo
- 9 conventions, trade shows, or exhibitions are currently allowed in Hawaii under existing statutes and
- 10 administrative rules.
- 11 The department further believes that: 1) DOH does not have the expertise to create professional
- licensing exams as required by this measure and 2) Any changes to the existing tattoo regulations

- should also include serious discussions regarding the currently unregulated practice of body-piercing
- 2 and body implants. These types of body modifications are performed very frequently in licensed tattoo
- 3 shops, but afford a much higher public health risk than tattooing.

I am a licensed tattoo artist in Honolulu and also own my own tattoo shop. I have been tattooing in the state of Hawaii for the last 11 years. I have owned my own business since 2004. I was a part of the coalition of Hawaii Tattoo artists in 2009 to help update the Hawaii tattoo exam at that time. Also helping to promote the statutes that are currently in place now for tattoo conventions. I also am heavily involved in the promotion of traditional style of polynesian tattooing and have been trained by master tufuga tatatau form Samoa, Su'a-Sulu'ape. Alaiva'a-Petelo.

I am writing to submit my testimony about the current issue of a tattoo convention being held here on Oahu in the near future. Although I am not against a convention being held here, but I am extremely concerned of health and infectious issues that concern holding a convention here. There should definitely be a cap on how many tattoo artists that may be enrolled to tattoo at this convention. In my opinion there should only be at the most 50 tattoo artists tattooing at any given time during the duration of the convention. Also that they have completed and passed the Hawaii State exam for a tattoo License. This is so our Department of Health staff which is currently short staffed and under budget are able to monitor these activities.

Also, the fact that the tattoo industry here in Hawaii is already saturated with non-licensed and untrained home tattooers that could possibly attend and tattoo at this convention, only promotes these concerns. Hawaii is already a model for other states as far as our rules and regulations go for the tattoo industry. Lets please help to keep it this way!

I am also firmly against any type of out of state or online testing for temporary or permanent licensing for tattoo artists, and or piercing. This is a potential disaster waiting to happen.

In regards to the tattoo and or piercing conventions being held here in the State of Hawaii, I believe there should definitely be an oversight committee made up of long time resident tattoo artists at least 10 yrs plus tattooing experience in the State of Hawaii. This coupled with health and infectious disease control experts, to work hand in hand with the Department of Health to better over see the tattooing and any tattoo convention related activities in the State of Hawaii. I firmly believe this will help controlling any big business tattoo convention organizers from holding a tattoo convention and or piercing convention with a cap of no more than 50 tattoo artists and or piercers enrolled to perform tattooing and or piercing at the convention.

Again my position is to keep a cap of no more that 50 tattoo artists at any given time tattooing during the convention period. Also that there be no out of state and online testing for temporary and or permanent tattooing and or piercing in the State of Hawaii. Thank you very much for your time, and hope that this helps with helping regulate Hawaii's rule and relations regarding these concerns.

I am testifying against S.B.2398, for the following reasons: With the increased popularity of tattooing in recent years, numerous "courses" and "tests" are offered in various locations on the mainland that are of very little substance. Many tattoo "schools" are offering inexpensive condensed courses that are far from sufficient on the hygiene front. Also there are many online courses and tests being offered. As an experiment, I recently took a course and test that cost \$40.00 and took just under 30 minutes and provided me with a downloadable "certificate". Another licensed tattooist here found a course for only \$17.00 which he completed in under 10 minutes. The issue is that there is absolutely no means of determining if an out-of-state test is sufficient. It could be simply a two-hour Red Cross course or 20 minute online test, or it could be a legitimate OSHA approved course. As for the Hawai'i State Exam being administered elsewhere by professional testing services, I believe we are jeopardizing our examination process and inviting problems. With the test being administered here in Hawai'i by our Department of DOH or by professional testing services, we have the option of investigating to see if the course truly is sufficient, confidential and properly administered. This is not a possibility with out of state exams.

TESTIMONY IN SUPPORT OF SB2398 ONLY WITH TWO REVISIONS.

I am a licensed tattooist and have been since 2000

My first suggested revision is in reference to [§321-373.5] d (1) in our current statutes dealing with temporary permits for trade shows and conventions.

In 2009 the coalition behind SB1263 polled over a hundred licensed tattooists as to what a safe cap is on the number of participating artists at any given event. Some limit must be in place to make monitoring the booths for safety precautions a feasible task. Recently it was determined that the limit on participating artists that we thought was in place is NOT! I would like to see this corrected and the original intent recognized and honored in a revision clarifying the language of that section, although a somewhat higher number; perhaps more is more suitable to meet the economic needs of convention promoters, but a limit is necessary to ensure public safety. The smaller the number of participating artists, the smaller risk of cross-contamination and exposure to the public.

If conventions with as many as two hundred participating tattooists are hosted here, there IS a health risk. Multiply 200 artists by an average of 6 clients per artist and you have the possibility of as many as 1200 people bleeding in a communal space. Although the new tattoos are bandaged, most clients remove the bandage in order to show off their new tattoo. This is a tremendous health risk when you consider how easily Hepatitis B is transmitted. Also monitoring that many booths for safety measures is impossible, whereas a small number of booths can feasibly be monitored.

Please consider a revision of SB2398 to clarify this. The original intent is quite clear, and that not implementing that maximum number is a MAJOR health concern. Raising that cap slightly is acceptable, but we urge to you realize the risks in having a very large number of participating tattooists.

The second concern with SB2398 in in allowing for out-of-state testing. I feel section 1 of the bill is fine, but would like a revision to REMOVE the option of out-of-state exams. With the increased popularity of tattooing in recent years, numerous " courses" and " tests" are offered in various locations on the mainland that are of very little substance. Many tattoo " schools" are offering inexpensive condensed courses that are far from sufficient on the hygiene front.
