MEASURE: S.B. No. 2438, S.D. 1, H.D. 1

TITLE:

Relating to the Public Utilities Commission

Chair Herkes and Members of the Committee:

DESCRIPTION:

This bill requires the director of the Hawaii Natural Energy Institute ("HNEI") to provide technology readiness analyses of renewable energy projects to the Commission upon request. The measure uses the United States Department of Energy's working list of nine technology readiness levels ("TRL") for renewable energy projects based on varying degrees of operational and commercial viability. The Commission shall not approve a proposal or contract with a TRL of 6 or below, and must also set out in its final determinations findings of the positive external factors a proposal or contract may have. Finally, this measure exempts short-term proposals, contracts, and demonstration projects meant for experimental and data collection purposes.

POSITION:

The Commission supports this measure and would like to offer the following comments.

COMMENTS:

The Commission appreciates the Legislature's effort to offer clear guidance to assess the technological viability of renewable energy projects the Commission must review for approval. S.B. No. 2438, S.D. 1, H.D. 1 Page 2

The Commission also recommends that the following clarifying amendments be appropriately included:

- Page 4, line 5, to read "...proposal or contract <u>for a renewable energy project</u> with a technology readiness level of 6 or..."
- Page 4, line 8, to read "...proposal or contract <u>for a renewable energy project</u> with a technology readiness level above..."
- Page 4, line 9, to read "...provided that positive external factors, <u>if any</u>, including but..."

Dear Chair Herkes, Vice-Chair Yamane and members of the Committee,

Pacific Biodiesel Technologies supports the passage of SB 2438 SB1, HD1 as proposed. We believe SB 2438 is a vehicle for encouraging the expansion of proven technologies in an industry fraught with promises and proposals, many of which have not been proven and have extended well beyond the promised date of delivery.

Pacific Biodiesel owns and operates two biodiesel plants in Hawai'i, with a third one in construction, employs about 40 residents in this state and is currently developing a new, state-of-the-art, zero waste biodiesel facility on the Big Island. We have been producing biofuel at a rate commensurate with our state's capacity to sustain such production; however, our efforts have often been bypassed in favor of new proposed technologies which make large, but unsubstantiated promises. SB 2438 is empowering legislation based on official DOE standards for technology readiness that will allow our state utility and state officials to focus on supporting renewable energy technologies that are truly feasible, and thus move Hawai'i toward a realistic, sustainable clean energy future.
