Thank you for the opportunity to testify on behalf of Chevron U.S.A., Inc. in support of the intent of SB 2446. This bill proposes to establish a pilot program to conduct random, unannounced tests of the octane and ethanol levels of motor vehicle fuel sold in the state.

Chevron supports the intent of this measure as a means to ensure that ethanol blended motor vehicle fuel, commonly referred to E10, meets all applicable specifications. Several other states have implemented programs with the similar intent to help assure consumers that the motor vehicle fuel being offered for sale is in compliance with all the pertinent government requirements and standards.
