In consideration of SENATE BILL 2460 RELATING TO AGRICULTURE

Senate Bill 2460 proposes amending Section 150A-5, Hawaii Revised Statutes, to add the electronic importer manifest program as an authorized use of funds in the Pest Inspection, Quarantine, and Eradication Fund, and proposes an appropriation from that fund to be expended by the Department of Agriculture (DOA) to implement the electronic importer manifest program. The Department of Land and Natural Resources (DLNR) supports this measure, and defers to DOA on the specific language regarding the use of the Pest Inspection, Quarantine, and Eradication Fund and the amount of the funds required to successfully implement the Program.

DLNR recognizes the challenge of inspecting the large volume of cargo entering the State and acknowledges the severe impacts that invasive species transported in cargo containers could have on the State's natural resources and public health and safety. DLNR welcomes the implementation of technology that increases the efficacy of inspections.
