## SUBJECT: S.B. 2568, H.D. 1 – RELATING TO THE HOMELESS

Hearing: Wednesday, April 4, 2012; 2:30 p.m. Conference Room 308, State Capitol

**PURPOSE:** The purpose of S.B. 2568, H.D. 1 is to establish a Return-to-Home Program to assist eligible homeless individuals to return to their home state if there is a support network available and able to receive them. This measure would also appropriate general funds and is effective July 1, 2030.

**DEPARTMENT'S POSITION:** The Department of Human Services appreciates the intent of this bill but has substantial reservations because of the cost implications generated by this proposal and the impact it may have on the priorities in the Executive Budget. The DHS also has substantial concerns on the overly prescriptive language of the services to be provided and the requirement for the cooperation of many private business organizations.

The DHS Homeless programs does not have the staffing or fiscal resources to administer this program. To administer this program, the DHS Homeless programs will require additional funding of at least \$150,000 funding for staff and for the services prescribed in this bill.

I am writing in strong support of SB 2568 HD1. This bill with it's recent changes I believe will be a tremendous help to our current problem of homelessness in the State of Hawaii. I have read the previous testimony for this bill and I agree that this bill has a small upfront cost that will save millions in the end. The cost of a plane ticket amounting between \$600 and \$800 is a very small number when compared to a potential \$30,000 to \$35,000 in assistance that one homeless individual would receive in a year. The cost of shelter, food, hospital stays, support services are far greater in comparison to a one time plane ticket. These individuals are unique in that they may have family and other support on the mainland that we can not duplicate. The harsh realities that they have come to face in the light of living on the streets of Hawaii are multiplied when paired with their lack of support and family. Though this is not the only measure needed to fix the homeless problem, it is a good tool to add to our arsenal. Please pass this bill and help these people who are in dire need of the service of their government.
