#### In consideration of SENATE BILL 2597 RELATING TO THE HAWAII LEGACY TRUST FUND

Senate Bill 2597 establishes the Hawai'i Legacy Trust Fund as a separate fund of the Hawai'i Community Foundation to encourage individuals to make strong financial investments while supporting conservation, reforestation of Hawaii's native trees, environmental stewardship, sustainable food and energy production, affordable housing, public education, and programs that support and benefit keiki and kupuna. The Department of Land and Natural Resources (Department) supports the intent and offers some suggested amendments to avoid duplication with the existing state forest stewardship and forest reserves management programs, and defers to the Hawai'i Community Foundation for discussion of their capacity and expertise for this program.

The Department strongly supports initiatives to encourage private and public entities to invest in sustainable forest management. The Department notes a great deal of duplication in this proposal with the existing State Forest Stewardship Program (Chapter 195F, Hawaii Revised Statutes (HRS)) and suggests using this existing program to achieve the private forest land restoration goals of the Hawaiian legacy trust fund initiative. Many of the Hawaii legacy trust fund goals and functions are compatible with the existing Forest Stewardship Program. The Forest Stewardship Program has the existing infrastructure to receive state, federal and private funds and deliver a wide variety of restoration projects throughout the state on private lands, including production of native hardwood trees such as Koa. The Forest Stewardship Program also has an advisory committee composed of experts in forest and natural resource management in Hawai'i that reviews proposed projects and their management plans as well as recommends awards for funding under the Forest Stewardship Program. This existing committee could be expanded to include financial management expertise, and serve the role and function intended under this initiative.

The measure also proposes investment in native Hawaiian hardwood trees on public forest lands. Management of the State Forest Reserve System is authorized under Chapter 183, HRS, and the duties and activities authorized under this Chapter are compatible with the goals to invest and restore native Hawaiian hardwood trees on public forest lands. Any revenue so generated would be deposited into the existing Forest Stewardship Special Fund (Section 195F-4, HRS) and return to the Department for management of state forests.

The Department would be happy to work with the Senate Water, Land and Housing Committee to incorporate this initiative into the forest stewardship program and state forest reserves management programs.

Thank you for the opportunity to testify on SB 2597, which establishes the Hawaii Legacy Trust Fund. I am Betty Lou Larson, Legislative Liaison at Catholic Charities Hawaii. Catholic Charities Hawaii supports this bill as an innovative initiative to develop additional resources for affordable housing and social services as well as environmental stewardship and other critical State needs.

Homelessness is growing in our State. Local residents struggle to afford "market" rents and are often just one paycheck away from homelessness. The Legislature has responded with funding for the Rental Housing Trust Fund, but limited State resources cannot meet the growing needs for affordable housing. The same is true for State resources for programs that benefit our keiki and kupuna. The tough economic times over the past four years has resulted in many cut-backs in programs that serve the most vulnerable in our community.

Catholic Charities Hawai'i sees the results of these tough times as hundreds of people call for help each month. Affordable housing is one of the top needs. This bill would create ongoing, additional resources that are greatly needed. The State would incur no administrative costs since the Fund would be under the Hawaii Community Foundation, a respected partner with many years of administering grants.

Finding new sources of revenue is extremely difficult. This creative and renewable concept would not only produce revenues but would also have a positive impact on environmental stewardship. The Fund will partner with private and public entities to achieve reforestation of lands with Hawaiian hardwood trees. This appears to be a win-win situation for all involved.
