Chair Ige, Vice Chair Kidani, and Members of the Committee,

My name is Robert Witt, executive director of the Hawaii Association of Independent Schools (HAIS), which represents 99 private and independent schools in Hawaii and educates over 33,000 students statewide.

**HAIS is in strong support of this measure**, introduced by one of our member schools, Hawaii Preparatory Academy. SB 2651 SD1 extends the lapse date of the special purpose revenue bonds that were authorized to assist Hawaii Preparatory Academy in 2007.

The legislature deemed, and voters reinforced, that the issuance of special purpose revenue bonds to private schools is in the public interest. Private schools in Hawaii serve everyday families from all walks of life. Many of our students are the beneficiaries of robust financial aid programs that defray the cost of tuition and more importantly, broaden our reach. For the last decade, private schools have judiciously utilized special purpose revenue bonds as a financing tool to leverage capital funds for campus development and improvement projects. Special purpose revenue bonds do not divert funds from the public school system and this arrangement has generated many millions of dollars in construction on campuses large and small across the state.

Thank you for the opportunity to **strongly support SB 2651 SD1** and the good work and mission of Hawaii Preparatory Academy.

Dear Chair Ige, Vice Chair Kidani, and Members of the Committee:

I thank each member of the Committee, as well as your accommodating and helpful staff members, in receiving this testimony in support of SB 2651 SD1, which relates to the Issuance of Special Purpose Revenue Bonds for Hawaii Preparatory Academy.

My name is Lindsay Barnes, and it is my honor to serve as Headmaster of Hawaii Preparatory Academy, which we affectionately call “HPA.” We are a full-service school on the Big Island. Our school operates on two campuses: one serving students from Kindergarten through Grade 8 and another (located two miles away) comprised of Grades 9 through 12. We offer a boarding option that begins in Grade 6 and extends through Grade 12. At present, we board 174 students. We also offer a five-day boarding option for families on the Big Island. We are a coeducational school, serving boys and girls from all walks of life. Our total student population generally ranges from 585 to 610 young people in a given year. While a large majority (78%) of our students hail from the Hawaii, we may well be one of the most diverse independent schools in the world with students from 17 states and territories and 18 countries.

As a member of the South Kohala business community, HPA employs 131 men and women full-time. This makes us one of the largest employers on the Big Island, and we are happy to be contributing to our economy by providing good jobs to good people during these recessionary times. We also assist our families with truly significant amounts of financial aid. In fact, current financial aid exceeds \$3 million and benefits 35% of our parents by making it possible for their children – children we cherish – to attend our school.

The bill before you will permit HPA to continue its march forward in service to our children. Many of our school buildings date from the late - 1960's and early 1970's. While they have served HPA for many years, the time has come to consider infrastructure upgrades. Having access to funds produced by special purpose revenue bonds will help to make needed improvements possible without, in any way, diverting funds from our public school brethren. In addition, having access to revenue from the issuance of these bonds will enable us to be a catalyst for even more jobs on the Big Island.

From new and renovated dormitories, to the construction of more modern classrooms, to projects helping HPA stand tall as a leader in environmental awareness and sustainability practices education, to the phased consolidation of our two separate campuses, I can assure you without any question that funds derived from the issuance of the special purpose bonds for which we seek authorization will do a world of good for our school and for the young people it is our privilege – but also our immense responsibility – to educate and to nurture.
