Honorable Stan S. Tsutsui, the Hawaii State Senate Legislature, and the Committee on Education,

I am writing in regards to S.B. No. 2625, the bill to <u>"repeal the minimum</u>" hourly and per diem rates for substitute teachers" that adjusts according to regular teacher pay. I am a substitute teacher on the Big Island servicing primarily Kau High and Waiakea High. I live in Volcano. This bill was just brought to my attention by another substitute teacher who had recently called Senator Green's office on February 24, 2012 inquiring as to the status of the payment for lost wages for substitute teachers resulting from the lawsuit previously settled. There has been no public notice about this bill. I do not know why the Board of Education and the Department of Education want to repeal this law. Substitute teachers are VITAL to the running of the public schools. As it stands now, our pay is calculated to the entry level pay of the class to which we fall under, regardless of our years of experience and service to the public schools. We have NO benefits such as healthcare insurance and paid sick days. Even the most basic benefit that all employed citizens have if they are laid off from work, unemployment insurance, is denied to us when school is not in session.

If the State is going to be in the business of education, they need to compensate their substitute teachers appropriately. Every good business person knows to have a motivated, innovative, productive workforce, you must pay them appropriately and make sure they are healthy. Because we have to purchase our own healthcare insurance or pay in full for our healthcare visits, and if we are sick and cannot work we do not get paid (i.e. paid sick days), we need <u>more</u> compensation than we are currently getting.

It has also been brought to my attention that the Puna and Kau district schools will be extending their instructional day by one hour. As a result of this, teachers will receive a 17.4% increase in pay. The substitute teachers will also need a 17.4% increase in pay.

Once again, substitute teachers are a <u>VITAL</u> part of the educational system. Substitute teachers must take the place of the regular teachers when the regular teachers are out. Please keep in mind that with a longer work day and the larger teacher workload that will be placed onto the teachers, teachers will be taking more sick days to care for their own health. This will result in an increase use of substitute teachers <u>EDUCATING</u> our students. We must be professionally and appropriately compensated.

I am very concerned about the repeal of Section 302A-624 by way of Bill 2652 as I do not know what the basis will be for calculating substitute teacher pay which is already currently a very low wage for such a VITAL teaching position.

I also feel that as forwarded the bill has been in direct violation of open public meeting, or " sunshine" laws? Introduced, and possibly " fast tracked" by Senate President Shan S. Tsutui on 1/25/2012, until 2 or 3 days ago neither I nor any of the many substitute teachers I have worked with had ever heard of this proposed legislation. In this age of renewed efforts to bust unions, it is even more important for the legislature to protect wages. Substitute teachers do not even have a union and rely solely on the legislature to protect a living wage. In this age of great concern for better schools, we need to support best business practices for retaining good contractors and employees. Does this legislation help create better schools? No.

At least in my neighborhood, it's difficult for teachers to get good quality substitutes. Substitute teaching is a difficult job under the best of circumstances. Around here, where discipline is more a buzz word than a practice, it's even harder. In an era when teachers are absent with alarming regularity (to attend all the trainings demanded by NCLB, Race to the Top, and recertification), we need to retain good substitutes. There were many times when I've had to call several substitutes to find one available. There have been many times when newer substitutes became overwhelmed, and when I returned to the classroom, it would take days to reteach appropriate behavior.

We need substitutes who are experienced, and will return from year to year. Any good business manager knows that you must treat your employees with respect if you want to keep them. And retention is a best business practice for success -- unless your model is slave labor and sweat shops. SB 2652, SD 1 is destructive to the American Dream of fair treatment and a living wage.

In SB 2652, SD1 I see no evidence of good business practices. What I see is the legislature abdicating its responsibility to provide checks and balances on the Department of Education. Democracy requires checks and balances. Please keep democracy alive. Please work toward providing better resources (such as substitute teachers) for public schools. Please show respect for citizens working in our schools by ensuring fair monetary compensation for substitute teachers.

I oppose SB 2652, SD1 which proposes to repeal wage adjustments based upon teacher pay, and minimum hourly and per diem rates, for substitute teachers. This legislation will only move us backwards.

Substitute teachers rely on the legislature to protect their wages. In this age of great concern for better schools, we need to support the retention of quality substitutes particularly based on the level of education required to become a substitute.

It is very difficult for teachers to get effective substitutes. Substitute teaching is a difficult job with discipline being a major issue. Teachers are absent with regularity (in order to attend trainings demanded by NCLB, Race to the Top, and re-certification.) It is crucial to retain quality experienced substitutes, so an entire instruction day is not lost. Recently my Principal refused my request to join an educaion focus group because he said, " A substitute can not deliver your lesson as effectively as you can. " Perhaps not the one that I would be forced to retain due to the shortage of substitutes. On workshop days, we often can not find enough subs to cover classes.

Please show respect for teachers not part of a union and provide fair compensation for substitute teachers.

Please reject SB 2652, SD1.
