#### RE: S.B. NO. 2671 SD1 RELATING TO COLLECTIVE BARGAINING

#### I. OVERVIEW OF PROPOSED LEGISLATION

SB2671SD1 clarifies that the Hawaii Labor Relations Board (HLRB) has the authority to appoint attorneys and paralegals and authorizes attorneys employed by the Board to represent the Board, draft legal documents and provide other legal services for the Board.

#### II. COMMENTS ON THE SENATE BILL

DLIR supports this measure, as it will give the HLRB more flexibility and the ability to efficiently allocate its resources. HLRB, like many other agencies within DLIR, has encountered severe budget restraints over the last few budget cycles and has significant case backlogs. DLIR notes that the Board is also encountering challenges in promulgating administrative rules. The measure, if enacted, will strengthen the ability of the Board to accomplish its mission of deciding appeals from the Occupational Safety and Health Division and promoting the harmonious and cooperative relations between government and its employees to the benefit of the state.

The department notes that the measure does not have a fiscal impact.

#### SB 2671, SD1, Relating to Collective Bargaining.

Dear Chairman Rhoads and Committee Members:

On behalf of the University of Hawaii Professional Assembly (UHPA), our union supports SB 2671, SD1 to ensure that the Hawaii Labor Relations Board has the ability to employ the appropriate personnel to support the work of the agency in meeting their responsibility to ensure the rights to collective bargaining are protected and advanced. This agency must be able to effectively operate. As an administrative agency it provides the necessary vehicle for resolving labor disputes without having to increase the workload of the Circuit Courts.

UHPA notes that over the course of the last few years, there has been an increase in complex issues needing the assistance of the HLRB. These are time intensive and strain the resources of the agency meaning that justice is delayed. UHPA supports the increase of resources to the Hawaii Labor Relations Board.


# STATEMENT OF THE ILWU LOCAL 142 ON S.B. 2671, SD1 RELATING TO COLLECTIVE BARGAINING

The ILWU Local 142 supports S.B. 2671, SD1, which clarifies the Hawaii Labor Relations Board's authority to hire attorneys and paralegals and authorizes attorneys hired by the Board on a part-time or contract basis to represent the Board in litigation, draft legal documents for the Board, and provide other necessary legal services to the Board.

S.B. 2671, SD1 does not request any appropriation but simply asks for clarification of the Hawaii Labor Relations Board's authority to hire attorneys and paralegals and to use them for legal services required by the Board. Among those services is the drafting of administrative rules to implement laws that are passed by the Legislature. For example, in 2009, the Legislature passed a law requiring union recognition by card check of agricultural workers working for companies with \$5 million or more in revenue. To date, we understand that, although an initial draft of rules has been done, finalizing the rulemaking process has been stalled for lack of staffing needed to rework the draft, vet, and put the rules out for public hearing.

Using funds at its disposal and not requiring any additional funds, HLRB proposes to use the authority granted to it by S.B. 2671, SD1 to contract with attorneys and paralegals to assist the HLRB to accomplish its purposes as set by law. We believe this is a prudent and cost-effective use of government resources.

The ILWU urges passage of S.B. 2671, SD1. Thank you for the opportunity to offer support for this measure.
