## SENATE BILL NO. 2692 RELATING TO AGRICULTURE

Chairperson Nishihara, Vice Chair Kahele, and Members of the Committee:

Thank you for this opportunity to provide testimony on Senate Bill No. 2692. The purpose of this measure is to create an agricultural development and food security program within the Department of Agriculture. We strongly support this measure.

The goal of this measure is intended to integrate programs in order to develop Hawaii's agriculture and food security. Hawaii's agriculture has transformed from sugar and pineapple to diversified agriculture and now faces such complexities as diversified export markets, increased pest pressure, global competitiveness, sustainability, food safety, food security and self-sufficiency.

To move the agriculture industry forward and meet the needs of the industry, a coordinated effort with the agricultural, transportation, and business industries, research organizations, and other federal and state agencies will be required. Although the objectives appear simple and straightforward, the complexities can only be solved with cooperation and cohesive industry strategies and planning.



This program takes a holistic approach from farm-to-market, including subsystems which are not necessarily under the Department of Agriculture's purview, but critical to the development of agriculture. The overall concept overseen by the Department includes subsystems or subprograms such as farm inputs, labor, infrastructure, biosecurity, food safety, sustainability, market development, and research and development. The Department of Agriculture (HDOA) is the government agency best positioned to oversee the development of agriculture, with active participation from the agriculture industry, transportation, the University of Hawaii-College of Tropical Agriculture and Human Resources (CTAHR), public and private research entities, and other Federal and State agencies.


Chair Nishihara, Vice Chair Kahele and Members of the Agriculture Committee:

My name is Alicia Maluafiti, Executive Director of the Hawaii Crop Improvement Association, a nonprofit trade association representing Hawaii seed farmers.

We support SB 2692 as an attempt by the State Department of Agriculture to provide a comprehensive and strategic approach to addressing many of the challenges facing agricultural viability and sustainability in Hawaii. I am Brian Miyamoto, Chief Operating Officer and Government Affairs Liaison for the Hawaii Farm Bureau Federation (HFBF). Organized since 1948, the HFBF is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

HFBF is in strong support of SB 2692, creating an agricultural development and food security program within the Department of Agriculture.

During the 2010 Legislative Session, HFBF did something we have never done before. Historically, the organization has advocated for reduction in taxes. Yet, we realized that change was needed. Investments in agriculture were lagging and critical infrastructure repairs were not happening. Consistent funding for expansion in source development for water and infrastructure for expansion of agricultural production was needed. We therefore supported the expansion of the Environmental Revolving Fund to include Agricultural development and Food Security.

This measure establishes a program in the HDOA to identify the use of these funds. The public desires transparency in use of public funds. This measure provides that process by listing the various activities that will fall under the scope of this fund.

Aloha Committee Chair and Committee Members,

I am an organic farmer on the North Shore of Oahu and President of the Hawaii Center for Organic Farming. Please accept my testimony on the subject Bill.

SB2692 tasks the Department of Agriculture (DoA) to establish an Agriculture Development and Food Security Program. I appreciate and support the purpose of this Bill that will address many of our Ag issues and I have some comments and concerns.

Agriculture Development is an important step towards Sustainability and requires a new look at old problems and, above all, advocacy. The legacy of our DoA has been regulatory, not advocacy; so the opportunity for "new-think" will be limited unless new doors are open to new ideas.

Food Sustainability should be defined in the text of the Bill to eliminate confusion and solidify intent. For many of us farmers, food sustainability refers to ensuring the continuous and uninterrupted flow of imported foods. It is the exact opposite of food-self-sufficiency i.e. growing local food for local consumption, which appears to be the true intent of this Bill.
