### SENATE BILL NO. 2695 SD2 RELATING TO LIVESTOCK FEED

Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 2695 Senate Draft 2. The purpose of this bill is to create a livestock feed feasibility pilot project to investigate the viability of a livestock feed program on Department of Agriculture land. We are in support of this bill but we would ask for the committee to defer the bill to a later date to allow us to work on solidifying the requested funding amount and potentially identify project partners.

The rising cost of feed has a significant impact on production costs for our local protein producers. Since 2007, two dairies and four egg farms have gone out of business primarily due to the rising cost of feed for livestock animals. Currently, only one dairy and four egg farms remain and they are being threatened by closure which would heighten the State's dependence on imported foods and threaten the State's food security and self-sufficiency. Without these local agricultural businesses, all beef, milk, pork, chicken, and eggs would have to be imported into the State, requiring up to ten days of shipping before being sold to consumers. This pilot project would assess the viability of growing livestock feed in Hawaii and look to reducing the cost of feed and increase the profitability of our local protein producers. Working together with private and public research organizations and the University of Hawaii College of Tropical Agriculture and Human Resources staff will deliver the best results.

## RE: Testimony in <u>strong support</u> of SB 2695 SD2 RELATING TO LIVESTOCK FEED FEASIBILITY

Aloha Chairs Tsuji and McKelvey, Vice Chairs Hashem and Choy, and Committee Members:

The Hawaii Aquaculture and Aquaponics Association (HAAA), representing Hawaii's aquaculture and aquaponics industry statewide, <u>strongly supports SB 2695 SD2</u>. This bill Creates a livestock feed feasibility pilot project to investigate the viability of growing and processing livestock feed on land held by the department of agriculture.

Feed costs are typically one of the highest costs if not the highest cost in most aquaculture operations. At present all aquaculture feeds are imported, with transportations costs increasing total feed costs by as much as 50 percent, i.e., a 24 ft container of feed for freshwater fish currently costs approx. \$16,000, and the costs of overland transportation, ocean freight, wharfage and fuel service charges, and local delivery add another \$8,000, for a combined cost of approx. \$24,000. Marine fish feeds cost significantly more. The only way for Hawaii aquaculture to reach its full potential is to develop a local source of high-quality fish feed made from locally grown and locally sourced products and by-products.

The HAAA therefore respectfully requests the House Committee on Agriculture to pass SB2695 SD2 for the benefit of Hawaii's farmers and ranchers who use commercial feeds to produce their livestock products including fish and shellfish.
