**SB2773, SD1 - Relating to Libraries**

The Hawaii State Public Library System strongly supports SB2773, SD1.

The purpose of this bill is to update Chapter 312, Hawaii Revised Statutes (HRS) so it accurately reflects long-standing State Board of Education (BOE) and Hawaii State Public Library System (HSPLS) practice.

Chapter 312, HRS, assigns various duties and responsibilities to the BOE. In practice, the board does not, and has not, performed these duties and responsibilities; they have been delegated to the state librarian and the HSPLS. This bill will amend Chapter 312, HRS, so that it more accurately reflects the duties and responsibilities of the BOE, HSPLS, and the State Librarian.

This bill also allows the State Librarian to appoint the State Librarian's private secretary and repeals section 312-6, HRS, relating to Bond Memorial Library, which was replaced by North Kohala Public Library in November 2010.

**Senate Bill No. 2773, S.D. 1  
Relating to Libraries**

TO CHAIRPERSON TAKUMI AND MEMBERS OF THE COMMITTEE:

The purpose of S. B. No. 2773, S.D. 1, is to formalize the recognition of the State Librarian as the top-level official, appointed by the Board of Education, who is responsible for administering the statewide library system. The Bill also allows the State Librarian to appoint an exempt secretary.

The Department of Human Resources Development **supports** this measure. It is reasonable that the State Librarian should be authorized, as are department heads and other top level officials in the State, to appoint a secretary who is at will, where the need is established by the individual official and his/her management style and/or personal preferences, rather than the functions of the office.
