I am Brian Miyamoto, Chief Operating Officer and Government Affairs Liaison for the Hawaii Farm Bureau Federation (HFBF). Organized since 1948, the HFBF is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.


HFBF supports SB 2782, SD1, appropriating funds to protect priority watershed forests and replenish Hawaii's water supplies.

HFBF agrees that healthy watersheds are important for Hawaii's goal of increased selfsufficiency and sustainability. As a primary user of watersheds, agriculture has a vested interest in this matter.

We agree fencing to limit invasive species in the watershed and grow local agriculture is important. Digging by pigs destroy the forest floor, reducing infiltration of water. We agree that removal of invasive species is also important to encourage plants that improve the capture of water.

As we support these initiatives, we also believe that a parallel effort to protect our State from new pests is critical. Efforts such as the Dog detector program, funding of biosecurity facilities and inspectors along with measures that improve farm and ranch viability are equally important. Even as we are users of the water, our agricultural products reduce the need for imports, minimizing the risk of introduction of new invasive species that have the potential to harm the watershed. HFBF respectfully request your support of this measure along with other biosecurity and agricultural measures that will protect our islands from new invasive pests.

Aloha Chair Ige, and Members of the Committee,

The Coordinating Group on Alien Pest Species (CGAPS) **supports SB 2782 SD1**, *Relating to environmental protection*, which would provide critical funding for watershed protection. Watershed protection has been chronically underfunded for decades.

With more people and more industry, demand for fresh water is growing, while exponential increases in water-wasting invasive species like strawberry guava and changing climate patterns threaten the ability of forests to deliver water. Funding to increase protection for priority watersheds by fencing, ungulate and invasive plant removal is key. As high a priority is the long-term invasive species control work that is provided by biocontrol, and the preventative work done by the Invasive Species Committees and other groups. We must recognize the true cost of protecting watersheds and move the bar accordingly, and SB 2782 SD1 is a great step in the right direction. Mahalo for your consideration.

STATEMENT IN SUPPORT OF STATE OF HAWAI'I WATERSHED INITIATIVE

The Hawai'i Conservation Alliance (HCA) is a cooperative collaboration of conservation leaders representing 19 state and federal agencies, educational institutions, and nonprofit organizations. HCA's mission is to provide unified leadership and advocacy on conservation issues critical to Hawai'i. Collectively, we are responsible for managing the biodiversity of Hawai'i's lands and waters with over 1,600 square miles of land and 140,000 square miles of marine area designated for biodiversity protection. HCA strives to manage these resources in a manner that integrates Native Hawaiian approaches and knowledge systems with conventional conservation efforts to care for Hawai'i's 'āina and people.

The HCA strongly supports the watershed restoration proposal entitled "The Rain Follows the Forest" put forth by the Department of Land and Natural Resources (DLNR). This timely proposal will advance broad goals of community sustainability, ecosystem integrity, and biodiversity conservation by: 1) controlling key threats to priority watersheds, including invasive plant and animal species, fire, and plant diseases; 2) restoring the integrity and water retention capacity of these watersheds through protection and replanting of native species; and 3) educating Hawai'i's public as to the value of ecologically intact watersheds. By providing effective forest management, this initiative will help to replenish streams and aquifers diminished by decades of ecological neglect.

The HCA further supports the DLNR watershed proposal because it is congruent with the broader goals and management efforts of the HCA. These include:

- 1) Reversing ecosystem degradation;
- 2) Enhancing ecosystem functioning and resulting goods and services;
- 3) Preservation of native ecosystems;
- 4) Increasing the diversity of native species;
- 5) Maintaining native biodiversity for future generations; and
- 6) Ensuring a sustainable management of Hawai'i's natural resources for island communities.

The HCA, therefore, stands ready to support and contribute to Hawai'i's watershed restoration efforts through:

- 1) Collaboration at various levels;
- 2) Management of adjacent land parcels by members such as Kamehameha Schools, National Park Service and The Nature Conservancy, among others;
- 3) Enhancing biosecurity efforts to prevent emergence of new threats; and
- Facilitation of funding opportunities through programs with agencies such as National Oceanic and Atmospheric Administration, Natural Resource Conservation Service, and U.S. Forest Service, U.S. Fish & Wildlife Service among others.
- 5) Increasing community, cultural and technical capacity to state efforts in support of sustainable land to sea watershed management.

In summary, "The Rain Follows the Forest" plan promotes the irreplaceable natural environment and its life giving benefits are maintained by and across generations. The HCA commends the DLNR for putting forward this important proposal.

The League of Women Voters of Hawaii supports sufficient funding to protect watershed forest reserve.

The Department of Land and Natural Resources Natural Area Reserve program works to project Hawaii's watersheds to allow for percolation of water to aquifers. In Support of SB 2782 SD 1 Relating to Environmental Protection

Aloha. The Conservation Council for Hawai'i supports SB 2782 SD 1, which appropriates funds to the Hawai'i Department of Land and Natural Resources to protect priority watersheds. Our native forests provide essential watershed areas that replenish our freshwater supply. Funding is needed to protect these forests and actively manage them for watershed, habitat, cultural, and other values. Sadly, much of our native forest has been destroyed by invasive species.

The DLNR's watershed protection initiative – The Rain Follows the Forest – is an exciting new effort by the State to protect an additional 10% of our remaining priority mauka watersheds in the next 10 years. We have a long way to go in light of climate change, drought, and the continued onslaught of invasive species, and this program is an essential first step. Please fund it.

State funding for this effort will leverage others sources of funding and support effective public-private partnerships already in place to protect native forests and the native species they support. A dedicated source of funding will also be needed.

Water is life. This is one of the most important things you, our elected officials, can do to protect water for our people and generations to come. Please support SB 2782 SD 1and protect our watersheds and freshwater supply.

Testimony of the Maui Invasive Species Committee Senate Bill 2782 SD1 Before the Senate Committee on Ways and Means Conference Room 211

The Maui Invasive Species Committee (MISC) supports S.B. 2872 SD1, which will appropriate funds to the Department of Land and Natural Resources for the protection of Hawaii's forested watersheds. Our native forests provide life-giving waters for human consumption and are home to plant and animal species found nowhere else in the world. Healthy forests mean healthy reefs.

Hundreds of studies have documented the damage caused by invasive plants and animals. Research has shown that invasive plants consume significantly more water than our native koa-'ōhi'a complex. Monotypic forests result in increased sedimentation threatening our precious coral reef ecosystems. We have seen the impacts of miconia elsewhere in the world. Resources to protect our forested watersheds have never been adequate. In some instances we are barely keeping pace with the invaders; in others, they are clearly winning.

Please reverse the trend of declining health in our forests and provide increased funding to the Department of Land and Natural Resources for this important initiative.

I am Paul Oshiro, testifying on behalf of Alexander & Baldwin, Inc. (A&B) and its agricultural company Hawaiian Commercial & Sugar Company on SB 2782 SD1, "A BILL FOR AN ACT RELATING TO ENVIRONMENTAL PROTECTION." We support this bill.

Hawaii's eleven watershed partnerships provide the general framework for largescale watershed protection. These voluntary alliances of public and private landowners and managers cooperatively work together to protect over two million acres of forests that supply hundreds of millions of gallons of fresh water in Hawaii every year. Working across ownership boundaries, these partnerships leverage State efforts, pool funding, and provide a diverse range of local employment opportunities. Alexander & Baldwin is an active participant in three of Hawaii's watershed partnerships, the East Maui Watershed Partnership, West Maui Mountains Watershed Partnership, and the Kauai Watershed Alliance.

We support this bill as it provides additional funding to maintain and to protect our valuable watersheds. In addition to being a primary source of our fresh water, Hawaii's watersheds also provide several other benefits. Without a healthy watershed to anchor the soil and temper the erosion from heavy rain, large amounts of sediment would wash off the mountain slopes and into the ocean. Watersheds also absorb large amounts of carbon dioxide, reducing Hawaii's greenhouse gas emissions. These watershed resources are integral in providing much needed water to sustain our island community into the future.

TESTIMONY IN SUPPORT OF SB 2782 (SD1)

Aloha Chair Ige and Members of the Committee:

The Sierra Club, Hawaii Chapter, with 10,000 dues paying members and supporters statewide, *strongly supports* SB 2782 (SD1). This bill would provide funding for the protection of priority watershed forests and protection of Hawai'i's environmental heritage.

Hawaii's Natural Area Reserves contains some of the best native Hawaiian ecosystems on statemanaged land. While the NARS struggles for its budget appropriation annually, resource experts estimate that at least \$11 million is needed annually to maintain the integrity of the watersheds for our children and future generations.

From the coral reefs at 'Ahihi-Kina'u to Lake Waiau on the summit of Mauna Kea, the NARS protects unique Hawaiian plants, animals, and ecosystems on 109,000 acres of public-trust lands. The NARS includes habitat for threatened and endangered species, and portions of essential watersheds that support our economy and way of life. But the NARS is seriously underfunded and understaffed. The result is increasing encroachment by invasive species, decrease in healthy habitat for native plants and animals, and the loss of the native essence of Hawai'i.

While SB 2782 is a needed bill and deserves to be passed, a source of permanent funding should be considered. A bill like SB 2511 could provide this support in future years after the initial funding from this year is expended. To that end, we support both bills moving forward.
