The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB2790, which extends the sunset date of 2010's Act 187 from 2012 to 2015.

This bill allows the Department of Hawaiian Homelands (DHHL) to begin contruction on its projects without having full capital costs on hand. This puts DHHL on similar financial footing to other developers who are managing multiple projects. This would enable DHHL to provide enhanced service to its beneficiaries, who are also OHA's beneficiaries.

Therefore, OHA urges the committee to PASS SB2790. Mahalo for the opportunity to testify on this important measure.
