PURPOSE: The purpose of S.B. 2801 is to allow the Department of Human Services (DHS) to conduct adult abuse perpetrator checks on providers, license exempt pursuant to section 346-152, Hawaii Revised Statutes, who care for children receiving child care subsidies from the department, applicants who want to operate a child care facility, prospective employees of the applicant, licensed child care providers, and new employees of the registered or licensed provider.

DEPARTMENT'S POSITION: The Department of Human Services strongly supports this Administration bill. DHS is responsible for ensuring the safety and health of children both in regulated settings such as licensed child care centers and for child care providers who care for children that receive child care subsidies from the Department.

This bill will allow the Department to conduct a more thorough check on the character of the individuals who are working directly with children in licensed and legally exempt settings by identifying individuals who have a history of maltreatment of vulnerable individuals.
