## SB2818, Relating to Disposition of Dead Human Bodies

- 4 The Department of Health strongly supports Senate Bill 2818, Relating to Disposition of Dead Human
- 5 Bodies. This proposal is part of Governor Abercrombie's Administrative Bills package and supports the

8 SB2818 has two main goals:

- 9 1. Remove from statute the authority to donate or receive unclaimed dead human bodies for
- 10 medical education and research purposes, and
- Clarify roles and responsibilities in the handling of human bodies eligible for burial or cremation
   at public expense.

## Promoting Lifelong Health and Wellness

Unclaimed corpses are exceptionally rare, perhaps one or two every few years. Current Hawaii Revised
Statutes permit the donation of unclaimed corpses to institutions for medical education and research
purposes. Despite the practical value to education and research, this practice does not enhance or protect
the dignity of either the institution or the decedent, who had no choice in the matter, nor does it reflect
contemporary community standards of practice. The University of Hawaii has confirmed their policy
that only willfully expressed and documented anatomical gifts are accepted so access to medical
cadavers will not be affected.

In the event a corpse is unclaimed by relatives, friends, or any other legally responsible party it becomes eligible for burial or cremation at public expense. SB2818 consolidates the process in the Department of Human Services, with whom DOH collaborated to develop this bill, where previously it spanned both departments. Improvements in efficiency, record keeping, and customer services are expected.

14 The Department of Health respectfully urges this committee to pass Senate Bill 2818.
