1 Department's Position: The Department of Health strongly supports S.B. 2821.

2 Fiscal Implications: None.

3 Purpose and Justification: S.B. 2821 will amend Chapter 321, Hawaii Revised Statutes, and provide

4 the Department of Health, Developmental Disabilities Division statutory authority to conduct

5 multidisciplinary and multiagency review of the deaths of persons with developmental or intellectual

6 disabilities, and allow the Director of Health to obtain clinical and other information surrounding the

7 deaths of individuals served by the Developmental Disabilities Division. The ability of the Department

8 of Health, Developmental Disabilities Division to conduct and obtain information necessary to conduct a

9 comprehensive death review will help assure the Centers for Medicare and Medicaid Services and the

10 public that any wrongful deaths of individuals are investigated and remediation implemented to address

11 service issues that may have contributed to any of these deaths. The Government Accountability Office

- 12 has recommended to the Centers for Medicare and Medicaid Services that they encourage states to
- 13 conduct mortality reviews of persons with developmental or intellectual disabilities to help states
- 14 identify and address quality of care concerns among these individuals who are receiving Home and

SUBJECT: SB 2821 - RELATING TO MORTALITY REVIEW OF DEATHS OF PERSONS WITH DEVELOPMENTAL OR INTELLECTUAL DISABILITIES

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS SB 2821.** The purpose of the bill is to create a new part in Chapter 321, Hawaii Revised Statutes (HRS), giving the Department of Health (DOH) the authority to obtain all records for death review for persons with developmental or intellectual disabilities (DD/ID).

The Council is aware that current mortality reviews conducted by DOH DD Division are hampered by their inability to obtain information from other sources, such as service providers, hospital staff, and other entities that may be relevant to the death of an individual with DD/ID. This situation prevents DD Division to conduct a complete review to determine issues into the cause of death.

Passage of the bill would provide legal authority to gain access to necessary information; facilitate comprehensive mortality reviews; help to identify health, safety, and quality of life issues that may have contributed to any deaths, and prevent future situations that may have caused a death. Mortality review of deaths for individuals with DD/ID would be consistent with Child Death Reviews pursuant to Chapter 321, Part XXVII, HRS.
