TESTIMONY ON SENATE BILL NO. 2968, S.D. 1 – RELATING TO MOTOR VEHICLE INSURANCE.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Gordon Ito, State Insurance Commissioner ("Commissioner"), testifying on behalf of the Department of Commerce and Consumer Affairs ("Department"). The Department supports the intent of the bill and offers the following comments.

The purpose of this bill is to allow motor vehicle insurers to offer premium discounts for drivers who complete a driver safety course or driver improvement course ("Driver Safety Course").

Existing Hawaii law does not prohibit motor vehicle insurers from offering premium discounts. Hawaii motor vehicle insurers already provide premium discounts to policyholders and are already offering discounts to policyholders who complete Driver Safety Courses.

While it supports incentives for drivers to take Driver Safety Courses, the Department is opposed to amending Hawaii Revised Statutes ("HRS") § 431:10C-207

to accomplish this because doing so creates confusion by creating an exception to prohibited discriminatory practices. It would be better to create the Driver Safety Course incentive in a new section in article 10C, chapter 431, HRS. In addition, the discount should be offered to "insureds" and not "drivers" who complete a Driver Safety Course to clarify that the owner of the policy, and not just any driver, has completed the Driver Safety Course.
