TESTIMONY ON SENATE BILL NO. 2968 - RELATING TO MOTOR VEHICLE INSURANCE.

TO THE HONORABLE J. KALANI ENGLISH, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Gordon Ito, State Insurance Commissioner ("Commissioner"), testifying on behalf of the Department of Commerce and Consumer Affairs ("Department"). The Department supports the intent of the bill, but takes no position.

The purpose of this bill is to allow motor vehicle insurance companies to offer discounts on premiums if the insured completes a state-certified driver improvement course. The bill also requires the Hawaii Insurance Commissioner to establish and maintain a list of state-approved driver safety courses.

Hawaii Revised Statutes § 431:10C-207 does not prohibit the offering of discounts to a policyholder who completes a driver improvement course. Hawaii motor vehicle insurance companies are already able to provide premium discounts to policyholders under existing law and are already offering discounts to policyholders who complete defensive driving classes.

The Department of Transportation ("DOT") already maintains a list of certified driver education instructors. Accordingly, if a program to monitor or regulate driver safety courses is established, we believe it would be more appropriate for DOT to take the lead for such a program.
