RELATING TO FIREARMS

Description:

Requires the loss or theft of a firearm to be reported to the police within a certain time after discovery. Exempts persons who comply with the reporting requirement from the penalties for improper storage and other firearms violations.

Hon. Chair, Co-Chair, Members,

HRA opposes this bill. It is yet another example of laws that burden the law-abiding gun owner and have no significant impact on scofflaws and outlaws. The current statute, with "absolute liability" a consequence for failure to report a missing or stolen firearm before it is used improperly or illegally is sufficient motivation for early reporting.

The 72 hour requirement is too short. Reporting within 3 days could be difficult. This year alone we have 10 three-day weekends. A theft discovered on Friday could not reasonably be reported or logged into PD records until Tuesday, and the owner would be in violation. Responsible gun owners would hesitate to clog the 24 hour 911 system with these reports.

The penalty is harsh. A full misdemeanor is one year jail and a \$2000 fine and the defendant is entitled to a jury trail. It is doubtful the prosecutor would be able to get a conviction. The added cost of a jury trial on the judiciary, state and public defender should be considered.

If passed, the time to report should be lengthened to 5 days to accommodate three day weekends and the penalty should be a petty misdemeanor or a violation subject to a fine only.

Honorable Senators,

I am opposed to this bill that requires persons to report stolen firearms within 72 hours under penalty of law.

It make no sense to criminalize a person that has already been a victim of a crime.

Instead the legislature should concentrate on putting the real criminals in jail, and stop the criminalization of law abiding, responsible citizens, who seek to protect themselves and their families.

There could be many reason one might not be able to report a stolen firearm. Just a few examples.

Suppose a person is on a vacation or the person is deployed military; how then would they be able to know if their firearm is stolen and report it within 72 hours? What if a person has a sizable collection of firearms and one or two of them is stolen. It may not be noticed within 72 hours.

Now if the criminal is caught with the firearm, the person who owned it will be penalized, because it was stolen?

I realize that the law, as written, states that the theft must be reported 72 hours from the time of discovery, and that there are many exemptions, however, this law is very open ended, therefore, innocent lawful citizens could be prosecuted on the whims and biases of law enforcement and the judiciary. This is unacceptable, there are much too many of these types of open-ended, confusing, and vague laws already on the books.

Any responsible person will report a firearm stolen as soon as it is possible. As such, there is no need for this law to be written in to the books. The law as written seem to be unenforceable in any case, unless fore mentioned biases are taken into account. There may be cases in which a person may be an accessory to a crime, and they may not report the firearm stolen in a reasonable manner. These cases should be considered on a case by case basis.

We do not need a law that states a person WILL report the firearm stolen within 72 hours.
