### In consideration of SENATE BILL 3023 RELATING TO HAWAIIAN FISHPONDS

Senate Bill 3023 proposes to amend Chapters 183B, Hawaii Revised Statutes (HRS), to require the Board of Land and Natural Resources (Board) to establish rules to streamline and facilitate the restoration of existing Hawaiian fishponds. The bill also proposes to allow commercial use of the fishponds if the applicant is a lineal or cultural descendant of Native Hawaiians or a Native Hawaiian organization. Finally, the bill proposes to amend the definition of "mariculture" in Chapters 171 and 190D, HRS, to exclude Hawaiian fishponds from certain lease provisions. The Department of Land and Natural Resources (Department) opposes this bill.

The Department recently adopted administrative rules to expedite and facilitate the restoration of existing Hawaiian fishponds. Recently amended Chapter 13-5, Hawaii Administrative Rules, rules and regulations of the Conservation District, allows for the repair, strengthening, reinforcement, and maintenance of a fishpond in accordance with Sections 183-44, HRS, - Fishponds; rules and 183B-2, HRS, - Exemption from environmental impact statement law, and requires no Conservation District Use Permit (CDUP). Repairs may be performed without a CDUP. The rules allow the Department to require a CDUP for new fishponds or for complete fishpond reconstruction.

In addition, the Department does not support the measure to the extent that it exempts an applicant from statutory permitting and disposition requirements, such as obtaining a lease for the use of public lands, based upon the applicant's lineage.

## HOUSE BILL 2529 RELATING TO HAWAIIAN FISHPONDS

Aloha Chairman Galuteria of the Senate Committee on Hawaiian Affairs and Chairman Nishihara of the Senate Committee on Agriculture. My name is Shane Nelsen, from Kealakekua Bay, Moku O Keawe, and President of the Kuakini Hawaiian Civic Club of Kona. I am testifying today in SUPPORT FOR SB 3023 RELATING TO HAWAIIAN FISHPONDS.

Currently, the permitting process is a long arduous process that can take up to several years, and the cost associated to this process is almost inhibiting the Native Hawaiian small business and/or Cultural Organizations.

Hawaiian fishponds were once a huge part of sustainability, which fed many Hawaiians for many generations, and harvesting as much as 400lbs. of sizeable eating fish per day. In Kepa Maly's study on Kaloko fishponds (Oct. 2000) on the Island of Hawaii, Fishponds were farmed commercially well into the 1940's by various families. Today, many traditional fishponds are at a standstill and sit waiting to be repaired. On the same token, the State is looking into offshore fish farms, an aquaculture tradition that is foreign to the local population.

This bill will allow Native Hawaiian organizations, 'ohana, and practitioners to lease Hawaiian fishponds for commercial purposes. The current statute forbids DLNR to lease the ponds for commercial purposes, which means most Hawaiian fishponds are prohibited from sustaining itself, and participate in stimulating economic stability in various communities.

We have the resources to utilize the traditional Hawaiian Way of Life in this modern world to create jobs accustomed to the local population, stimulate economy, and provide food that is locally grown. Let us look into bringing these traditions to the forefront for the purpose of creating jobs, education, and food for the community.

We urge the committees on Hawaiian Affairs and Agriculture to take serious action on improving economic conditions utilizing cultural traditions. Let us NOT inhibit ourselves by creating such an arduous permitting process for FOOD. Many fishponds are inactive because the process is discouraging. Tourism is essential, but Agriculture is LIFE!

Aloha mai kākou,

Under Section 2-14-125 of the Neighborhood Board Plan, I have been appointed as a Delegate with responsibilities to represent the **Kuli'ou'ou / Kalani Iki Neighborhood Board #2** on matters approved by the Board. As Committee Chair of the **Kuli'ou'ou / Kalani Iki Neighborhood Board #2** Legislative Sub-Committee, I am pleased to inform you **Neighborhood Board #2** supports SB3023 which allows for the streamlining and facilitation of the permitting process for the restoration of Hawaiian fishponds and amends the definition of "mariculture" for chapters 171 and 190D, Hawaii Revised Statutes, to exclude Hawaiian fishponds from certain lease provisions. **Neighborhood Board #2** represents over 6,000 households, with a population of almost 20,000 people (State of Hawaii Data Book 2002) in East Honolulu.

Before Westerners arrived in Hawai'i, native Hawaiians lived a life of self-subsistence and harmony with the land and sea. Native Hawaiians understood that by caring for the land and sea, they too, would be cared for by the land and sea. A great example of this is a native Hawaiian fishpond (loko i'a or loko kuapā) which were first built around the fifteenth century. Hawaiians built 488 fishponds statewide, however only about 60 fishponds remain recognizable today. O'ahu alone had 97 fishponds, but only six accessible ponds remain today. Thirteen fishponds have been restored statewide, with six ponds currently in use: three on Moloka'i, one on the island of Hawai'i, and two on O'ahu.

Currently, the Maunalua Fishpond Heritage Center is working to stop the sale of two remaining fishponds at auction by the Department of Transportation and obtain the leases. They are Kanewai Fishpond, a royal pond assessed to have the properties that make it eligible for listing on the National Historic Register, and Kalauha'iha'i (Lucas Spring and Fishpond) reported to be the location of a summer home of Kamehameha I

and where Queen Ka'ahumanu was said to have renounced the ancient kapu system at the Kalauha'iha'i Assembly. Kalauha'iha'i refers to the scattering of the leaves and breaking of the ancient kapu and was listed as one of Hawai'i's Most Endangered Historic Sites in 2008 by the Historic Hawai'i Foundation.

Recognizing the important cultural significance these fishponds represent, at its November 6, 2008 meeting, **Neighborhood Board #2** voted to support preventing any governmental entity from selling culturally significant Native Hawaiian treasurers such as fishponds. Allowing for the streamlining and facilitation of the permitting process for the restoration of Hawaiian fishponds (loko i'a) and amendING the definition of "mariculture" for chapters 171 and 190D, Hawaii Revised Statutes, to exclude Hawaiian fishponds from certain lease provisions will help to restore a uniquely Hawaiian cultural resource and safeguard our last remaining fishponds for future generations.

Your support of SB3023 is respectfully requested.



#### SB3023 RELATING TO HAWAIIAN FISHPONDS

Aloha Chairman Galuteria, Chairman Nishihara and members of the Senate Committees on Hawaiian Affairs and Agriculture.

My name is Graydon "Buddy" Keala and I have been working with and restoring loko i'a for about thirty years. After receiving my aquaculture degree from the University of Hawaii-Manoa, working in the commercial production of Marine shrimp and a stint at teaching at-risk high school kids on Molokai, all things concerning loko i'a have been my life work.

I have worked on loko i'a on most major islands; Hawaii, Maui, Molokai, Oahu; and will soon be completing the restoration of a loko i'a in Hanalei on Kauai.

On two USDA grants, in 1990's and again in 2000's, the organization I was working with put the reduction and streamlining of the permit process a major objective. We held two symposiums under the Hawaiian Fishpond Revitalization program and worked directly with all agencies involved.

In 2000, USDA provided funds to Molokai's fishponds revitalization and we again focused on streamlining the permit process. During this effort, we were recognized and awarded by the Environmental Protection Agency's Region 9 for our work on Molokai with Hawaiian Fishponds. This work created a draft streamline permitting process that was almost adopted by all agencies involved, but funding changes limited the outcome of the streamline permit.

In 2006, I started the permitting process for Kauikeolani Fishpond restoration in Hanalei, Kauai. For the most part all agencies exhibited attention to wanting to assist in permits processing for loko i'a restoration. Even so, permits still took over a year and a half, with the Department of Health-Clean Water Branch being the most difficult application to

understand and apply for. Our application took 7 months, but I've commonly heard of permitting taking up to two years.

In each case, the permitting process to restore loke i'a has added unnecessarily to the overall expense as well as many months of delay. Some owners have thrown up their hands in defeat and the loke i'a is not restored due to the permitting frustrations and delays of red tape add to the restoration costs AND this doesn't include the actual work cost and effort.

While this bill will be somewhat helpful in speeding up the permitting process, in my estimation, it is the Clean Water Branch of the State Department of Health that creates the most frustrating and expensive delays in the name of environmental protection.

It has been my experience to have Federal and County clearances to proceed with work, only to be held up for two years waiting for the Clean Water Branch of the Department of Health approvals. I fully appreciate the need to protect the environment and know full well the need for clean water in the loko i'a. However, loko i'a in this restrictive case, is the victim of negative impacts, where actually these systems are really some of the greatest environmental assets provided to us by our kupuna and should no longer be held hostage to some red tape process.

Please amend this bill to add the Clean Water Branch of the DOH. The permit streamlining to restore loko i'a needs to start there. Mahalo.

My ohana have several kuleana aina in the above areas I mentioned, re: The mahele awards. Indeed I am kanaka. Kuleana owners maintained the rights to fish in their ahupua'a. My grandfather born 1893 reminded me of those rights and often reminded foreign western real estate buyers.

Alekoko Fishpond - I was 8 yrs. old that I accompanied my uncles to help maintain the rockwalls of the fishpond. My job was to pull the invasive mangrove seeds out of the rockwalls. Today they are like giant trees in the rockwall. The person that purchased Alekoko did nothing to improve Alekoko and the natural resources. He was Japanese and he has expired. His heirs are doing nothing to restore it, infact they are trying to sell it. Upperland developments (Grove Farm) are also negative contributors of drainage ways entering into Huleia Stream and Alekoko. The DOT Harbors Division built the Nawiliwili Small Boat Harbor and blocked much of the ocean tide to reach Alekoko. Big ships, tugs barges - turbulence added sediments to the floors of the harbor. The state has done nothing to vaccum the harbor floor. It was discussed in the 2010 master plan. We got NADAS! My tutu man is probably roaring in his grave.

Aloha Chair Chang, Chair Hanohano, and Members of the Committees:

I support SB 3023 to streamline Hawaiian fishpond (loko i'a) permitting while encouraging Native Hawaiian sustainable economic development of loko i'a.

Hawaii Revised Statutes, the Hawaii Supreme Court, and Article XII of the Hawaii State Constitution have declared that government agencies have an affirmative duty to protect Native Hawaiian rights customarily and traditionally exercised for subsistence, cultural, and religious purposes. The easing of restrictions on Hawaiian fishpond usage and restoration will help to fulfill this duty.

Hawaiian fishponds were once part of a sustainable food system that fed over a million Hawaiians. Now, they languish unrepaired while the State focuses on offshore factory farms.

Currently, to lease and restore the loko i'a requires a convoluted application process and includes up to 17 permits. The process can take several years and is highly cost-prohibitive for Native Hawaiian small businesses and/or cultural organizations. This bill would also allow Native Hawaiians and Native Hawaiian organizations to lease Hawaiian fishponds for commercial purposes (ie: to sell the fish they raise or to create work exchange for fish programs). The current statute forbids DLNR to lease the ponds for commercial purposes. That means that most Hawaiian fishponds lie in disrepair because the extensive work to permit and rebuild cannot be offset by fish sales or work exchange for fish programs.

If a family business or community organization can receive benefits from their work associated with Hawaiian fishponds, they will more fully commit to the restoration and maintenance of one of Hawaii's cultural treasures. And the public benefits from increased access to sustainably grown local fish.
