### I AM IN STRONG SUPPORT OF SB 3039

Aloha Senator Josh Green M. D., Chair; Senator Clarence Nishihara, Vice Chair; and Committee Members,

Thank you for the opportunity to allow me to testify. I am the wife of a transplant recipient as well as a mother and caregiver to a HIV infected son. I have seen the results of what transplant organs did for many families and their loved ones. Lives being changed and renewed, as well as the sorrow of families and their courage to allow a gift of life to sick and dying strangers, so that their loved ones would not die in vain.

The problem that the State of Hawaii is having, relates to the fear, and stigma of the HIV patient somehow affecting everyone around them. Some believe they should and will die an early death from their illness.

The true fact is my son was diagnosed with HIV 28 years ago, and is still trying to fight for his life. He is happy and contented with most of his life. Recently he found out that one of his medications can cause kidney failure, if taken for 3 years. My son was on this medication for 6 years before any warning was issued.

He stopped using the medicine when the warning was posted by the FDA. Two months later he found himself on dialysis.

My son's team of Physicians all wrote referrals to recommend him for kidney transplant and he was denied from the only facility and transplant team in the Pacific. There was no explanation of any kind, only mentioning that his HIV medical condition precludes him from any transplant. The facility closed within a week.

Due to these circumstances, when there were no longer any transplants being done in the entire State of Hawaii, he was forced to apply and was accepted for transplant in California. Amazingly they didn't have a problem with his HIV status.

When new facilities open up for transplants in Hawaii they should accept all patients that need their help to saves their lives without any stigmas of any kind. If this Bill is passed and signed into law, then this legislature protects all the people.
