In consideration of SENATE BILL 3053, SENATE DRAFT 1 **RELATING TO NATIVE HAWAIIANS**

Senate Bill 3053, Senate Draft 1 proposes to: 1) Create an aha moku advisory committee within the Office of Hawaiian Affairs (OHA) to advise the chairperson of the Board of Trustees of OHA on matters related to land and natural resources management through the aha moku system; and 2) Facilitate island burial council meetings and business by establishing a reduced quorum requirement for island burial council meetings. The Department of Land and Natural Resources (Department) supports this measure and offers the following comments with regard to PART II dealing with Island Burial Councils.

The purpose of Section 6E-43, Hawaii Revised Statutes (HRS), is to ensure that Native Hawaiians and landowners have a forum to discuss and voice their opinions on the treatment of burials on their respective island. However, lack of quorum, particularly difficulty in getting large landowner representation on small islands, has hindered the ability of island burial councils to meet. PART II of this measure proposes that "the members present at the scheduled start time of any meeting shall constitute a quorum to do business."

The Department supports this proposed language which clarifies the definition of what constitutes a quorum, and allows a burial council meeting and business to be conducted without regard to ratio requirements proscribed in Section 6E-43.5(b), HRS, for development and large property owner burial council representatives attending a meeting, as long as any member of the respective burial council is present at that meeting.

Aloha,

The Maunalua Hawaiian Civic Club supports of SB3053, we have been involved with the initiative since 2006. The Association of Hawaiian Civic Clubs has supported formal recognition of the Aha Moku system since 2006 when the first Aha Ki`ole/Aha Moku resolution, tabled by our club, was heard and adopted at the AOHCC annual convention and subsequent conventions.

SB3053 should be amended to place the Aha Moku Advisory Committee in the Department of Land and Natural Resources and Section 2, appending the Burial Council bill to this bill, should be deleted as inappropriate to this initiative. The Burial Council resolves issues arising from the disturbance and destruction of native Hawaiian burials. The Aha Moku Advisory Committee is about natural resource management. The Aha Moku Advisory Committee will support and help facilitate the participation of communities in the management of our natural resources, based on a system of traditional practices, to protect, conserve and sustain the resources of the State of Hawaii. It is for all Hawai'i's people not just the Hawaiian community.

An amendment made in the joint hearing by the Committee On Hawaiian Affairs and Water, Land and Housing to move this advisory committee into the office of Hawaiian Affairs does not make sense since OHA's mandate is to serve the Hawaiian people and the system is for all of the people of Hawai'i.

At the HWN and WLH joint committee hearing the Aha Moku Advisory Committee was portrayed as conflicting with a new act under DLNR's authority. We reviewed the new Acts and Act 55 appears to be that Act. However, this advisory

committee would in fact complement the operation of the Public Land Development Corporation by making that process more open and transparent.

The Aha Moku process is an opportunity to improve natural resource management within the current resource management regime. The process was inclusive rather than exclusive, giving all Hawai`i's residents an opportunity to participate in a traditional successful Hawaiian process.

The people of Hawai'i deserve the best of Hawai'i's traditions and after six years of community consultation--meetings, workshops and puwalu--this is the best that native Hawaiians can share.

Aloha, Chair Hee, Chair Ige, and Committee members:

My name is Rocky Kaluhiwa and I am speaking in favor of S.B. 3053, S.D.1. I am testifying on behalf of the Ko`olau Foundation in strong support of H.B. 2806, House Draft 1, which would establish an Aha Moku Advisory Committee to assist the state in a process to integrate Hawaiian cultural practices into rules and regulations governing land, water and cultural resources.

We were very disappointed when the law regarding the Aha Moku system was allowed to sunset. However, we are encouraged by this legislation, and hope you will consider it favorably.

This new advisory committee would be housed in the Department of Land and Natural Resources. We have two specific comments about the bill:

- 1) The burial councils already have kuleana for iwi kupuna and that responsibility should remain with them and not be part of this advisory committee's work.
- 2) For more than two decades now, the Kane'ohe Bay Master Plan has been sitting in the Department of Land and Natural Resources a plan that took more than 1,500 hours of work involving both practitioners and the general community and stakeholders. It was a plan to maintain and sustain the life of Kane'ohe bay. The act became law in the 1990s, a law that until today has not been complied with by the department.

Our Hawaiians planned for seven generations with our food and sustainability. In today's world, our Native Hawaiians' plans have to go through this bureaucracy to stay afloat.

That is why I feel we need this legislation, and we need this formal connection and relationship between the DLNR and our Native Hawaiian practitioners. Otherwise, the director of the department will feel like he can only listen to the Western way of making rules, and may not be able to give equal weight to the mana'o and recommendations of Native practitioners.

My plea to you is to pass this bill, with the amendment I suggested, for the betterment of the Hawaiian people and for our entire State of Hawaiii.

SUBJECT: Comments on SB 3053, SD1, Relating to Native Hawaiians

I am Dr. Sara Collins, Chair of the Legislative Committee of the Society for Hawaiian Archaeology (SHA). We have over 150 members that include professional archaeologists and advocates of historic preservation in general. On behalf of SHA, I am providing comments on SB 3053, SD 1. The subject bill originally pertained to establishment of the Aha Moku advisory committee but was amended with the addition of a Part II that included language pertaining to the island burial councils. Our comments address only the amendments in Part II. The stated purpose of these amendments is to address the increasing problems the island burial councils have in meeting quorum by establishing in statute a very minimal quorum requirement for island burial council meetings. The specific amendments pertaining to island burial councils affect Chapter 6E-43.5(d), Hawaii Revised Statutes (HRS) and read as follows:

(d) The councils shall hold meetings and acquire information as they deem necessary and shall communicate their findings and recommendations to the department. Notwithstanding section 92-3, whenever the location and description of burial sites are under consideration, the councils may hold closed meetings. The members present at the scheduled start time of any meeting shall constitute a quorum to do business. Concurrence of a majority of the members present at a meeting shall be necessary to make any action of a council valid."

While we understand the concern generated by quorum problems and the resulting inability of the island burial councils to meet on a regular basis, we do not believe that the proposed amendments will solve these problems. We provide the following comments and suggestions for your consideration.

- As written, it appears that a quorum could consist of one person if he or she is the only member in attendance at the start of a burial council meeting. It is also possible that only two or three individuals out of a maximum of 9 to 15 burial council members may be present, in which case these individuals will constitute a quorum, as defined by SB 3053, SD 1. The determinations and recommendations made by the burial councils are too important to too many people, often for very different reasons, to leave these decisions solely to one or two members who were, by chance, able to make that meeting. The councils were rightly designed to represent the islands' diverse geographic areas and the interests of those communities. This amendment potentially undermines the very real benefits of this diversity and the credibility of the councils' deliberations.
- On February 24, 2012, I attended a meeting of the Chairs and Vice-Chairs of the IBCs from Kaua'i/Ni'ihau, Maui/Lana'i, Moloka'i, O'ahu, and Hawai'i Islands sponsored by the

Office of Hawaiian Affairs; interested members of the Native Hawaiian community also participated. The purpose of the meeting was to discuss the problems with achieving and maintaining quorum at IBC meetings, and to come up with solutions. The following statement was issued as a result of the meeting, and SHA supports this statement in its entirety:

Be it resolved by the leadership of the Island Burial Councils from Kaua'i/Ni'ihau, O'ahu, Moloka'i, Maui/Lana'i, and Hawai'i Island, as well as community members present on February 24, 2012 that we ask the Legislature to reject SB 2854, HB 2592, and/or any other bills or portions thereof (e.g., SB 3053, SD1) that would amend the Burial Law (HRS 6E) during the 2012 Legislative Session, because there has been no consultation with the Burial Councils and the Hawaiian community on the actions that are needed to address current concerns and strengthen our burial law and Councils. With the support from the Office of Hawaiian Affairs and others, we are in the process to continue over the next year to consult within the Councils and the Hawaiian community to identify the critical issues (including but not limited to quorum, composition, enforcement) that should be addressed, and shall propose legislation for the 2013 session.

Given the above, we respectfully suggest that the amendments in Part II of SB 3053, SD1 pertaining to the island burial councils be stricken entirely from the subject bill. Comments:

I support the Aha Moku Bill, but the Burial Council Bill should not be attached to it. These are two completely distinct and separate issues, like apples and oranges, and should be voted on in separate bills. That way each bill/issue can stand and fall on their own merits. Putting them together in one bill only serves to muddy the waters.

It would be better for the Aha Moku Council to remain under DLNR rather than OHA. The bill is about a traditional resource system that would benefit all of Hawaii and its people. It is not a " Hawaiian issue" to benefit one group of people only. Putting the Aha Moku under OHA would give the appearance that this is a for Hawaiian program only. It is not. This program has broad base support and it is designed to benefit all the people of Hawaii.
