Chair Baker, Vice Chair Taniquchi, and Members of the Committee:

Retail Merchants of Hawaii (RMH) is a not-for-profit trade organization representing 200 members and over 2,000 storefronts, and is committed to support the retail industry and business in general in Hawaii.

RMH would like to offer comments on SB749, which prohibits the sale of toy guns to minors, and propose an amendment.

In light of the recent episode at one of our schools, we recognize that adolescents do not always make reasonable or rational choices, and it is a challenge for parents continually to monitor their children's activities.

Federal Law (*Title 15, CHAPTER XI, PART 1150, Marking of Toy, Look-alike and Imitation Firearms*) imposes strict regulations on manufacturers to avoid one's mistaking toys for real firearms. Yet, we do acknowledge that there are circumstances that could lead to confusion and serious consequences.

Many of us, when hearing the phrase "toy guns," visualize the myriad of brightly colored squirt pistols, Nerf rifles, and cowboy six-guns in the marketplace that obviously are toys. We do not believe it is the intent of this measure to restrict these items. Therefore, we respectfully request amending SB749 to narrow the focus to apply only to replica-type firearms that mimic actual weapons in size, colorations, authentic details and accurate markings. We believe this definition will achieve the purpose of this bill.
